4 Relating to Houston County; to amend Section 45-35-111,
5 Code of Alabama 1975, to provide for the compensation and
6 appointment of election officials; and to repeal Section
7 45-35-111.01, Code of Alabama 1975.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. Section 45-35-111, Code of Alabama 1975, is
10 amended to read as follows:

11 "§45-35-111

12 (a) (1) In Houston County, the election officials ~~who~~
13 ~~work at polling places are hereby entitled to an additional~~
14 ~~per diem allowance in such an amount as will, together with~~
15 ~~any amount paid by the state, make the total paid to such~~
16 ~~officials fifty-five dollars (\$55) for each day they work at~~
17 ~~the polls and supervisors are hereby entitled to an additional~~
18 ~~per diem allowance in such amount as will, together with any~~
19 ~~amount paid by the state, make the total paid to them~~
20 ~~sixty-five dollars (\$65) for each day they work at the~~
21 polls. referred to in Section 17-8-12 as "inspectors" and
22 "clerks" are respectively referred to as "chief inspectors"
23 and "poll workers."

24 (2) The Houston County Appointing Board may appoint
25 chief inspectors and deputy chief inspectors from the total
26 number of appointed poll workers.

27 (b) A chief inspector shall receive additional
28 compensation in an amount that, together with any amount paid

29 by the state, shall make his or her total compensation two
30 hundred dollars (\$200) per day for each day he or she works at
31 the polls.

32 (c) A deputy chief inspector shall receive additional
33 compensation in an amount that, together with any amount paid
34 by the state, shall make his or her total compensation one
35 hundred fifty dollars (\$150) per day for each day he or she
36 works at the polls.

37 (d) Poll workers shall receive additional compensation
38 in an amount that, together with any amount paid by the state,
39 shall make their total compensation one hundred twenty-five
40 dollars (\$125) per day for each day they work at the polls.

41 (e) If the amount paid to ~~such~~ the above officials as
42 compensation or expense allowance by the state increases in
43 the future, then the amount paid by the county under this
44 section shall automatically decrease in a like amount.

45 (f) ~~The expense allowance~~ All additional compensation
46 provided for in this section shall be paid from the general
47 fund of the county."

48 Section 2. Section 45-35-111.01, Code of Alabama 1975,
49 providing for additional compensation for Houston County poll
50 workers, is repealed.

51 Section 3. This act shall become effective immediately
52 following its passage and approval by the Governor, or its
53 otherwise becoming law.
