

House Bill 1137 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating a new charter for the City of Holly Springs in the County of  
2 Cherokee, approved March 18, 1980 (Ga. L. 1980, p. 3281), as amended, particularly by an  
3 Act approved April 13, 2001 (Ga. L. 2001, p. 3679), and an Act approved April 24, 2013  
4 (Ga. L. 2013, p. 3648), so as to provide for the terms and manner of election of the mayor  
5 and councilmembers; to provide for wards; to provide for qualifications; to provide for the  
6 filling of vacancies; to provide for removal from office; to provide for related matters; to  
7 repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 style="text-align:center">**SECTION 1.**

10 An Act creating a new charter for the City of Holly Springs in the County of Cherokee,  
11 approved March 18, 1980 (Ga. L. 1980, p. 3281), as amended, particularly by an Act  
12 approved April 13, 2001 (Ga. L. 2001, p. 3679), and an Act approved April 24, 2013  
13 (Ga. L. 2013, p. 3648), is amended by revising Section 2.02 as follows:

14 style="text-align:center">"SECTION 2.02.

15 The members of the city council shall serve for terms of four years and until their  
16 respective successors are elected and qualified. No person shall be eligible to serve as  
17 mayor or councilmember unless he or she has been a resident of the city for one year prior  
18 to the date of the election of mayor and councilmembers and has been a resident of the  
19 ward which he or she represents for a period of one year previous to the election in which  
20 he or she is a candidate. Each shall continue to reside in such ward during such member's  
21 period of service and continue to be registered and eligible to vote in municipal elections  
22 of the city."

23 **SECTION 2.**

24 Said Act is further amended by revising Article V as follows:

25 "ARTICLE V

26 ELECTIONS

27 **SECTION 5.01.**

28 Applicability of general law.

29 All primaries and elections shall be held and conducted in accordance with the provisions  
30 of Chapter 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code.'31 **SECTION 5.02.**

32 Regular elections.

33 (a)(1) For purposes of electing members of the city council, the city is divided into five  
34 wards. One member of the council shall be elected from each such ward. The five wards  
35 shall be and correspond to those five numbered districts described in and attached to and  
36 made a part of this Act and further identified as 'Plan: hollysprings-2014 Plan Type:  
37 Local Administrator: Holly Springs User: bak'.

38 (2) For the purposes of such plan:

39 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
40 provided in the report of the Bureau of the Census for the United States decennial  
41 census of 2010 for the State of Georgia. The separate numeric designations in a district  
42 description which are underneath a VTD heading shall mean and describe individual  
43 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
44 United States decennial census of 2010 for the State of Georgia; and45 (B) Except as otherwise provided in the description of any district, whenever the  
46 description of any district refers to a named city, it shall mean the geographical  
47 boundaries of that city as shown on the census maps for the United States decennial  
48 census of 2010 for the State of Georgia.49 (3) Any part of the city which is not included in any ward described in paragraph (1) of  
50 this subsection shall be included within that ward contiguous to such part which contains  
51 the least population according to the United States decennial census of 2010 for the State  
52 of Georgia.53 (4) Any part of the city which is described in paragraph (1) of this subsection as being  
54 included in a particular ward shall nevertheless not be included within such district if

55 such part is not contiguous to such ward. Such noncontiguous part shall instead be  
 56 included within that ward contiguous to such part which contains the least population  
 57 according to the United States decennial census of 2010 for the State of Georgia.

58 (b) Those members of the city council who are serving as such on the effective date of this  
 59 section and any person selected to fill a vacancy in any such office shall continue to serve  
 60 as such members until the regular expiration of their respective terms of office and upon  
 61 the election and qualification of their respective successors.

62 (c) On and after the effective date of this section, Kyle Whitaker shall be deemed to  
 63 represent Ward No. 1, Debbie Phillips shall be deemed to represent Ward No. 2, Michael  
 64 Roy Zenchuk II shall be deemed to represent Ward No. 3, Karen Barnett shall be deemed  
 65 to represent Ward No. 4, and Jeremy Smith shall be deemed to represent Ward No. 5.

66 SECTION 5.03.

67 Election at large; plurality vote.

68 The councilmember for each ward and the mayor shall be elected by the qualified electors  
 69 of the city at large, and each candidate for mayor and city council receiving a plurality of  
 70 the votes cast from the city at large shall be declared elected.

71 SECTION 5.04.

72 Special elections; vacancies.

73 In the event that the office of mayor or councilmember shall become vacant for any cause  
 74 whatsoever, the city council or those remaining shall call for a special election to fill the  
 75 balance of the unexpired term of such office; provided, however, that, if such vacancy  
 76 occurs within six months of the expiration of the term of such office, the city council or  
 77 those remaining shall appoint a successor for the remainder of the term. In all other  
 78 respects, the special election shall be held and conducted in accordance with Chapter 2 of  
 79 Title 21 of the O.C.G.A., the 'Georgia Election Code.'

80 SECTION 5.05.

81 Other provisions.

82 Except as otherwise provided by this charter, the city council shall by ordinance prescribe  
 83 such rules and regulations it deems appropriate to fulfill any options and duties under the  
 84 provisions of state law pertaining to elections.

85 SECTION 5.06.

86 Grounds and procedure for removal of elected officers.

87 The council may by ordinance set forth the grounds and procedure for the removal of  
88 elected officials of the City of Holly Springs."

89 SECTION 3.

90 All laws and parts of laws in conflict with this Act are repealed.
