A BILL TO BE ENTITLED AN ACT

- 1 To amend Part 1 of Article 1 of Chapter 2 of Title 44 of the Official Code of Georgia
- 2 Annotated, relating to recording of deeds and other real property transactions, so as to
- 3 authorize clerks of superior courts to require identification for the recording of deeds and
- 4 other instruments; to provide requirements therefor; to provide for rules and regulations; to
- 5 provide for a short title; to provide for related matters; to repeal conflicting laws; and for
- 6 other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 This Act shall be known and may be cited as the "Georgia Not on My Deed Act."
- SECTION 2.
- 11 Part 1 of Article 1 of Chapter 2 of Title 44 of the Official Code of Georgia Annotated,
- 12 relating to recording of deeds and other real property transactions, is amended by adding a
- 13 new Code section to read as follows:
- 14 "44-2-31.
- 15 (a) When a deed or other instrument is presented to a clerk of a superior court for
- 16 recording, whether in person or through an electronic recording service, the clerk may

17 require the individual presenting the deed or other instrument to produce a government

- issued photographic identification card.
- 19 (b) A clerk who requires an individual to produce a government issued photographic
- 20 <u>identification card pursuant to this Code section may:</u>
- 21 (1) Refuse to record a deed or other instrument if the individual presenting the deed or
- 22 <u>other instrument for recording does not produce such identification card in compliance</u>
- with this Code section; and
- 24 (2) Photocopy such identification card, require the individual to submit a photocopy of
- 25 such identification card, or record the identifying information, including the name and
- 26 address, of the individual as such information appears on the identification card.
- 27 (c) A clerk who requires an individual to produce a government issued photographic
- 28 <u>identification card pursuant to this Code section shall:</u>
- 29 (1) Require the production of such identification card from all individuals presenting a
- deed or other instrument for recording;
- 31 (2) Maintain a record of the photocopy of such identification card and note on such
- record the official records book and page number or instrument number assigned to the
- deed or other instrument recorded in connection therewith;
- 34 (3) Allow the individual to redact from the photocopy of such identification card any
- 35 <u>information the individual does not wish to be made public, except for the individual's</u>
- 36 name, address, and photograph; and
- 37 (4) Provide notice on the clerk's official public website of the identification requirement.
- 38 (d) Records created pursuant to this Code section shall not be made available for viewing
- 39 on the clerk's official public website but shall be made available for public inspection and
- 40 copying as required by the public records laws of this state.
- 41 (e) The Georgia Superior Court Clerks' Cooperative Authority may adopt rules and
- 42 <u>regulations necessary to implement this Code section."</u>
