- 22 trauma care networks and tort-reform legislation, worked for national healthcare reform, and
- 23 helped grow the GHA Political Action Committee; and
- 24 WHEREAS, he was named numerous times to the 100 Most Influential Georgians by
- 25 Georgia Trend Magazine; and
- 26 WHEREAS, he is an active community member, having served as a member of multiple
- 27 chamber organizations and earning many awards for his outstanding leadership; and
- 28 WHEREAS, an Augusta native, he and his wife, Mary, make their home in Marietta,
- 29 Georgia, and after a long, distinguished career, he is enjoying spending more time with his
- 30 family and friends; and
- 31 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
- 32 remarkable and distinguished Georgian be appropriately recognized.
