Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 50. The amount of \$700,000, or so much thereof as
- 5 may be necessary, is appropriated from the General Revenue Fund
- 6 to the Department of Employment Security for data analysis and
- 7 administrative expenses associated with the Homelessness
- 8 Prevention administrative data pilot addressing homelessness
- 9 prevention strategies.
- 10 Section 55. The amount of \$155,000, or so much thereof as
- 11 may be necessary, is appropriated from the General Revenue Fund
- 12 to the Department of Employment Security to implement
- diversity, equity, inclusion, and accessibility initiatives.
- 14 Section 99. Effective date. This Act takes effect July 1,
- 15 2024.
