DIGEST OF HB 1321 (Updated January 26, 2014 4:51 pm - DI 84)

Citations Affected: IC 20-25.5.

Synopsis: Innovation network schools. Authorizes Indianapolis public schools to enter into an agreement with a school management team to establish innovation network schools.

Effective: July 1, 2014.

HOUSE BILL No. 1321

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-25.5 IS ADDED TO THE INDIANA CODE AS
2 A NEW ARTICLE TO READ AS FOLLOWS [EFFECTIVE JULY 1,
3 2014]:

4 **ARTICLE 25.5. INNOVATION NETWORK SCHOOLS**

5 **Chapter 1. Applicability**

6 **Sec. 1. This article applies to a common school corporation that:**

7 (1) is located in whole or in part in the most populous
8 township in a county having a population of more than seven
9 hundred thousand (700,000); and

10 (2) serves the largest geographical territory of any school
11 corporation in the county.

12 **Chapter 2. Definitions**

13 **Sec. 1. As used in this article, "board" has the meaning set forth**
14 **in IC 20-25-2-5.**

15 **Sec. 2. As used in this article, "eligible school" means a school**
16 **which is part of a school corporation that:**

- 1 (1) was in the lowest two (2) categories of school improvement
2 for three (3) consecutive school years; or
3 (2) is vacant, underutilized or underenrolled as designated by
4 the school corporation.

5 **Sec. 3.** As used in this article, "innovation network school" is an
6 eligible school operated by a school management team. The term
7 includes a charter school.

8 **Sec. 4.** As used in this article, "school management team" is a
9 not-for-profit entity responsible for the operations of an eligible
10 school within a school corporation.

11 **Chapter 3. Establishment of Innovation Network Schools**

12 **Sec. 1.** An innovation network school is subject to all federal and
13 state laws and constitutional provisions that prohibit
14 discrimination on the basis of the following:

- 15 (1) Disability.
16 (2) Race.
17 (3) Color.
18 (4) Gender.
19 (5) National origin.
20 (6) Religion.
21 (7) Ancestry.

22 **Sec. 2.** (a) Subject to section 3 of this chapter, the board may
23 enter into an agreement with a school management team to
24 establish an innovation network school.

25 (b) The terms of the agreement shall specify the following:

- 26 (1) A statement that the innovation network school is
27 considered to be part of the school corporation and not
28 considered a separate local educational agency.
29 (2) A statement that the school management team authorizes
30 the school corporation to include the innovation network
31 school's performance assessment results under IC 20-31-8
32 when calculating the school corporation's performance
33 assessment under rules adopted by the state board.
34 (3) Provide that the innovation network school is eligible to
35 receive state and federal funding, including tuition support, as
36 determined in the agreement.

37 (c) If a school management team and a board enter into an
38 agreement under subsection (a), the school management team and
39 the board shall notify the department that an agreement has been
40 made under this section within thirty (30) days of the agreement.

41 (d) The school corporation and the school management team
42 shall outline the distribution of all federal and state funds in the



1 agreement entered into under subsection (a).

2 (e) Upon receipt of the notification under subsection (c), the
3 department shall, for school years starting after the date of the
4 agreement, include the innovation network school's performance
5 assessment results under IC 20-31-8 when calculating the school
6 corporation's performance assessment under rules adopted by the
7 state board.

8 **Sec. 3.** An innovation network school that is an eligible school
9 described under IC 20-25.5-2-2(1) shall be subject to oversight
10 from the state board. The state board shall evaluate the
11 performance of the innovation network school based on measures
12 agreed upon by the board and the school management team. The
13 school management team shall also provide to the state board on
14 a quarterly basis:

- 15 (1) academic data;
- 16 (2) financial data; and
- 17 (3) operational data

18 for the innovation network school.

19 **Sec. 4. (a)** For as long as the school management team operates
20 the innovation network school:

- 21 (1) the school management team may use the eligible school
22 building, the accompanying real property, and the building's
23 contents, equipment, and supplies, as provided in the
24 agreement established in section 2 of this chapter; and
- 25 (2) the school corporation shall continue to:

- 26 (A) provide transportation for students attending the
27 innovation network school at the same level of service the
28 school corporation provided before the eligible school
29 became an innovation network school; and
- 30 (B) maintain and repair the buildings and grounds
31 consistent with the maintenance and repair to the school
32 corporation's other buildings and grounds.

33 (b) If the school management team contracts with a school
34 corporation for goods or services, the school corporation may not
35 charge the school management team more for the goods or services
36 than the school corporation pays for the goods or services.

37 **Sec. 5. (a)** The school management team shall have full
38 operational autonomy to run the innovation network school as
39 provided in the agreement described in section 2 of this chapter.

40 (b) A school management team that operates an innovation
41 network school under this chapter shall make all personnel
42 decisions in the innovation network school. In operating the eligible



1 school as an innovation network school under this chapter, the
2 school management team is not bound by a contract entered into
3 under IC 20-29. Employees of a school management team may not
4 organize and collectively bargain under IC 20-29-6.

5 Sec. 6. (a) Except as provided in subsection (b), the following do
6 not apply to an innovation network school:

7 (1) An Indiana statute applicable to a governing body or
8 school corporation.

9 (2) A rule or guideline adopted by the state board.

10 (3) A rule or guideline adopted by the state board concerning
11 teachers, except for those rules that assist a teacher in gaining
12 or renewing a standard or advanced license.

13 (4) A local regulation or policy adopted by a school
14 corporation unless specifically incorporated in the agreement
15 described in section 2 of this chapter.

16 (b) IC 20-24-8-5 applies to an innovation network school.

17 Sec. 7. Any student who lives in the attendance area served by
18 a school that is operated as an innovation network school under
19 this chapter may attend the innovation network school. The
20 innovation network school may not refuse enrollment to a student
21 who lives in the attendance area.

22 Sec. 8. The school management team and the board shall hold
23 a joint public meeting at least two (2) times each year to discuss
24 issues and progress concerning the innovation network school.
