2 WHEREAS, Representative Brandon Reed is a man of faith; a devout husband to
3 Olivia; a proud father of Chloe, Alexandria, and Wilkin; a dedicated public servant; and a
4 dear friend to those who know him; and

5 WHEREAS, Representative Brandon Reed is a staunch supporter of the 24th House
6 District, serving parts of Green, Hart, and LaRue Counties from 2017 until his recent
7 retirement; and
