# ACT No. 985

1 AN ACT

2 To amend and reenact R.S. 47:463.102, relative to the Rotary District 6200 special prestige  
3 license plate; to provide for the name; to provide for eligibility; to provide for  
4 distribution and use of royalty fees; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 47:463.102 is hereby amended and reenacted to read as follows:

7 §463.102. Special prestige license plates; Louisiana Rotary ~~District 6200~~

8 A. The secretary of the Department of Public Safety and Corrections shall  
9 establish a special prestige license plate, to be known as the Louisiana Rotary  
10 ~~District 6200, hereafter referred to as the "organization"~~, plate, subject to the  
11 provisions of this Section. The license plate shall be restricted to passenger cars,  
12 pickup trucks, vans, and recreational vehicles. The color and design of the license  
13 plate shall be selected by ~~Rotary District 6200~~ the Louisiana Rotary organization  
14 hereafter referred to as the "organization". The license plate shall contain the  
15 organization's logo, provided it is in compliance with R.S. 47:463(A)(3), and shall  
16 bear the words "SERVICE ABOVE SELF".

17 B. The license plate shall be issued, upon application, to any ~~member in~~  
18 ~~good standing of the organization~~ citizen of Louisiana in the same manner as any  
19 other motor vehicle license plate and as provided for in this Section.

20 C. A ~~one-time~~ royalty fee of twenty-five dollars for use of the organization's  
21 logo shall be collected from the applicant and forwarded to ~~the organization~~ the  
22 Rotary District 6200 Foundation, for each license plate issued and renewed as  
23 provided in this Section, and shall be accompanied by identification of the parish in  
24 which the applicant is domiciled. The department shall also collect the standard  
25 motor vehicle registration license fee provided for in R.S. 47:463 and a handling fee

1 of three dollars and fifty cents. The handling fee shall be retained by the department  
2 to offset a portion of administrative costs.

3 D. The monies received from the royalty fees by the ~~organization~~ foundation,  
4 shall be used solely for charitable purposes ~~for residents of the state of Louisiana and~~  
5 shall be distributed to the Rotary district in the parish of the applicant's domicile, as  
6 reported to the foundation by the department. The ~~organization~~ foundation shall be  
7 responsible for establishing and disbursing the funds for charitable purposes.

8 E. The secretary shall establish a prestige license plate for the organization  
9 in accordance with the provisions of this Section when all of the following  
10 conditions are met:

11 (1) All necessary contracts regarding use of the organization's logo have  
12 been executed.

13 (2) The secretary has received a minimum of one thousand applications for  
14 the license plate.

15 F. The secretary shall establish rules and regulations as are necessary to  
16 implement the provisions of this Section, including but not limited to rules and  
17 regulations governing the collection and disbursement of royalty fees, ~~verification~~  
18 ~~that an applicant is a member of the organization~~, the transfer and disposition of such  
19 license plates, the colors available, and the design criteria.
