| 4 | provision of certain materials to women prior to abortion and to provide for the |
| 5 | content of such materials; to provide for requirements of the Department of Health |
| 6 | and Hospitals relative to development and publication of printed and Internet-based |
| 7 | materials concerning abortion; to provide for duties of physicians who perform |
| 8 | abortions; to provide for items to be retained in the medical record of each pregnant |
| 9 | woman upon whom an abortion is performed or induced; to provide for the content |
| 10 | of reports to the Department of Health and Hospitals by physicians concerning |
| 11 | abortions performed or induced; to provide for a task force on informational |
| 12 | materials to be delivered to women prior to abortion; to provide relative to a |
| 13 | definition; to provide relative to an effective date; and to provide for related matters. |
| 14 | Be it enacted by the Legislature of Louisiana: |
| 15 | Section 1. Children's Code Article 603(9) is hereby amended and reenacted to read |
| 16 | as follows: |
| 17 | Art. 603. Definitions |
| 18 | As used in this Title: |
| 19 | * * * |
| 20 | (9) "Coerced abortion" means the use of force, intimidation, threat of force, |
| 21 | threat of deprivation of food and shelter, or the deprivation of food and shelter by a |
| 22 | parent or any other person in order to compel a female child to undergo an abortion |

| 4 | Section 2. R.S. 40:1299.35.12 is hereby amended and reenacted and R.S. |
| 5 | 40:1299.35.5.2 and 1299.35.8(A)(6) are hereby enacted to read as follows: |
| 6 | §1299.35.5.2. Information on psychological impacts, illegal coercion, abuse, and |
| 7 | human trafficking required prior to abortion; task force on information |
| 8 | resources |
| 9 | A. The legislature hereby declares that women of this state have a right to |
| 10 | know that undergoing an abortion may have serious psychological impacts, including |
| 11 | severe emotional distress and mental and behavioral health afflictions. |
| 12 | B. At least twenty-four hours prior to undergoing an elective abortion as |
| 13 | defined in R.S. 40:1299.35.1, and as a condition for consent to the abortion to be |
| 14 | deemed voluntary and informed, the woman or minor female considering abortion |
| 15 | shall be given a copy of the printed materials described in this Section by the |
| 16 | physician who is to perform the abortion or a qualified person as defined in R.S. |
| 17 | 40:1299.35.6(B)(4)(c), except in the case of medical emergency as provided in R.S. |
| 18 | <u>40:1299.35.12.</u> |
| 19 | C.(1) The physician or qualified person shall provide to the woman or minor |
| 20 | female seeking an abortion the printed materials required by this Section individually |
| 21 | and in a private room for the purpose of ensuring that she has an adequate |
| 22 | opportunity to ask questions and discuss her individual circumstances. |
| 23 | (2) The physician or qualified person shall obtain the signature of the woman |
| 24 | or minor female seeking an abortion on a form certifying that the printed materials |
| 25 | were given to the woman or minor female. |
| 26 | (3) In the case of a minor female considering an abortion, if a parent |
| 27 | accompanies the minor female to the appointment with the physician or qualified |
| 28 | person described in Subsection B of this Section, then the physician or qualified |
| 29 | person shall provide to the parent copies of the materials given to the female in |
| 30 | accordance with Paragraph (1) of this Subsection. |

| 11 | emotional, or behavioral health afflictions prior to undergoing an abortion. |
| 12 | (b) The department shall take such actions as are necessary to ensure that any |
| 13 | mental or behavioral health professional or other counselor to whom a woman or |
| 14 | minor female may be referred through the organizations listed in the materials |
| 15 | developed pursuant to this Paragraph meets all of the following criteria: |
| 16 | (i) Provides counseling services that objectively address the mental, |
| 17 | emotional, and behavioral health effects that may occur prior to an abortion. |
| 18 | (ii) Is not affiliated with an abortion provider. |
| 19 | (2)(a) Information, telephone numbers, and links to Internet websites of |
| 20 | nonprofit organizations that offer free and confidential access to mental health |
| 21 | professionals, social workers, and other trained counselors who serve women and |
| 22 | minor females who may experience psychological distress or other mental, |
| 23 | emotional, or behavioral health afflictions after undergoing an abortion. |
| 24 | (b) The department shall take such actions as are necessary to ensure that any |
| 25 | mental or behavioral health professional or other counselor to whom a woman or |
| 26 | minor female may be referred through the organizations listed in the materials |
| 27 | developed pursuant to this Paragraph meets all of the following criteria: |

| 8 | (b) The department shall take such actions as are necessary to ensure that any |
| 9 | mental or behavioral health professional or other counselor to whom a woman or |
| 10 | minor female may be referred through the organizations listed in the materials |
| 11 | developed pursuant to this Paragraph meets all of the following criteria: |
| 12 | (i) Provides counseling services that objectively address the mental, |
| 13 | emotional, and behavioral health effects that may result from experiencing coercion |
| 14 | to obtain an abortion. |
| 15 | (ii) Is not affiliated with an abortion provider. |
| 16 | (c) The materials developed pursuant to this Paragraph shall clearly indicate |
| 17 | that coerced abortion is defined in Louisiana law, Children's Code Article 603, as a |
| 18 | form of abuse that seriously endangers the physical, mental, and emotional health |
| 19 | and safety of a child. |
| 20 | (4)(a) Information, telephone numbers, and links to Internet websites of |
| 21 | nonprofit organizations that offer free and confidential access to mental health |
| 22 | professionals, social workers, and other trained counselors for women and minor |
| 23 | females who are victims of the crime of human trafficking or the crime of trafficking |
| 24 | of children for sexual purposes. |
| 25 | (b) The department shall take such actions as are necessary to ensure that any |
| 26 | mental or behavioral health professional or other counselor to whom a woman or |
| 27 | minor female may be referred through the organizations listed in the materials |
| | developed pursuant to this Paragraph meets all of the following criteria: |

| 7 | (i) That victims of trafficking can be safe after their rescue from being |
| 8 | trafficked. |
| 9 | (ii) That Louisiana provides for assistance to victims of human trafficking, |
| 10 | as required by R.S. 46:2162 et seq. |
| 11 | (iii) That there are public and private agencies providing valuable assistance |
| 12 | to women and minor females who have been commercially and sexually exploited; |
| 13 | and that help available to victims of trafficking and other exploitation includes |
| 14 | housing assistance, education, job training, and drug addiction counseling. |
| 15 | (iv) That legal assistance is available to women and minor females seeking |
| 16 | to escape the sex trade, including assistance in vacating prior prostitution |
| 17 | convictions. |
| 18 | (v) That the crime of trafficking of children for sexual purposes is subject |
| 19 | to the mandatory reporting laws set forth in Children's Code Articles 603, 609, and |
| 20 | <u>610.</u> |
| 21 | (d) Any pamphlet developed pursuant to this Paragraph shall be known as |
| 22 | the "Point of Rescue" pamphlet. |
| 23 | E. The materials provided for in Subsection D of this Section shall be printed |
| 24 | in a typeface large enough to be clearly legible and shall be available at no cost from |
| 25 | the department upon request and in appropriate number to any person, facility, or |
| 26 | hospital. The department's website shall contain the content of the printed material, |
| 27 | a printable electronic image of the printed material, and information on ordering |
| 28 | printed materials. The department shall promulgate rules and regulations relative to |
| 29 | the methods of distribution of printed materials. |

| 1 | F. The governor shall convene a task force to assist the Department of Health |
| 2 | and Hospitals in the preparation of the printed and Internet materials provided for in |
| 3 | this Section. The task force shall be comprised of the following members: |
| 4 | (1) One psychologist licensed by the Louisiana State Board of Examiners of |
| 5 | Psychologists. |
| 6 | (2) One physician who is board certified as a psychiatrist and licensed by the |
| 7 | Louisiana State Board of Medical Examiners. |
| 8 | (3) One licensed clinical social worker licensed by the Louisiana State Board |
| 9 | of Social Work Examiners. |
| 10 | (4) Two Louisiana residents who provide pre-abortion or post-abortion |
| 11 | counseling in association with a nonprofit organization that does not counsel for or |
| 12 | provide abortion. |
| 13 | (5) Two attorneys licensed in Louisiana who specialize in advocacy for |
| 14 | women and minor females who are at risk of being coerced into or psychologically |
| 15 | harmed by abortion. |
| 16 | (6) The executive director of the Louisiana Human Trafficking Task Force. |
| 17 | (7) The executive director and the residential director of a residential |
| 18 | program for women who have been commercially and sexually exploited. |
| 19 | (8) Two members of the Senate appointed by the president. |
| 20 | (9) Two members of the House of Representatives appointed by the speaker. |
| 21 | (10) The secretary of the Department of Health and Hospitals, who shall |
| 22 | serve as the chairperson of the task force. |
| 23 | G. Nothing in this Section shall be construed to conflict with or supercede |
| 24 | the requirement for mandatory reporting of child abuse provided in Children's Code |
| 25 | Article 603 et seq. |

| 2 | A. Each physician shall retain and make part of the medical record of each |
| 3 | pregnant woman upon whom an abortion is performed or induced, copies of the |

| 7 | indicating that the woman or minor female acknowledged receipt of informational |
| 8 | materials concerning psychological impacts, illegal coercion, abuse, and human |
| 9 | trafficking. |

| 11 | §1299.35.12. Emergency |
| 12 | The provisions of R.S. 40:1299.35.2, 1299.35.4, 1299.35.5, and 1299.35.6 |
| 13 | this Part shall not apply when a medical emergency compels the immediate |
| 14 | performance of an abortion because the continuation of the pregnancy poses an |
| 15 | immediate threat and grave risk to the life or permanent physical health of the |
| 16 | pregnant woman. Within twenty-four hours, the attending physician shall certify to |
| 17 | the emergency need for the abortion and shall enter such certification in the medical |
| 18 | record of the pregnant woman. |
| 19 | Section 3. The provisions of Section 2 of this Act requiring a physician or a qualified |
| 20 | person to provide required printed materials to a woman considering an abortion shall |
| 21 | become effective thirty days after the Department of Health and Hospitals publishes a notice |
| 22 | of the availability of such materials. |
