1	AN ACT
2	To amend and reenact R.S. 37:3200(9), 3205(B), 3208(B), 3209, 3210(C) and (D), 3211,
3	and 3218, relative to radiologic technologists; to amend the definition of "radiologic
4	technologist"; to provide for meetings of the Louisiana Radiologic Technology
5	Board of Examiners; to provide for the qualification of applicants for licensure; to
6	require a certification examination; to require payment of fees prior to licensure; to
7	authorize the board to promulgate a fee schedule; to make technical changes; and to
8	provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
0	Section 1. R.S. 37:3200(9), 3205(B), 3208(B), 3209, 3210(C) and (D), 3211, and
1	3218 are hereby amended and reenacted to read as follows:
12	§3200. Definitions
13	As used in this Chapter:

15	(9) "Radiologic technologist" means any person who is a radiographer, a
16	radiation therapy technologist, a fusion technologist, or a nuclear medicine
17	technologist licensed under this Chapter who under the direction and supervision of
18	a licensed practitioner applies radiation to humans upon prescription of a licensed
19	practitioner.

12	A. Each applicant for licensure shall be required to pass a license
13	certification examination designated and approved by the board.
14	B. The board shall hold an examination at least every six months at such
15	times and in such localities within the state of Louisiana as the board may consider
16	necessary and appropriate.
17	C. An applicant who fails to pass the examination may reapply for the
18	examination provided the applicant complies with the regulations established by the
19	board.
20	D. Each application for examination for licensure shall be accompanied by
21	the fee prescribed by the board.

24	C. Upon application and payment for examination for initial licensure, the
25	board may issue a working permit to any graduate of an approved school who meets

1	D. Upon application and payment for licensure, the board may issue a
2	temporary permit to any person who holds a certificate from the American Registry
3	of Radiologic Technologists, the American Society of Clinical Pathologists
4	Pathology, (NM) or the Nuclear Medicine Technology Certification Board issued on
5	the basis of an examination satisfactory to the board, provided that standards of the
6	issuing body are at least as stringent as those established by the board. This permit
7	shall be valid for a period not to exceed ninety days.
8	§3211. Licensure
9	The board shall issue a license to and authorize the use of the title "Licensed
10	Radiologic Technologist" by each applicant who has successfully passed the board
11	certification examination or has otherwise been qualified under the provisions of this
12	Chapter and authorize the use of the title "Licensed Radiologic Technologist" and
13	has paid all fees required by this Chapter.

15	§3218. Fees
16	A. Fees to be paid under this Chapter shall be as follows:
17	(1) Examination and initial license fee \$ 50.00
18	(2) Duplicate license
19	(3) Renewal of license 50.00
20	(4) Temporary working permits
21	The board shall promulgate, in accordance with the Administrative Procedure
22	Act, a reasonable fee schedule for the issuance, renewal, or reinstatement of any
23	license or permit, for administration of examinations for licensure, or for any other
24	administrative function provided for in this Chapter. The fee schedule may be
25	modified from time to time as deemed necessary by the board.
26	B. All fees collected pursuant to the provisions of this Section shall be paid
27	to the secretary-treasurer of the board and disbursed for the purpose of administering
28	shall be used to carry out the purposes of this Chapter.

Abramson HB No. 610

Abstract: Amends the provisions of law relative to the licensure of radiologic technologists.

<u>Present law</u> defines "radiologic technologist" as any person who is a radiographer, a radiation therapy technologist, or a nuclear medicine technologist licensed under <u>present law</u> who under the direction and supervision of a licensed practitioner applies radiation to humans upon prescription of a licensed practitioner.

<u>Proposed law</u> retains <u>present law</u> but adds a fusion technologist to the list of occupations that fall under the definition of "radiologic technologist".

<u>Present law</u> requires the La. Radiologic Technology Board of Examiners (board), for administrative purposes, to meet in Baton Rouge, La. at least every three months and at such other times as may be necessary.

<u>Proposed law</u> changes the meeting location <u>from</u> Baton Rouge <u>to</u> a time and place to be fixed by the board.

<u>Present law</u> requires each applicant for licensure as a radiologic technologist to have successfully completed a course of study in radiography, radiation therapy technology, or nuclear medicine technology or fusion technology approved by the board in accordance with standards promulgated by the board.

<u>Proposed law</u> retains <u>present law</u> but makes a technical change.

<u>Present law</u> requires each applicant for licensure to pass a license examination designated and approved by the board.

<u>Proposed law</u> changes the required examination $\underline{\text{from}}$ a license examination $\underline{\text{to}}$ a certification examination.

<u>Present law</u> requires the board to hold an examination at least every six months at such times and in such localities within the state of La. as the board may consider necessary and appropriate.

Proposed law repeals present law.

<u>Present law</u> provides that an applicant who fails to pass the examination may reapply for the examination if the applicant complies with the regulations established by the board.

Proposed law repeals present law.

<u>Present law</u> requires each application for examination for licensure to be accompanied by the fee prescribed by the board.

Proposed law repeals present law.

<u>Present law</u> authorizes the board, upon receiving an application for examination for initial licensure, to issue a working permit to any graduate of an approved school who meets the

qualifications for licensure pending results of the first licensing examination scheduled by the board following the applicant's graduation.

<u>Proposed law</u> authorizes the board, upon receiving an application and payment for examination for initial licensure, to issue a working permit to any graduate of an approved school who meets the qualifications for licensure pending results of the first certification examination following the applicant's graduation.

<u>Present law</u> authorizes the board, upon application for licensure, to issue a temporary permit, valid for a period not to exceed 90 days, to any person who holds a certificate from the American Registry of Radiologic Technologists, the American Society of Clinical Pathology, (NM) or the Nuclear Medicine Technology Certification Board issued on the basis of an examination satisfactory to the board, provided that standards of the issuing body are at least as stringent as those established by the board.

<u>Proposed law</u> retains <u>present law</u> but adds the requirement that the applicant pay the applicable fees for licensure prior to the issuance of the temporary permit.

<u>Present law</u> requires the board to issue a license to each applicant who has successfully passed the board examination or has otherwise been qualified under the provisions of <u>present law</u> and to authorize the use of the title "Licensed Radiologic Technologist".

<u>Proposed law</u> retains <u>present law</u> but requires all fees to be paid by the applicant prior to the issuance of the license and makes technical changes.

<u>Present law</u> provides that fees to be paid under <u>present law</u> shall be as follows:

(1)	Examination and initial license fee	\$ 50.00
(2)	Duplicate license	25.00
(3)	Renewal of license	50.00
(4)	Temporary working permits	10.00

<u>Proposed law</u> repeals <u>present law</u> and requires the board to establish by administrative rule a reasonable fee schedule for the issuance, renewal, or reinstatement of any license or permit, for administration of examinations for licensure, or for any other administrative function provided for in <u>proposed law</u>. <u>Present law</u> authorizes the fee schedule to be modified from time to time as deemed necessary by the board.

<u>Present law</u> requires all fees collected to be paid to the secretary-treasurer of the board and disbursed for the purpose of administering <u>present law</u>.

<u>Proposed law</u> retains <u>present law</u> but makes technical changes.
