2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2010-3 2011 to be used to pay the consent judgment against the Department of 4 Transportation and Development in the suit entitled "Olivia M. Krause, Joshua 5 Garrett McIntyre, and Sarah Anne McIntyre, Individually and on behalf of the Estate 6 of John Gilbert McIntyre v. Russell G. Hebert, Jr., the Cajun Company, the Hanover 7 Insurance Company, ABC Insurance Company and State Farm Mutual Automobile 8 Insurance Company"; and to provide for related matters. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1.
