CONDOLENCES. Expresses condolences upon the death of former state legislator Thomas "Bud" Brady.

1	A CONCURRENT RESOLUTION
2	To express the sincere and heartfelt condolences of the Legislature of Louisiana upon the
3	death of former legislator Thomas "Bud" Brady.
4	WHEREAS, it is with deep regret and profound sorrow that the members of the
5	legislature and the citizens of the state of Louisiana learned of the death of former legislator
6	Thomas "Bud" Brady on Friday, April 1, 2011, at the age of seventy-two in Alexandria,
7	Louisiana; and
8	WHEREAS, Mr. Brady served as state representative from 1976 to 1988,
9	representing voters in Caldwell, Grant, LaSalle, Rapides, and Winn parishes; and
10	WHEREAS, he served the legislature under governors Edwin Edwards and Dave
11	Treen; and
12	WHEREAS, he was born in Urania, Louisiana on July 9, 1938, and grew up to
13	become a standout football player at LaSalle High School despite battling many childhood
14	illnesses such as severe fevers and rare muscle and neurological ailments; and
15	WHEREAS, Mr. Brady earned a football scholarship to Louisiana State University,
16	but his health eventually convinced him to leave football and the university; and
17	WHEREAS, he transferred to Northwestern State University in Natchitoches,
18	Louisiana, going to school and working as a radio disc jockey in Alexandria, Natchitoches,

1	Winnfield, and Farmerville; and
2	WHEREAS, he met his wife, Cullyne Roy Scott, at Northwestern State University
3	and was married in 1960; and
4	WHEREAS, he was inspired by the Long's political dynasty and worked on the staff
5	of former Congressman Speedy O. Long in Washington, D.C., from 1965 to 1971; and
6	WHEREAS, while serving Congressman Long, he also began a career in real estate
7	and real estate appraisal; and
8	WHEREAS, he left Washington, D.C. to start his own political career and was
9	elected to the Louisiana House of Representatives in 1976; and
10	WHEREAS, after leaving politics in 1988, he moved to Alexandria and founded Bud
11	Brady Appraisals; and
12	WHEREAS, along with politics, Mr. Brady enjoyed photography, painting and
13	music, including playing a Dobro that was a gift from the late Governor Jimmie Davis; and
14	WHEREAS, he attended Tullos First Baptist Church while living in LaSalle Parish,
15	and recently attended the Pentacostal Church of Alexandria; and
16	WHEREAS, he was preceded in death by his father, Floyd Lee Brady; mother Lucille
17	McCarrol Brady; and son, Roderick Edward Brady; and
18	WHEREAS, he leaves a legacy of love and many fond memories by his devoted
19	family; his brother, Gerald Brady of Lafayette, Louisiana; sister, Shirley Talley of Houston,
20	Texas; two daughters, Cecella Brady of San Diego, California, and Charlane Rene Brady of
21	Reykjavik, Iceland; and two grandchildren, Joseph Gonzalez of Newport Beach, California,
22	and Gabriella Gonzalez of San Diego, California.
23	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
24	extend its sincere and heartfelt condolences upon the death of Thomas "Bud" Brady.
25	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
26	family of Thomas "Bud" Brady.
