By Mr. Sciortino of Medford, a petition (accompanied by bill, House, No. 154) of Carl M. Sciortino, Jr. and others relative to the protection of the mental and physical health of minors from sexual orientation and/or gender identity change efforts. Children, Families and Persons with Disabilities.

**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act relative to abusive practices to change sexual orientation and gender identity in minors .

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 112 of the General Laws, as appearing in the 2010 Official  
2 addition, is hereby amended by adding following new section:-

3 Section 264. (a) Definitions.

4 For the purposes of this section, “licensed professional” means any licensed medical,  
5 mental health, or human service professional licensed under Chapter 112, including any  
6 psychologist, psychiatrist, social worker, psychiatric nurse, allied mental health and human  
7 services professional, licensed marriage and family therapist, licensed rehabilitation counselor,  
8 licensed mental health counselor, licensed educational psychologist, or any of their respective  
9 interns or trainees, or any other person designated or licensed as a mental health or human  
10 service professional under Massachusetts law or regulation.

11 “Sexual orientation and gender identity change efforts” means any practice by a licensed  
12 professional that seeks or purports to impose change of an individual’s sexual orientation or  
13 gender identity. Such term--

14 (1) Includes practices which

15 (A) to change behavioral expression of an individual’s sexual orientation or gender  
16 identity, or

17 (B) to eliminate or reduce sexual or romantic attractions or feelings toward individuals of  
18 the same sex.

19 (2) Does not include practices which

20 (A) provide acceptance, support, and understanding of an individual's sexual orientation,  
21 gender identity, or gender expression and the facilitation of an individual's coping, social  
22 support, and identity exploration and development, including interventions to prevent or address  
23 unlawful conduct or unsafe sexual practices, or

24 (B) provide acceptance, support, or understanding of an individual's gender expression or  
25 the facilitation of an individual's coping, social support, and identity exploration and  
26 development.

27 (b) Under no circumstances shall a licensed professional advertise for or engage in sexual  
28 orientation and gender identity change efforts with a patient less than 18 years of age. Any  
29 licensed professional violating this prohibition shall be such subject to discipline by the board,  
30 which may include suspension or revocation of license.

31 (c) Whoever violates this section shall be considered to have violated section 2 of chapter  
32 93A.

33 SECTION 2. (a) Subsection (a) of Section 51A of chapter 119 of the General Laws, as  
34 appearing in the 2010 Official addition, is hereby amended by inserting after the words "chapter  
35 233" the following words:-

36 or (vi) being subjected to sexual orientation and gender identity change efforts as defined  
37 by section 169 of chapter 112

38 (b) Section 51A of chapter 119 is further amended in subsection (i) after the word  
39 "family." by adding the following words:-

40 Any report including licensed professionals engaging in sexual orientation and gender  
41 identity change efforts as defined under section 169 of chapter 112 shall be filed within 30 days  
42 to the appropriate licensing board for review and possible suspension or revocation of license.
