Scibak and others relative to establishing a special commission (including members of the General Court) to make an investigation and study concerning the use of applied behavior analysis and behavior modification procedures techniques. An Act Creating a special commission on applied behavior analysis.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:
- 3 SECTION 1. There shall be a special commission to investigate and make legislative
- 4 recommendations on the adequacy and effectiveness of laws and regulations governing the right
- 5 to effective treatment and the use of applied behavior analysis and behavior modification
- 6 procedures techniques across all public agencies in the commonwealth or private agencies
- 7 receiving public funding or subsidy through the commonwealth, any of its political subdivisions,
- 8 or another state or political subdivision, thereof.
- 9 SECTION 2. The investigation shall include, but not be limited to, the scope of 10 techniques permissible under current statutes and regulations, the existent classification system
- 11 of behavioral interventions, the format and content of behavioral plans, the policies and
- 12 procedures governing the development, review, approval, implementation, monitoring and
- 13 review of behavior plans across all public agencies where applied behavior analysis and behavior
- 14 modification procedures are permissible.
- 15 SECTION 3. The commission shall also determine whether agencies which are licensed
- 16 or regulated by multiple state agencies are currently subjected to conflicting statutes and
- 17 regulations regarding the use of applied behavior analysis and behavior modification procedures
- 18 and recommend, where appropriate, a unified set of standards regarding the use of applied

- behavior analysis behavior procedures in all agencies and programs licensed, funded and/or regulated by the Commonwealth.
- SECTION 4. The commission shall also review and evaluate the status and appropriateness of a sample of current behavioral plans within state agencies as well as contracted providers.
- SECTION 5. The commission shall consist of 2 members of the Senate, 1 of whom shall
- 25 be appointed by the Minority Leader; 2 members of the House of Representatives, 1 of whom
- 26 shall be appointed by the Minority Leader; the Commissioner of the Department of
- 27 Developmental Services or designee, the Commissioner of the Department of Mental Health or
- 28 designee, the Commissioner of the Department of Early Education and Care or designee, the
- 29 Commissioner of the Department of Elementary and Secondary Education or designee, the
- 30 Commissioner of the Department of Children and Families or designee, the Commissioner of the
- 31 Department of Youth Services or designee, the Chief Justice of the Probate and Family Court or
- 32 designee, the Executive Director of the Disabled Persons Protection Commission or designee, the
- 33 Chairman of the Governor's Commission on Intellectual Disability or designee; the President of
- 34 the Berkshire Association of Behavior Analysis and Therapy or designee, the President of the
- 35 Massachusetts Association of Behavior Analysis or designee; and 9 persons to be appointed by
- 36 the Governor, 3 of whom shall be individuals who are members of licensed as Behavior Analysts
- 37 or who meet the statutory qualifications for such licensure; 3 of whom shall be service providers
- 38 whose agency conducts behavioral intervention programming; and 3 of whom shall be
- 39 consumers, parents, or family members of individuals who have been recipients of applied
- 40 behavior analysis services.
- SECTION 6. The commission may hold public hearings and site visits to assist in the collection and evaluation of data and testimony from providers, family members, and the general public.
- SECTION 7. The commission shall report to the general court the results of its
- 45 investigation and study, and its recommendations, if any, together with drafts of legislation
- 46 necessary to carry such recommendations into effect by filing them with the Clerk of the Senate
- 47 and the Clerk of the House of Representatives on or before June 30, 2014. The commission may
- 48 issue preliminary or interim reports to the general court before that date.
