# The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act relative to the relief of mortgage debt.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

Paragraph (a) of part B of section 3 of chapter 62 of the General Laws, as appearing in
the 2010 Official Edition, is hereby further amended by adding the following subparagraph:-

4  $\Box(17)$  Income attributable to the discharge of debt on a principal residence including debt

5 reduced through mortgage restructuring, as well as mortgage debt forgiven in connection with a

6 foreclosure, shall qualify for tax relief provided that no more than \$1,000,000 of forgiven debt is

7 eligible for this exclusion, except if married filing jointly, up to \$2,000,000 may be excluded.

8 The exclusion shall not apply if the discharge is due to services performed for the lender or any

9 other reason not directly related to a decline in the home's value or the taxpayer's financial

10 condition. The commissioner of the department of revenue shall promulgate regulations to

11 effectuate this provision.
