An Act relative to compulsory motor vehicle liability insurance.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 1. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
2 Official Edition, is hereby amended by inserting after the word "registration", in the first  
3 sentence, and inserting in place thereof the following word :- "or registration renewal".

4 Section 2. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
5 Official Edition, is hereby amended by striking out in line 3, after the word "amount of", the  
6 word, "ten" inserting in place thereof the following word:- 50,000.

7 Section 3. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
8 Official Edition, is hereby amended by striking out in line 4 after the word:- "less than" the  
9 word, "ten" and inserting in place thereof the following word:- 50,000.

10 Section 4. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
11 Official Edition, is hereby amended by inserting after the word:- "damages", at the end of the  
12 first sentence, inserting in place thereof the following words:- "to property owned by another  
13 party. The applicant shall deposit with the state treasurer a further cash amount of 50,000 dollars  
14 or bonds, stock or other evidence of indebtedness satisfactory to said treasurer of the market value

15 of not less than 50,000 dollars as security for the payment by such applicant or by any person  
16 responsible for the operation of such applicant's motor vehicle with his express or implied  
17 consent of all judgements rendered against such applicant or against such person in actions to  
18 recover damages for"

19 Section 5. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
20 Official Edition, is hereby amended by striking out the word:- " ten", in the second sentence, and  
21 inserting in place thereof the following word:- "50,000."

22 Section 6. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
23 Official Edition, is hereby amended by striking out the word :-" ten", in line 27, and inserting in  
24 place thereof the following word:- "50,000."

25 Section 7. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
26 Official Edition, is hereby amended by striking out the word:-" ten", in line 30 and inserting in  
27 place thereof the following word:- "50,000."

28 Section 8. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
29 Official Edition, is hereby amended by inserting after the word:- "shall", in the third sentence,  
30 the following word:- " not",

31 Section 9. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
32 Official Edition, is hereby amended by inserting in the third sentence, the word:- " or " after the  
33 word "deposit" and further insert the word" but" after the word deposited" in the same sentence.

34 Section 10. Section 34D of Chapter 90 of the General Laws as appearing in the 2008  
35 Official Edition, is hereby amended by striking out the word:-" ten", in line 53, and inserting in  
36 place thereof the word:- "50,000."
