A BILL ENTITLED

1 AN ACT concerning

2 **Condominiums and Homeowners Associations – Sales – Disclosure and**
3 **Cancellation Requirements**

4 FOR the purpose of altering the information that a purchaser must receive before a
5 contract for the sale or resale of a unit in a condominium or a lot in a
6 homeowners association may be enforced by the vendor or seller under certain
7 circumstances; altering the time period within which a purchaser may cancel a
8 contract for the sale or resale of a unit or lot without stating a reason and
9 without liability on the part of the purchaser under certain circumstances;
10 altering the time period within which a council of unit owners must furnish a
11 certificate to a unit owner relating to certain disclosure requirements for the
12 resale of a unit under certain circumstances; repealing a certain requirement
13 that a purchaser of a unit provide certain information to the council of unit
14 owners under certain circumstances; altering the standard for a vendor's
15 fulfillment of a certain requirement to provide information to a purchaser of a
16 lot if the property is subject to a declaration by a person who is not affiliated
17 with the vendor under certain circumstances; authorizing a homeowners
18 association to direct a vendor to obtain certain information from a depository
19 under certain circumstances; making stylistic changes; providing for the
20 application of this Act; and generally relating to sales in condominiums and
21 homeowners associations.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
4 MARYLAND, That the Laws of Maryland read as follows:

5 **Article – Real Property**

6 11–126.

7 (a) A contract for the initial sale of a unit to a member of the public is not
8 enforceable by the vendor unless:

9 (1) The purchaser is given [on or before the time a contract is entered
10 into between the vendor and the purchaser,] a current public offering statement as
11 amended and registered with the Secretary of State containing all of the information
12 set forth in subsection (b) of this section;

13 **(2) THE PURCHASER IS GIVEN NOTICE OF ANY CHANGES IN THE**
14 **MANDATORY FEES AND PAYMENTS EXCEEDING 10% OF THE AMOUNT**
15 **PREVIOUSLY STATED TO EXIST AND ANY OTHER SUBSTANTIAL AND MATERIAL**
16 **AMENDMENTS TO THE PUBLIC OFFERING STATEMENT AFTER THEY BECOME**
17 **KNOWN TO THE VENDOR; and**

18 **[(2)] (3)** The contract of sale contains, in conspicuous type, a notice
19 of:

20 (i) The purchaser's right to receive a public offering statement
21 and his rescission rights under this section; and

22 (ii) The warranties provided by § 11–131 of this title.

23 (b) The public offering statement required by subsection (a) of this section
24 shall be sufficient for the purposes of this section if it contains at least the following:

25 (1) A copy of the proposed contract of sale for the unit;

26 (2) A copy of the proposed declaration, bylaws, and rules and
27 regulations;

28 (3) A copy of the proposed articles of incorporation of the council of
29 unit owners, if it is to be incorporated;

30 (4) A copy of any proposed management contract, insurance contract,
31 employment contract, or other contract affecting the use of, maintenance of, or access
32 to all or part of the condominium to which it is anticipated the unit owners or the

1 council of unit owners will be a party, and a statement of the right of the council of
2 unit owners to terminate contracts entered into during the developer control period
3 under § 11–133 of this title;

4 (5) A copy of the actual annual operating budget for the condominium
5 or, if no actual operating budget exists, a copy of the projected annual operating
6 budget for the condominium including reasonable details concerning:

7 (i) The estimated monthly payments by the purchaser for
8 assessments;

9 (ii) Monthly charges for the use, rental, or lease of any facilities
10 not part of the condominium;

11 (iii) The amount of the reserve fund for repair and replacement
12 and its intended use; and

13 (iv) Any initial capital contribution or similar fee, other than
14 assessments for common expenses, to be paid by unit owners to the council of unit
15 owners or vendor, and a statement of how the fees will be used;

16 (6) A plain language statement of the policy and procedures for
17 collecting assessments and handling collection of delinquencies, including reasonable
18 details concerning:

19 (i) The number and percentage of unit owners who are
20 delinquent or in arrears in an amount equal to or greater than 50% of the annual
21 assessment of the unit owner;

22 (ii) The number of unsatisfied liens currently recorded against
23 unit owners under the Maryland Contract Lien Act;

24 (iii) The number of unsatisfied judgments obtained against unit
25 owners for unpaid assessments; and

26 (iv) The total amount of arrearages among all unit owners;

27 (7) A copy of any lease to which it is anticipated the unit owners or the
28 council of unit owners will be a party following closing;

29 (8) A description of any contemplated expansion of the condominium
30 with a general description of each stage of expansion and the maximum number of
31 units that can be added to the condominium;

32 (9) A copy of the floor plan of the unit or the proposed condominium
33 plats;

1 (10) A description of any recreational or other facilities which are to be
2 used by the unit owners or maintained by them or by the council of unit owners, and a
3 statement as to whether or not they are to be part of the common elements;

4 (11) A statement as to whether streets within the condominium are to
5 be dedicated to public use or maintained by the council of unit owners;

6 (12) A statement of any judgments against the council of unit owners
7 and the existence of any pending suits to which the council of unit owners is a party;

8 (13) In the case of a condominium containing buildings substantially
9 completed more than 5 years prior to the filing of the application for registration under
10 § 11–127 of this title, a statement of the physical condition and state of repair of the
11 major structural, mechanical, electrical, and plumbing components of the
12 improvements, to the extent reasonably ascertainable, and estimated costs of repairs
13 for which a present need is disclosed in the statement and a statement of repairs
14 which the vendor intends to make. The vendor is entitled to rely on the reports of
15 architects or engineers authorized to practice their profession in this State;

16 (14) A description of any provision in the declaration or bylaws limiting
17 or providing for the duration of developer control or requiring the phasing–in of unit
18 owner participation, or a statement that there is no such provision;

19 (15) If the condominium is one which will be created by the conversion
20 of a rental facility, a copy of the notice and materials required by §§ 11–102.1 and
21 11–137 of this title;

22 (16) A statement of whether the unit being purchased is subject to an
23 extended lease under § 11–137 of this title, or local law, and a copy of any extended
24 lease;

25 (17) A written notice of the unit owner’s responsibility for the council of
26 unit owners’ property insurance deductible and the amount of the deductible; and

27 (18) Any other information required by regulation duly adopted and
28 issued by the Secretary of State.

29 (c) A person may not advertise or represent that the Secretary of State has
30 approved or recommended the condominium, the public offering statement, or any of
31 the documents contained in the application for registration.

32 (d) (1) Following execution of a contract of sale by a purchaser, the vendor
33 may not amend any of the material required to be furnished by subsection (a) of this
34 section without the approval of the purchaser if the amendment would affect
35 materially the rights of the purchaser.

1 (2) Approval is not required if the amendment is required by any
2 governmental authority or public utility, or if the amendment is made as a result of
3 actions beyond the control of the vendor or in the ordinary course of affairs of the
4 council of unit owners.

5 (3) A copy of any amendments shall be delivered promptly to any
6 purchaser and to the Secretary of State.

7 (e) (1) **(I)** [Any purchaser may at any time (i) within 15 days following
8 receipt of all of the information required under subsection (b) of this section or the
9 signing of the contract, whichever is later; and (ii) within 5 days following receipt of
10 the information required under subsection (d) of this section, rescind in writing the
11 contract of sale without stating any reason and without any liability on his part, and
12 he shall be] **IF A PURCHASER HAS NOT RECEIVED ALL OF THE INFORMATION**
13 **REQUIRED UNDER SUBSECTION (B) OF THIS SECTION AT LEAST 7 CALENDAR**
14 **DAYS BEFORE THE SALES CONTRACT IS ENTERED INTO, THE PURCHASER,**
15 **WITHIN 7 CALENDAR DAYS FOLLOWING RECEIPT OF ALL THE INFORMATION,**
16 **MAY CANCEL IN WRITING THE CONTRACT WITHOUT STATING A REASON AND**
17 **WITHOUT LIABILITY ON THE PART OF THE PURCHASER.**

18 **(II) IF A PURCHASER RECEIVES NOTICE OF A CHANGE IN**
19 **THE MANDATORY FEES AND PAYMENTS THAT EXCEEDS 10% OF THE AMOUNT**
20 **PREVIOUSLY STATED TO EXIST OR ANY OTHER SUBSTANTIAL AND MATERIAL**
21 **AMENDMENT TO THE INFORMATION REQUIRED UNDER SUBSECTION (B) OF THIS**
22 **SECTION THAT ADVERSELY AFFECTS THE PURCHASER, THE PURCHASER,**
23 **WITHIN 3 CALENDAR DAYS FOLLOWING RECEIPT OF THE NOTICE OR**
24 **AMENDMENT, MAY CANCEL IN WRITING THE CONTRACT OF SALE WITHOUT**
25 **STATING A REASON AND WITHOUT LIABILITY ON THE PART OF THE PURCHASER.**

26 (2) **ON RESCISSION, THE PURCHASER IS** entitled to the return of
27 any deposits made on account of the contract.

28 **[(2)] (3)** The return of any deposits held in trust by a licensed real
29 estate broker to a purchaser under this subsection shall comply with the procedures
30 set forth in § 17-505 of the Business Occupations and Professions Article.

31 (f) Any vendor who, in disclosing the information required under subsections
32 (a) and (b) of this section, makes any untrue statement of a material fact, or omits to
33 state a material fact necessary in order to make the statements made, in the light of
34 circumstances under which they were made, not misleading, shall be liable to any
35 person purchasing a unit from the vendor for those damages proximately caused by
36 the vendor's untrue statement or omission. However, an action may not be maintained
37 to enforce any liability created under this section unless brought within 1 year after
38 the facts constituting the cause of action are or should have been discovered.

1 (g) The rights of a purchaser under this section may not be waived in the
 2 contract of sale and any attempted waiver is void. However, if any purchaser proceeds
 3 to closing, [his] **THE PURCHASER'S** right under this section to rescind is terminated.

4 (h) This section does not apply to the sale of any unit which is to be occupied
 5 and used for nonresidential purposes.

6 (i) This section applies to the sale of any unit offered for sale in the State
 7 without regard to the location of the condominium.

8 (j) The provisions of this section do not apply to a sale of a unit in an action
 9 to foreclose a mortgage or deed of trust.

10 11–135.

11 (a) Except as provided in [subsection (b) of this section] **§ 11–135.1 OF THIS**
 12 **TITLE**, a contract for the resale of a unit by a unit owner other than a developer is not
 13 enforceable **BY THE SELLER** unless [the contract of sale contains in conspicuous type
 14 a notice in the form specified in subsection (g)(1) of this section, and the unit owner
 15 furnishes to the purchaser not later than 15 days prior to closing]:

16 **(1) THE PURCHASER IS GIVEN THE DISCLOSURES SET FORTH IN**
 17 **SUBSECTION (B) OF THIS SECTION;**

18 **(2) THE PURCHASER IS GIVEN NOTICE OF ANY CHANGES IN THE**
 19 **MANDATORY FEES AND PAYMENTS EXCEEDING 10% OF THE AMOUNT**
 20 **PREVIOUSLY STATED TO EXIST AND ANY OTHER SUBSTANTIAL AND MATERIAL**
 21 **AMENDMENTS TO THE DISCLOSURES AFTER THEY BECOME KNOWN TO THE**
 22 **SELLER; AND**

23 **(3) THE CONTRACT OF SALE CONTAINS A NOTICE IN**
 24 **CONSPICUOUS TYPE, IN A FORM SUBSTANTIALLY THE SAME AS THE FOLLOWING:**

25 **“NOTICE**

26 **THIS SALE IS SUBJECT TO THE MARYLAND CONDOMINIUM ACT (“ACT”).**
 27 **THE ACT REQUIRES THAT THE SELLER DISCLOSE TO YOU CERTAIN**
 28 **INFORMATION CONCERNING THE CONDOMINIUM, WHICH IS DESCRIBED IN §**
 29 **11–135 OF THE ACT. THIS INFORMATION MUST INCLUDE AT LEAST THE**
 30 **FOLLOWING:**

31 **(I) A COPY OF THE DECLARATION (OTHER THAN THE**
 32 **PLATS);**

33 **(II) A COPY OF THE BYLAWS;**

1 (III) A COPY OF THE RULES AND REGULATIONS OF THE
2 CONDOMINIUM;

3 (IV) A CERTIFICATE CONTAINING:

4 1. A STATEMENT DISCLOSING THE EFFECT ON THE
5 PROPOSED CONVEYANCE OF ANY RIGHT OF FIRST REFUSAL OR OTHER
6 RESTRAINT ON THE FREE ALIENABILITY OF THE UNIT, OTHER THAN ANY
7 RESTRAINT CREATED BY THE UNIT OWNER;

8 2. A STATEMENT OF THE AMOUNT OF THE MONTHLY
9 COMMON EXPENSE ASSESSMENT AND ANY UNPAID COMMON EXPENSE OR
10 SPECIAL ASSESSMENT CURRENTLY DUE AND PAYABLE FROM THE SELLING UNIT
11 OWNER;

12 3. A STATEMENT OF ANY OTHER FEES PAYABLE BY
13 THE UNIT OWNERS TO THE COUNCIL OF UNIT OWNERS;

14 4. A STATEMENT OF ANY CAPITAL EXPENDITURES
15 APPROVED BY THE COUNCIL OF UNIT OWNERS OR ITS AUTHORIZED DESIGNEE
16 PLANNED AT THE TIME OF THE CONVEYANCE WHICH ARE NOT REFLECTED IN
17 THE CURRENT OPERATING BUDGET INCLUDED IN THE CERTIFICATE;

18 5. THE MOST RECENTLY PREPARED BALANCE SHEET
19 AND INCOME AND EXPENSE STATEMENT, IF ANY, OF THE CONDOMINIUM;

20 6. THE CURRENT OPERATING BUDGET OF THE
21 CONDOMINIUM, INCLUDING DETAILS CONCERNING THE AMOUNT OF THE
22 RESERVE FUND FOR REPAIR AND REPLACEMENT AND ITS INTENDED USE, OR A
23 STATEMENT THAT THERE IS NO RESERVE FUND;

24 7. A STATEMENT OF ANY JUDGMENTS AGAINST THE
25 CONDOMINIUM AND THE EXISTENCE OF ANY PENDING SUITS TO WHICH THE
26 COUNCIL OF UNIT OWNERS IS A PARTY;

27 8. A STATEMENT GENERALLY DESCRIBING ANY
28 INSURANCE POLICIES PROVIDED FOR THE BENEFIT OF THE UNIT OWNERS, A
29 NOTICE THAT THE POLICIES ARE AVAILABLE FOR INSPECTION STATING THE
30 LOCATION AT WHICH THEY ARE AVAILABLE, AND A NOTICE THAT THE TERMS OF
31 THE POLICY PREVAIL OVER THE GENERAL DESCRIPTION;

1 **9. A STATEMENT AS TO WHETHER THE COUNCIL OF**
2 **UNIT OWNERS HAS KNOWLEDGE THAT ANY ALTERATION OR IMPROVEMENT TO**
3 **THE UNIT OR TO THE LIMITED COMMON ELEMENTS ASSIGNED TO THE UNIT**
4 **VIOLATES ANY PROVISION OF THE DECLARATION, BYLAWS, OR RULES OR**
5 **REGULATIONS;**

6 **10. A STATEMENT AS TO WHETHER THE COUNCIL OF**
7 **UNIT OWNERS HAS KNOWLEDGE OF ANY VIOLATION OF THE HEALTH OR**
8 **BUILDING CODES WITH RESPECT TO THE UNIT, THE LIMITED COMMON**
9 **ELEMENTS ASSIGNED TO THE UNIT, OR ANY OTHER PORTION OF THE**
10 **CONDOMINIUM;**

11 **11. A STATEMENT OF THE REMAINING TERM OF ANY**
12 **LEASEHOLD ESTATE AFFECTING THE CONDOMINIUM AND THE PROVISIONS**
13 **GOVERNING ANY EXTENSION OR RENEWAL OF THE LEASEHOLD ESTATE; AND**

14 **12. A DESCRIPTION OF ANY RECREATIONAL OR**
15 **OTHER FACILITIES WHICH ARE TO BE USED BY THE UNIT OWNERS OR**
16 **MAINTAINED BY THEM OR THE COUNCIL OF UNIT OWNERS, AND A STATEMENT**
17 **AS TO WHETHER OR NOT THEY ARE TO BE A PART OF THE COMMON ELEMENTS;**

18 **(v) A STATEMENT BY THE UNIT OWNER AS TO WHETHER**
19 **THE UNIT OWNER HAS KNOWLEDGE:**

20 **1. THAT ANY ALTERATION TO THE UNIT OR TO THE**
21 **LIMITED COMMON ELEMENTS ASSIGNED TO THE UNIT VIOLATES ANY PROVISION**
22 **OF THE DECLARATION, BYLAWS, OR RULES AND REGULATIONS;**

23 **2. OF ANY VIOLATION OF THE HEALTH OR BUILDING**
24 **CODES WITH RESPECT TO THE UNIT OR THE LIMITED COMMON ELEMENTS**
25 **ASSIGNED TO THE UNIT; OR**

26 **3. THAT THE UNIT IS SUBJECT TO AN EXTENDED**
27 **LEASE UNDER § 11-137 OF THIS TITLE OR UNDER LOCAL LAW, AND IF SO, A**
28 **COPY OF THE LEASE MUST BE PROVIDED; AND**

29 **(vi) A WRITTEN NOTICE OF THE UNIT OWNER'S**
30 **RESPONSIBILITY FOR THE COUNCIL OF UNIT OWNERS' PROPERTY INSURANCE**
31 **DEDUCTIBLE AND THE AMOUNT OF THE DEDUCTIBLE.**

32 **IF YOU DO NOT RECEIVE THIS INFORMATION AT LEAST 7 CALENDAR DAYS**
33 **BEFORE ENTERING INTO A CONTRACT FOR THE PURCHASE OF THE UNIT, YOU**
34 **HAVE THE RIGHT TO CANCEL THE CONTRACT WITHOUT PENALTY, AT ANY TIME**

1 **WITHIN 7 DAYS FOLLOWING DELIVERY TO YOU OF ALL OF THIS INFORMATION.**
2 **HOWEVER, ONCE THE SALE IS CLOSED, YOUR RIGHT TO CANCEL THE CONTRACT**
3 **IS TERMINATED.”.**

4 **(B) THE SELLER SHALL PROVIDE THE PURCHASER THE FOLLOWING**
5 **INFORMATION IN WRITING:**

6 (1) A copy of the declaration (other than the plats);

7 (2) The bylaws;

8 (3) The rules or regulations of the condominium;

9 (4) A certificate containing:

10 (i) A statement disclosing the effect on the proposed conveyance
11 of any right of first refusal or other restraint on the free alienability of the unit other
12 than any restraint created by the unit owner;

13 (ii) A statement setting forth the amount of the monthly
14 common expense assessment and any unpaid common expense or special assessment
15 currently due and payable from the selling unit owner;

16 (iii) A statement of any other fees payable by the unit owners to
17 the council of unit owners;

18 (iv) A statement of any capital expenditures approved by the
19 council of unit owners planned at the time of the conveyance which are not reflected in
20 the current operating budget disclosed under item (vi) of this item;

21 (v) The most recent regularly prepared balance sheet and
22 income expense statement, if any, of the condominium;

23 (vi) The current operating budget of the condominium including
24 details concerning the reserve fund for repair and replacement and its intended use, or
25 a statement that there is no reserve fund;

26 (vii) A statement of any judgments against the condominium and
27 the existence of any pending suits to which the council of unit owners is a party;

28 (viii) A statement generally describing any insurance policies
29 provided for the benefit of unit owners, a notice that copies of the policies are available
30 for inspection, stating the location at which the copies are available, and a notice that
31 the terms of the policy prevail over the description;

32 (ix) A statement as to whether the council of unit owners has
33 knowledge that any alteration or improvement to the unit or to the limited common

1 elements assigned to the unit violates any provision of the declaration, bylaws, or
2 rules or regulations;

3 (x) A statement as to whether the council of unit owners has
4 knowledge of any violation of the health or building codes with respect to the unit, the
5 limited common elements assigned to the unit, or any other portion of the
6 condominium;

7 (xi) A statement of the remaining term of any leasehold estate
8 affecting the condominium and the provisions governing any extension or renewal
9 thereof; and

10 (xii) A description of any recreational or other facilities which are
11 to be used by the unit owners or maintained by them or the council of unit owners, and
12 a statement as to whether or not they are to be a part of the common elements;

13 (5) A statement by the unit owner as to whether the unit owner has
14 knowledge:

15 (i) That any alteration to the unit or to the limited common
16 elements assigned to the unit violates any provision of the declaration, bylaws, or
17 rules and regulations;

18 (ii) Of any violation of the health or building codes with respect
19 to the unit or the limited common elements assigned to the unit; and

20 (iii) That the unit is subject to an extended lease under § 11–137
21 of this title or under local law, and if so, a copy of the lease must be provided; and

22 (6) A written notice of the unit owner's responsibility for the council of
23 unit owners' property insurance deductible and the amount of the deductible.

24 [(b) A contract for the resale by a unit owner other than a developer of a unit
25 in a condominium containing less than 7 units is not enforceable unless the contract of
26 sale contains in conspicuous type a notice in the form specified in subsection (g)(2) of
27 this section, and the unit owner furnishes to the purchaser not later than 15 days
28 prior to closing:

29 (1) A copy of the declaration (other than the plats);

30 (2) The bylaws;

31 (3) The rules and regulations of the condominium;

32 (4) A statement by the unit owner of the unit owner's expenses during
33 the preceding 12 months relating to the common elements; and

1 (5) A written notice of the unit owner's responsibility for the council of
2 unit owners' property insurance deductible and the amount of the deductible.]

3 (c) (1) The council of unit owners, within [20] 7 days after a written
4 request by a [unit owner] **SELLER** and receipt of a reasonable fee therefor, not to
5 exceed the cost to the council of unit owners, if any, shall furnish a certificate
6 containing the information necessary to enable the [unit owner] **SELLER** to comply
7 with subsection [(a)] **(B)** of this section. A [unit owner] **SELLER** providing a certificate
8 under subsection [(a)] **(B)** of this section is not liable to the purchaser for any
9 erroneous information provided by the council of unit owners and included in the
10 certificate.

11 (2) With respect to the remaining information that the [unit owner]
12 **SELLER** is required to disclose under subsection [(a)] **(B)** of this section that is not
13 provided by the council of unit owners and included in the certificate, a [unit owner]
14 **SELLER**:

15 (i) Except as provided in item (ii) of this paragraph, is liable to
16 the purchaser under this section for damages proximately caused by:

17 1. An untrue statement about a material fact; and

18 2. An omission of a material fact that is necessary to
19 make the statements made not misleading, in light of the circumstances under which
20 the statements were made; and

21 (ii) Is not liable to the purchaser under this section if the
22 [owner] **SELLER** had, after reasonable investigation, reasonable grounds to believe,
23 and did believe, at the time the information was provided to the purchaser, that the
24 statements were true and that there was no omission to state a material fact
25 necessary to make the statements made not misleading, in light of the circumstances
26 under which the statements were made.

27 (d) A purchaser is not liable for any unpaid assessment or fee greater than
28 the amount set forth in the certificate prepared by the council of unit owners. A [unit
29 owner] **SELLER** is not liable to a purchaser for the failure or delay of the council of
30 unit owners to provide the certificate in a timely manner.

31 (e) The rights of a purchaser under this section may not be waived in the
32 contract of sale, and any attempted waiver is void. However, if a purchaser proceeds to
33 closing, [his] **THE PURCHASER'S** right to rescind the contract under subsection (f) of
34 this section is terminated.

35 (f) (1) **(I)** [Any purchaser may at any time within 7 days following
36 receipt of all of the information required under subsection (a) or (b) of this section,
37 whichever is applicable, rescind in writing the contract of sale without stating any

1 reason and without any liability on his part] **IF A PURCHASER HAS NOT RECEIVED**
 2 **ALL OF THE DISCLOSURES REQUIRED UNDER SUBSECTION (B) OF THIS SECTION**

18 You should review the MHAA information carefully to ascertain your rights,
19 responsibilities, and obligations within the development.”

20 (b) The vendor shall provide the purchaser the following information in
21 writing:

- 22 (1) A statement as to whether the lot is located within a development;
- 23 (2) (i) The current monthly fees or assessments imposed by the
24 homeowners association upon the lot;
- 25 (ii) The total amount of fees, assessments, and other charges
26 imposed by the homeowners association upon the lot during the prior fiscal year of the
27 homeowners association; and
- 28 (iii) A statement of whether any of the fees, assessments, or
29 other charges against the lot are delinquent;
- 30 (3) The name, address, and telephone number of the management
31 agent of the homeowners association, or other officer or agent authorized by the
32 homeowners association to provide to members of the public, information regarding

1 the homeowners association and the development, or a statement that no agent or
2 officer is presently so authorized by the homeowners association;

3 (4) A statement as to whether the owner has actual knowledge of:

4 (i) The existence of any unsatisfied judgments or pending
5 lawsuits against the homeowners association; and

6 (ii) Any pending claims, covenant violations actions, or notices
7 of default against the lot; and

8 (5) A copy of:

9 (i) The articles of incorporation, the declaration, and all
10 recorded covenants and restrictions of the primary development, and of other related
11 developments to the extent reasonably available, to which the purchaser shall become
12 obligated on becoming an owner of the lot, including a statement that these obligations
13 are enforceable against an owner's tenants, if applicable; and

14 (ii) The bylaws and rules of the primary development, and of
15 other related developments to the extent reasonably available, to which the purchaser
16 shall become obligated on becoming an owner of the lot, including a statement that
17 these obligations are enforceable against an owner and the owner's tenants, if
18 applicable.

19 (c) (1) Within 30 calendar days of any resale transfer of a lot within a
20 development, the transferor shall notify the homeowners association for the primary
21 development of the transfer.

22 (2) The notification shall include, to the extent reasonably available,
23 the name and address of the transferee, the name and forwarding address of the
24 transferor, the date of transfer, the name and address of any mortgagee, and the
25 proportionate amount of any outstanding homeowners association fee or assessment
26 assumed by each of the parties to the transaction.

27 (d) **[The] EXCEPT AS PROVIDED IN SUBSECTION (E) OF THIS SECTION,**
28 **THE** requirements of subsection (b) of this section shall be deemed to have been
29 fulfilled if the information required to be disclosed is provided to the purchaser in
30 writing in a clear and concise manner. The disclosures may be summarized or
31 produced in any collection of documents, including plats, the declaration, or the
32 organizational documents of the homeowners association, provided those documents
33 effectively convey the required information to the purchaser.

34 **(E) (1) (I) SUBJECT TO THE PROVISIONS OF SUBPARAGRAPH (II)**
35 **OF THIS PARAGRAPH, IF ANY OF THE INFORMATION REQUIRED TO BE**
36 **DISCLOSED BY SUBSECTION (B) OF THIS SECTION CONCERNS PROPERTY THAT IS**

1 SUBJECTED TO A DECLARATION BY A PERSON WHO IS NOT AFFILIATED WITH
2 THE VENDOR, WITHIN 7 CALENDAR DAYS AFTER RECEIPT OF A WRITTEN
3 REQUEST FROM THE VENDOR OF THE PROPERTY, AND RECEIPT OF A
4 REASONABLE FEE NOT TO EXCEED THE COST, IF ANY, OF REPRODUCTION, AN
5 UNAFFILIATED DECLARANT SHALL NOTIFY THE VENDOR IN WRITING OF THE
6 INFORMATION THAT IS CONTAINED IN THE DEPOSITORY, AND FURNISH THE
7 INFORMATION NECESSARY TO ENABLE THE VENDOR TO COMPLY WITH
8 SUBSECTION (B) OF THIS SECTION.

9 (II) AN UNAFFILIATED DECLARANT MAY NOT BE REQUIRED
10 TO FURNISH INFORMATION REGARDING A HOMEOWNERS ASSOCIATION OVER
11 WHICH THE UNAFFILIATED DECLARANT HAS NO CONTROL, OR WITH RESPECT
12 TO ANY DECLARATION THAT THE UNAFFILIATED DECLARANT DID NOT FILE.

13 (2) A VENDOR IS NOT LIABLE TO THE PURCHASER FOR ANY
14 ERRONEOUS INFORMATION PROVIDED BY AN UNAFFILIATED DECLARANT, SO
15 LONG AS THE VENDOR PROVIDES THE PURCHASER WITH A CERTIFICATE
16 STATING THE NAME OF THE PERSON WHO PROVIDED THE INFORMATION ALONG
17 WITH AN ADDRESS AND TELEPHONE NUMBER FOR CONTACTING THE PERSON.

18 (F) IN SATISFYING A VENDOR'S REQUEST FOR ANY INFORMATION
19 DESCRIBED UNDER SUBSECTION (B) OF THIS SECTION, A HOMEOWNERS
20 ASSOCIATION:

21 (1) SHALL BE ENTITLED TO DIRECT THE VENDOR TO OBTAIN THE
22 INFORMATION FROM THE DEPOSITORY FOR ALL DISCLOSURES CONTAINED IN
23 THE DEPOSITORY AFTER JUNE 30, 1989; AND

24 (2) MAY NOT BE REQUIRED TO SUPPLY A VENDOR WITH ANY
25 INFORMATION THAT IS CONTAINED IN THE DEPOSITORY.

26 [(e)] (G) In satisfying the requirements of subsection (b) of this section, the
27 vendor shall be entitled to rely upon the disclosures contained in the depository after
28 June 30, 1989.

29 [(f)] (H) The provisions of [subsections (a), (b), (d), and (e) of] this section do
30 not apply to the sale of a lot in an action to foreclose a mortgage or deed of trust.

31 11B-108.

32 (a) A person who enters into a contract as a purchaser but who has not
33 received all of the disclosures required by § 11B-105, § 11B-106, or § 11B-107 of this
34 title, as applicable, shall, prior to settlement, be entitled to cancel the contract and to
35 the immediate return of deposits made on account of the contract.

1 (b) (1) Any purchaser who has not received all of the disclosures required
2 under § 11B-105 or § 11B-106 of this title, as applicable, ~~[5]~~ 7 calendar days or more
3 before the contract was entered into, within ~~[5]~~ 7 calendar days following receipt by
4 the purchaser of the disclosures required by § 11B-105(a) and (b) or § 11B-106(a) and
5 (b) of this title, as applicable, may cancel in writing the contract without stating a
6 reason and without liability on the part of the purchaser.

7 (2) The purchaser shall be entitled to the return of any deposits made
8 on account of the contract, except that the vendor shall be entitled to retain the cost of
9 reproducing the information specified in § 11B-105(b), § 11B-106(b), or § 11B-107(b)
10 of this title, as applicable, or \$100, whichever amount is less, if the disclosures are not
11 returned to the vendor at the time the contract is cancelled.

12 (c) Any purchaser may within 3 calendar days following receipt by the
13 purchaser of a change in mandatory fees and payments exceeding ~~[10 percent]~~ 10% of
14 the amount previously stated to exist or any other substantial and material
15 amendment to the disclosures required by § 11B-105 or § 11B-106 of this title, as
16 applicable, which adversely affects the purchaser, cancel in writing the contract
17 without stating a reason and without liability on the part of the purchaser, and the
18 purchaser shall be entitled to the return of deposits made on account of the contract.

19 (c-1) If any deposits are held in trust by a licensed real estate broker, the
20 return of the deposits to a purchaser under subsection (a), (b), or (c) of this section
21 shall comply with the procedures set forth in § 17-505 of the Business Occupations
22 and Professions Article.

23 (d) The rights of a purchaser under this section may not be waived in the
24 contract and any attempted waiver is void. However, if any purchaser proceeds to
25 settlement, the purchaser's right to cancel under this section is terminated.

26 (e) In satisfying the requirements of subsection (b) of this section, the vendor
27 shall be entitled to rely upon the disclosures contained in the depository after June 30,
28 1989.

29 (f) The provisions of this section do not apply to a sale of a lot in an action to
30 foreclose a mortgage or deed of trust.

31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
32 construed to apply only prospectively and may not be applied or interpreted to have
33 any effect on or application to any contract for the sale or resale of a unit in a
34 condominium or a lot in a homeowners association used for residential purposes before
35 the effective date of this Act.
