A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Medical Assistance Program – Limited Behavioral Health Services**

3 FOR the purpose of requiring, beginning on a certain date, the Maryland Medical
4 Assistance Program to provide limited behavioral health services to individuals
5 under a certain age regardless of whether the individual has a behavioral health
6 diagnosis; requiring the Maryland Department of Health to seek input from
7 stakeholders to determine the limited behavioral health services to be covered; and
8 generally relating to the Maryland Medical Assistance Program and limited
9 behavioral health services.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
27 That the Laws of Maryland read as follows:

Article – Health – General

15–103.

(a) (1) The Secretary shall administer the Maryland Medical Assistance Program.

(2) The Program:

(xxi) Beginning on January 1, 2024, shall provide gender–affirming treatment in accordance with § 15–151 of this subtitle; [and]

(xxii) Beginning on July 1, 2025, shall provide, subject to the limitations of the State budget, and as permitted by federal law, coverage for biomarker testing in accordance with § 15–859 of the Insurance Article; AND

(XXIII) BEGINNING ON JANUARY 1, 2025, SHALL PROVIDE COVERAGE FOR LIMITED BEHAVIORAL HEALTH SERVICES TO INDIVIDUALS UNDER THE AGE OF 18 YEARS REGARDLESS OF WHETHER THE INDIVIDUAL HAS A BEHAVIORAL HEALTH DIAGNOSIS IN ACCORDANCE WITH § 15–141.5 OF THIS SUBTITLE.

15–141.5.

(A) (1) THE PROGRAM SHALL PROVIDE LIMITED BEHAVIORAL HEALTH SERVICES TO INDIVIDUALS UNDER THE AGE OF 18 YEARS REGARDLESS OF WHETHER THE INDIVIDUAL HAS A BEHAVIORAL HEALTH DIAGNOSIS.

(2) THE LIMITED BEHAVIORAL HEALTH SERVICES REQUIRED TO BE PROVIDED UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL INCLUDE:

(I) EVALUATION AND TREATMENT PLANNING;

(II) FAMILY THERAPY;

(III) GROUP THERAPY;

(IV) INDIVIDUAL THERAPY;

(V) SERVICES RELATED TO PREVENTION, PROMOTION, EDUCATION, OR OUTREACH; AND

1 **(VI) ANY OTHER SERVICES DETERMINED NECESSARY BY THE**
2 **DEPARTMENT BASED ON INPUT RECEIVED FROM STAKEHOLDERS IN ACCORDANCE**
3 **WITH SUBSECTION (B) OF THIS SECTION.**

4 **(B) TO DETERMINE THE LIMITED BEHAVIORAL HEALTH SERVICES TO BE**
5 **PROVIDED UNDER SUBSECTION (A) OF THIS SECTION, THE DEPARTMENT SHALL**
6 **SEEK INPUT FROM STAKEHOLDERS WHO HAVE EXPERIENCE WITH BEHAVIORAL**
7 **HEALTH ISSUES, INCLUDING:**

8 **(1) INDIVIDUALS UNDER THE AGE OF 18 YEARS;**

9 **(2) PARENTS; AND**

10 **(3) HEALTH CARE PROVIDERS.**

11 **(C) ON OR BEFORE JANUARY 1 EACH YEAR, THE DEPARTMENT SHALL**
12 **REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2-1257 OF THE**
13 **STATE GOVERNMENT ARTICLE, ON THE LIMITED BEHAVIORAL HEALTH SERVICES**
14 **PROVIDED UNDER THIS SECTION, INCLUDING THE DEMOGRAPHICS OF THE**
15 **INDIVIDUALS RECEIVING THE SERVICES.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2024.
