CHAPTER 114-B		
INNOVATIVE LEARNING FUND		
§2661. Innovative Learning Fund		
1. Innovative Learning Fund. The Innovative Learning Fund, referred to in this section as "the fund," is established in the department as a nonlapsing fund to provide grants to promote innovative learning strategies to address student achievement gaps.		
2. Grants. The department shall establish criteria to award grants to school administrative units from the fund. In awarding grants, the department shall give special consideration to school administrative units that demonstrate instructional partnerships with professional organizations or companies and partnerships with institutions of higher education and that provide specific data on closing the achievement gap for economically disadvantaged students, racial and ethnic populations and students whose learning achievements were negatively affected due to restrictions during the pandemic related to coronavirus disease 2019, referred to as COVID-19.
