1 Section 1. Section 28-320.01, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 28-320.01 (1) A person commits sexual assault of a child
- 4 in the second or third degree: if
- 5 (a) When he or she subjects another person under fourteen
- 6 years of age or younger to sexual contact and the actor is at least
- 7 nineteen years of age or older; or -
- 8 (b) When he or she subjects another person who is at
- 9 <u>least fourteen years of age but less than sixteen years of age to</u>
- 10 sexual contact and the actor is twenty-five years of age or older.
- 11 (2) Sexual assault of a child is in the second degree if
- 12 the actor causes serious personal injury to the victim. Sexual
- 13 assault of a child in the second degree is a Class II felony for the
- 14 first offense.
- 15 (3) Sexual assault of a child is in the third degree if
- 16 the actor does not cause serious personal injury to the victim.
- 17 Sexual assault of a child in the third degree is a Class IIIA felony
- 18 for the first offense.
- 19 (4) Any person who is found guilty of second degree
- 20 sexual assault of a child under this section and who has previously
- 21 been convicted (a) under this section, (b) under section 28-319 of
- 22 first degree or attempted first degree sexual assault, (c) under
- 23 section 28-319.01 for first degree or attempted first degree sexual
- 24 assault of a child, or (d) in any other state or federal court under
- 25 laws with essentially the same elements as this section, section

1 28-319, or section 28-319.01 shall be guilty of a Class IC felony and

- 2 shall be sentenced to a mandatory minimum term of twenty-five years
- 3 in prison.
- 4 (5) Any person who is found guilty of third degree sexual
- 5 assault of a child under this section and who has previously been
- 6 convicted (a) under this section, (b) under section 28-319 of first
- 7 degree or attempted first degree sexual assault, (c) under section
- 8 28-319.01 for first degree or attempted first degree sexual assault
- 9 of a child, or (d) in any other state or federal court under laws
- 10 with essentially the same elements as this section, section 28-319,
- or 28-319.01 shall be guilty of a Class IC felony.
