An application shall be 4 accompanied by the proper fee. For permits, provisional 5 licenses or driver's licenses other than those issued pursuant to the New Mexico Commercial Driver's License Act, submission 6 7 of a complete application with payment of the fee entitles the 8 applicant to not more than three attempts to pass the 9 examination within a period of six months from the date of application. 10

An application shall contain the applicant's Β. full <u>legal</u> name; social security number, [or individual tax identification number] except for an applicant ineligible for a social security number; date of birth; sex; and New Mexico residence address of the applicant and briefly describe the applicant and indicate whether the applicant has previously been licensed as a driver and, if so, when and by what state or country and whether any such license has ever been suspended or revoked or whether an application has ever been refused and, if so, the date of and reason for the suspension, revocation or refusal. [For foreign nationals applying for driver's licenses, the secretary shall accept the individual taxpayer identification number as a substitute for a social security number regardless of immigration status.] The secretary is authorized to establish by regulation other documents that may

<u>C. An applicant who is a foreign national shall</u> provide proof of authorized period of admission into the United <u>States.</u>

An application by a foreign national shall contain the unique identifying number of the foreign national's 8 valid passport, valid visa, employment authorization card 9 issued under the applicant's approved deferred action status or 10 other arrival-departure record or document issued by the 11 12 federal government and the expiration date of the foreign national's authorized period of admission or extension of stay 13 as demonstrated on the foreign national's valid passport, valid 14 visa, employment authorization card issued under the 15 applicant's approved deferred action status or arrival-16 departure record or other document issued by the federal 17 government. The department may issue to an eligible foreign 18 national applicant a driver's license that is valid only for 19 the duration of the foreign national's authorized period of 20 admission or extension of stay and that shall state that it is 21 term limited. 22

Failure to disclose any such 2 conviction prevents the issuance of a driver's license, 3 provisional license, temporary license or instruction permit 4 for a period of one year if the failure to disclose is discovered by the department prior to issuance. If the nondisclosure is discovered by the department subsequent to 6 7 issuance, the department shall revoke the driver's license, 8 provisional license, temporary license or instruction permit 9 for a period of one year. Intentional and willful failure to disclose, as required in this subsection, is a misdemeanor.

[<del>D.</del>] <u>F.</u> An applicant under eighteen years of age who is making an application for a first New Mexico driver's license shall submit evidence that the applicant has:

(1) successfully completed a driver education course approved by the bureau that included a DWI prevention and education component. The bureau may accept verification of driver education course completion from another state if the driver education course substantially meets the requirements of the bureau for a course offered in New Mexico;

(2) had a provisional license for at least the twelve-month period immediately preceding the date of the application for the driver's license; provided that thirty days shall be added to the twelve-month period for each adjudication or conviction of a traffic violation committed during the time the person was driving with a provisional license;
