

ASSEMBLY BILL NO. 462—COMMITTEE ON WAYS AND MEANS

SUMMARY—Appropriates to and authorizes the expenditure of money by the Desert Regional Center within the Division of Mental Health and Developmental Services of the Department of Health and Human Services for a new computer system for medical records, provider invoices and claims processing. (BDR S-1179)

AN ACT making an appropriation to the Desert Regional Center within the Division of Mental Health and Developmental Services of the Department of Health and Human Services for a new computer system for medical records, provider invoices and claims processing; authorizing the Desert Regional Center to expend certain other money for the same purpose; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General
2 Fund to the Desert Regional Center within the Division of Mental
3 Health and Developmental Services of the Department of Health
4 and Human Services the sum of \$938,119 for a new computer
5 system for the Center's medical records, provider invoices and
6 claims processing.

1 **Sec. 2.** Expenditure of the sum of \$579,591 not appropriated
2 from the State General Fund or the State Highway Fund is hereby
3 authorized during the fiscal years beginning on July 1, 2013, and
4 ending on June 30, 2015, by the Desert Regional Center within the
5 Division of Mental Health and Developmental Services of the
6 Department of Health and Human Services for a new computer
7 system for the Center's medical records, provider invoices and
8 claims processing.

9 **Sec. 3.** Any remaining balance of the appropriation made by
10 section 1 of this act must not be committed for expenditure after
11 June 30, 2015, by the Desert Regional Center within the Division of
12 Mental Health and Developmental Services of the Department of
13 Health and Human Services or any entity to which money from the
14 appropriation is granted or otherwise transferred in any manner, and
15 any portion of the appropriated money remaining must not be spent
16 for any purpose after September 18, 2015, by either the Desert
17 Regional Center or the entity to which the money was subsequently
18 granted or transferred, and must be reverted to the State General
19 Fund on or before September 18, 2015.

20 **Sec. 4.** This act becomes effective upon passage and approval.
