14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. NEW LAW A new section of law to be codified
16	in the Oklahoma Statutes as Section 9211 of Title 74, unless there
17	is created a duplication in numbering, reads as follows:
18	There is hereby created in the State Treasury a revolving fund
19	for the Oklahoma Broadband Office to be designated the "Broadband
20	Administrative Expenses Revolving Fund". The fund shall be a
21	continuing fund, not subject to fiscal year limitations, and shall
22	consist of all monies received by the Oklahoma Broadband Office from
23	appropriations and such other sources as may be provided by law.
24	All monies accruing to the credit of the fund are hereby

1	appropriated and may be budgeted and expended by the Oklahoma
2	Broadband Office for the purpose of funding administrative costs and
3	needs that are otherwise disallowed by or not covered by federal
4	grant programs. Expenditures from said fund shall be made upon
5	warrants issued by the State Treasurer against claims filed as
6	prescribed by law with the Director of the Office of Management and
7	Enterprise Services for approval and payment.
8	SECTION 2. It being immediately necessary for the preservation
9	of the public peace, health or safety, an emergency is hereby
10	declared to exist, by reason whereof this act shall take effect and
11	be in full force from and after its passage and approval.
