16	have the sole and exclusive jurisdiction to determine the
17	entitlement of any owner in a well to:
18	1. Its share of proceeds from production; or
19	2. Damages, interest, court costs, attorneys' <u>attorney</u> fees or
20	allowable litigation expenses incurred as a result of the violation
21	of this act the Production Revenue Standards Act.
22	B. Any rulemaking power granted to the Corporation Commission
23	by the Production Revenue Standards Act shall neither preclude nor
24	impair the right of any owner to obtain through the district courts

C. Any owner injured in business or property by reason of any
action in violation of the provisions of the Production Revenue
Standards Act shall have the right to:

1. Recover actual damages so sustained; and

9 2. Obtain specific performance where equitable.

10 The prevailing party in any court proceeding brought pursuant to the 11 Production Revenue Standards Act shall be entitled to recover the 12 costs of the suit, including but not limited to reasonable attorney 13 and expert witness fees.

D. <u>1.</u> For purposes of the Production Revenue Standards Act,
the statute of limitations on actions brought pursuant to the
provisions of the Production Revenue Standards Act shall be five (5)
years from the date the cause of action shall have accrued₇;
provided, however, nothing shall create, limit or expand any statute
of limitations applicable to production occurring prior to September
1, 1992.

5	B. The statute of limitations established pursuant to Section
6	570.14 of Title 52 of the Oklahoma Statutes shall apply to the
