AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for application for vehicle
- 3 registration.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 1305(a) of Title 75 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 1305. Application for registration.
- 9 (a) General rule. -- Application for the registration of a
- 10 vehicle shall be made to the department upon the appropriate
- 11 form or forms furnished by the department. The application shall
- 12 contain the full name and address of the owner or owners,
- 13 <u>including county of residence</u>; the make, model, year and vehicle
- 14 identification number of the vehicle; and such other information
- 15 as the department may require. Program participants in the
- 16 Address Confidentiality Program under 23 Pa.C.S. Ch. 67
- 17 (relating to domestic and sexual violence victim address

- 1 confidentiality) may use a substitute address designated by the
- 2 Office of Victim Advocate as their address. Applicants for
- 3 registration of a truck, truck tractor, trailer or bus shall
- 4 provide the vehicle's Gross Vehicle Weight Rating (GVWR), or the
- 5 Gross Combination Weight Rating (GCWR), as applicable. If the
- 6 manufacturer's ratings are not available, the applicant shall
- 7 provide sufficient information as to the horsepower, braking
- 8 capacity and such other data as necessary for the department to
- 9 determine an equivalent measure of the vehicle's hauling and
- 10 stopping capability. If the applicant wishes to register a
- 11 vehicle at a registered gross weight less than the gross vehicle
- 12 weight rating, the application shall include information as to
- 13 weight, load and any other such information as the department
- 14 may require. The application shall be accompanied by self-
- 15 certification of financial responsibility and the applicable
- 16 fee.
