- AN ACT Amending Title 12 (Commerce and Trade) of the Pennsylvania Consolidated Statutes, providing for Commonwealth Economic 2 Development Action Team. 3 The General Assembly of the Commonwealth of Pennsylvania 4 5 hereby enacts as follows: 6 Section 1. - 1 § 901. Scope of chapter.
- 2 This chapter relates to the Commonwealth Economic Development
- 3 Action Team.
- 4 § 902. Definitions.
- 5 The following words and phrases when used in this chapter
- 6 shall have the meanings given to them in this section unless the
- 7 <u>context clearly indicates otherwise:</u>
- 8 <u>"Committee." The Commonwealth Economic Development Selection</u>
- 9 and Organization Committee established under section 907(a)
- 10 (relating to Commonwealth Economic Development Selection and
- 11 Organization Committee).
- 12 <u>"Executive agency." A department, board or commission of the</u>
- 13 Executive Department which is under the policy supervision and
- 14 <u>control of the Governor.</u>
- 15 "Executive director." The executive director of the team
- 16 appointed under section 903(b) (relating to Commonwealth
- 17 Economic Development Action Team).
- 18 "Permit." An authorization issued by an executive agency to
- 19 perform an activity regulated by the executive agency.
- 20 "Project." An effort by a qualified business which will
- 21 result in any of the following:
- 22 (1) A meaningful increase in the number of jobs in this
- 23 Commonwealth.
- 24 (2) A substantial increase in the amount of tax revenue
- collected by the Commonwealth.
- 26 "Qualified business." A business that is authorized to do
- 27 business in this Commonwealth and has received an evaluation
- 28 under section 904(c) (relating to powers and duties of team).
- 29 "Team." The Commonwealth Economic Development Action Team
- 30 established under section 903(a).

- 1 <u>"Team member." An employee of the department who has been</u>
- 2 appointed as staff of the team under section 903(c).
- 3 § 903. Commonwealth Economic Development Action Team.
- 4 (a) Establishment. -- The Commonwealth Economic Development
- 5 Action Team is established as an office within the department.
- 6 (b) Executive director. -- The team shall be directed by an
- 7 <u>executive director</u>. Within 90 days of the effective date of this
- 8 <u>section</u>, the committee shall appoint an executive director to
- 9 <u>direct the team. The Executive Board established under section</u>
- 10 204 of the act of April 9, 1929 (P.L.177, No.175), known as The
- 11 Administrative Code of 1929, shall set the compensation of the
- 12 <u>executive director</u>.
- (c) Staffing. -- The executive director shall appoint
- 14 <u>individuals</u>, including experienced economic development
- 15 professionals, to act as staff of the team as may be
- 16 appropriate. The executive director may contract for additional
- 17 services as necessary for the performance of the executive
- 18 <u>director's duties</u>.
- 19 (d) Legal services. -- The Office of General Counsel shall
- 20 provide legal services as necessary to the team.
- 21 (e) Administrative services.--
- 22 (1) The department shall provide administrative services
- 23 <u>and staff to the team. The team shall reimburse the</u>
- 24 department for the cost of providing the administrative
- 25 <u>services and staff under this paragraph.</u>
- 26 (2) The executive director may enter into an agreement
- 27 <u>with the department specifying the rights and obligations of</u>
- the team and the department in carrying out their duties to
- 29 each other under this chapter and to further the intent of
- 30 this chapter.

- 1 (f) Appropriation. -- The appropriation for the team shall be
- 2 in a separate line item and shall be under the jurisdiction of
- 3 the executive director.
- 4 § 904. Powers and duties of team.
- 5 (a) Single point of contact. -- The team shall serve as a
- 6 single point of contact for a business considering moving to,
- 7 considering expanding in or seeking to maintain operations in
- 8 <u>this Commonwealth.</u>
- 9 (b) Regional offices. -- The executive director shall
- 10 establish appropriate regions and regional offices for the team
- 11 <u>across this Commonwealth.</u>
- 12 (c) Needs evaluation.--Upon the request of a business, the
- 13 team shall evaluate the needs of the business and a proposed
- 14 project, including all of the following:
- 15 (1) The overall economic impact of the proposed project.
- 16 (2) The financial condition of the business.
- 17 (3) The strength of the business model of the business.
- 18 (4) The strength of the commitments for private
- 19 financing for the proposed project.
- 20 (5) The competitive posture of the proposed project.
- 21 (d) Assignment of team members. -- The team shall assign a
- 22 team member for a qualified business, who shall serve as the
- 23 primary point of contact for the qualified business and the
- 24 team.
- 25 (e) Referrals for assistance. -- Upon completing an evaluation
- 26 under subsection (c), the team may refer a qualified business
- 27 <u>for assistance under section 905 (relating to assistance for</u>
- 28 qualified businesses) and other economic development programs.
- 29 <u>(f) Survey and feedback.--The team shall annually survey</u>
- 30 qualified businesses and provide an opportunity to submit

- 1 feedback on the assistance provided under this chapter. The team
- 2 shall provide the survey results and feedback under this
- 3 subsection to the committee.
- 4 (g) Performance metrics. -- The team shall collect and compile
- 5 performance metrics relating to the actions of the team,
- 6 <u>including the data necessary to compile the annual report under</u>
- 7 <u>section 908 (relating to annual report).</u>
- 8 § 905. Assistance for qualified businesses.
- 9 (a) Site selection. -- The team shall do all of the following:
- 10 (1) Maintain a site selection database on a publicly
- 11 <u>accessible Internet website, which shall include a voluntary</u>
- 12 registration of business site locations and information on
- 13 available resources.
- 14 (2) Provide individualized site selection assistance for
- 15 a qualified business.
- 16 (b) Interagency coordination. -- The team shall do all of the
- 17 following:
- 18 (1) Coordinate the involvement of executive agencies in
- 19 a project.
- 20 (2) Facilitate introductions with relevant executive
- 21 agencies.
- 22 (3) To the extent permitted by law and policy of an
- 23 executive agency, facilitate the permit review and approval
- for a project.
- 25 (c) Economic development referral. -- The team shall refer a
- 26 qualified business to economic development programs and other
- 27 grant programs that are available to the qualified business.
- 28 (d) General development consultations. -- At the request of a
- 29 qualified business, consult with an executive agency about
- 30 applications by the qualified business for a program or permit

- 1 administered by the executive agency.
- 2 (e) Designation for expedited permit review. -- At the request
- 3 of a qualified business, the team may designate a project as
- 4 being critical for the Commonwealth's overall economic strategy.
- 5 The team may make a designation under this subsection based on
- 6 the need for the projected growth or job creation which would be
- 7 generated by the successful completion of the project and the
- 8 viability of the project. Upon making a designation under this
- 9 subsection, the team shall notify the executive agencies with
- 10 which the qualified business is seeking a permit.
- 11 § 906. Duties of executive agencies.
- 12 (a) Consultation with team members.--Except as otherwise
- 13 provided by Federal law or an applicable duty or privilege, an
- 14 <u>executive agency shall agree to consult with a team member for</u>
- 15 the purpose of section 905(d) (relating to assistance for
- 16 <u>qualified businesses</u>). The executive agency may require a
- 17 qualified business to request the consultation under this
- 18 subsection in writing.
- 19 (b) Review of permits under expedited permit review.--Upon
- 20 notification of a designation under section 905(e), an executive
- 21 agency shall provide expedited permit review for all
- 22 applications for permits submitted by the qualified business for
- 23 the project which is the subject of the designation. The
- 24 expedited permit review under this subsection shall include
- 25 providing priority review and approval of the permit, to the
- 26 <u>extent feasible and permitted by Federal law.</u>
- 27 § 907. Commonwealth Economic Development Selection and
- 28 Organization Committee.
- 29 <u>(a) Establishment.--The Commonwealth Economic Development</u>
- 30 Selection and Organization Committee is established as a

- 1 committee within the team.
- 2 (b) Duties. -- The committee shall establish all of the
- 3 following:
- 4 (1) Procedures to select the executive director.
- 5 (2) The operational budget of the team.
- 6 (c) Composition. -- The committee shall be comprised of the
- 7 <u>following members:</u>
- 8 <u>(1) The Governor or a designee.</u>
- 9 (2) The State Treasurer or a designee.
- 10 (3) The Auditor General or a designee.
- 11 (4) The Majority Leader of the Senate or a designee.
- 12 (5) The Minority Leader of the Senate or a designee.
- 13 (6) The Majority Leader of the House of Representatives
- or a designee.
- 15 (7) The Minority Leader of the House of Representatives
- or a designee.
- 17 (d) Operations.--
- 18 (1) The committee shall conduct a meeting to organize
- 19 within 30 days of the effective date of this paragraph.
- 20 (2) The members of the committee shall select a member
- 21 of the committee to serve as chair. The chair shall call
- 22 meetings of the committee.
- 23 (3) The committee shall act upon a vote of the majority
- of the members of the committee.
- 25 <u>§ 908. Annual report.</u>
- 26 (a) Report.--No later than March 31, 2024, and each March 31
- 27 thereafter, the executive director shall publish an annual
- 28 report on the team.
- 29 (b) Contents. -- The annual report under subsection (a) shall
- 30 include all of the following information:

Τ	(1) The number of businesses that used the team as a
2	single point of contact under section 904(a) (relating to
3	powers and duties of team) during the prior calendar year.
4	(2) The number of businesses that were evaluated under
5	section 904(c) during the prior calendar year.
6	(3) The number of qualified businesses which received
7	assistance from the team during the prior calendar year.
8	(4) To the extent possible, all of the following
9	<pre>information:</pre>
10	(i) The number of jobs retained in this Commonwealth
11	for projects that received assistance from the team.
12	(ii) The number of jobs added in this Commonwealth
13	for projects that received assistance from the team.
14	(iii) The amount of additional capital investment in
15	this Commonwealth for projects that received assistance
16	from the team.
17	Section 2. The Governor's Action Team is abolished. All
18	personnel, allocations, appropriations, equipment, files,
19	records, contracts, agreements, obligations and other materials
20	which are used, employed or expended in connection with the
21	functions of the Governor's Action Team are transferred to the
22	Commonwealth Economic Development Action Team, with the same
23	force and effect as if:
24	(1) The allocations and appropriations had been made to
25	the Commonwealth Economic Development Action Team in the
26	first instance.
27	(2) The personnel, equipment, files, records and other
28	materials of the Governor's Action Team had been the
29	personnel and property of the Commonwealth Economic
30	Development Action Team in the first instance.

- 1 (3) The contracts, agreements and obligations of the
- 2 Governor's Action Team had been incurred or entered into by
- 3 the Commonwealth Economic Development Action Team.
- 4 Section 3. Except as otherwise provided under 12 Pa.C.S. Ch.
- 5 9, all activities initiated by the Governor's Action Team prior
- 6 to the effective date of this section shall continue and remain
- 7 in full force and effect and may be completed by the
- 8 Commonwealth Economic Development Action Team. Orders,
- 9 regulations, rules and decisions which were made prior to the
- 10 effective date of this section and which are in effect on the
- 11 effective date of this section shall remain in full force and
- 12 effect until revoked, vacated or modified by the Commonwealth
- 13 Economic Development Action Team. Contracts, obligations and
- 14 collective bargaining agreements entered into by the Governor's
- 15 Action Team are not affected nor impaired by this act.
- 16 Section 4. This act shall take effect in 60 days.
