AN ACT

Amending the act of November 10, 1999 (P.L.491, No.45), entitled "An act establishing a uniform construction code; imposing 2 3 powers and duties on municipalities and the Department of 4 Labor and Industry; providing for enforcement; imposing 5 penalties; and making repeals," in adoption and enforcement by municipalities, providing for fire protection services 6 7 fee. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. The act of November 10, 1999 (P.L.491, No.45), 11 known as the Pennsylvania Construction Code Act, is amended to 12 by adding a section to read: Section 501.1. Fire protection services fee. 13 14 (a) Fee. -- Municipalities administering and enforcing the 15 provisions of this act may assess a fee of not more than \$30 for 16 fire protection services on each occupancy permit issued under this act. The fee for fire protection services shall be in 17 addition to any other fee imposed on the occupancy permit. The 18

- 5 (2) Rescue vehicles or utility or special services
- 6 vehicles used by volunteer firefighters or firefighters
- 7 <u>employed by municipalities during firefighting, emergency</u>
- 8 <u>responding services and training purposes.</u>
- 9 <u>(3) Construction or maintenance of firehouses utilized</u>
- 10 <u>by volunteer firefighters or firefighters employed by</u>
- 11 <u>municipalities.</u>
- 12 <u>(4) Salaries of paid firefighters who are employed by a</u>
- 13 <u>municipality</u>.
- 14 (b) Definitions.--As used in this section, the following
- 15 words and phrases shall have the meaning given to them in this
- 16 subsection:
- 17 <u>"Accessory equipment."</u> Firefighting and rescue equipment
- 18 necessary to carry out the ordinary functions of supporting fire
- 19 and rescue activities.
- 20 "Apparatus equipment." Elevated equipment, pumpers, tankers,
- 21 ladder trucks, utility or special service vehicles, rescue
- 22 vehicles or other large equipment used by firefighters.
- "Communications equipment." Any voice or original
- 24 <u>transmission system required to support the operation of a fire</u>
- 25 company.
- 26 "Firehouse." Facilities used by fire companies to house
- 27 <u>firefighting equipment. The term shall not include meeting</u>
- 28 halls, social rooms or any other facilities not directly related
- 29 to firefighting.
- 30 "Protective equipment." Any equipment used by firefighters

- 1 to protect their persons from injury while performing their
- 2 functions, including, but not limited to, helmets, turnout coats
- 3 and pants, boots, eyeshields, gloves and self-contained
- 4 <u>respiratory protection units.</u>
- 5 <u>"Rescue vehicle."</u> Any vehicle used for the rescue services.
- 6 <u>"Utility or special service vehicle." A vehicle carrying</u>
- 7 accessory equipment, including, but not limited to, ladders,
- 8 oxygen equipment, generators and adapters, floodlights, smoke
- 9 ejectors and other equipment necessary to perform the ordinary
- 10 <u>functions of supporting firefighting activities.</u>
- 11 Section 2. This act shall take effect in 60 days.
