AN ACT

- 1 Amending Titles 13 (Commercial Code) and 42 (Judiciary and 2 Judicial Procedure) of the Pennsylvania Consolidated
- 3 Statutes, in general provision, providing for construction;
- and in particular rights and immunities, further providing
- for required disclosures in connection with rental-purchase
- agreement and for lessee's right to acquire ownership.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Title 13 of the Pennsylvania Consolidated
- 10 Statutes is amended by adding a section to read:
- 11 § 1109. Construction.
- 12 <u>Nothing in this title shall be construed to modify or</u>
- 13 supersede the provisions of 42 Pa.C.S. Ch. 69 (relating to
- 14 particular rights and immunities).
- 15 Section 2. Sections 6903(a)(10) and 6905 of Title 42 are
- 16 amended to read:
- 17 § 6903. Required disclosures in connection with rental-purchase
- 18 agreement.
- 19 (a) General rule. -- A lessor shall disclose all of the

- 1 following in a clear and conspicuous manner:
- 2 * * *
- 3 (10) That the lessee has the option to purchase the
- 4 rented property at any time [and at what price or by what
- formula or method the purchase price will be determined] at a
- 6 price or by a formula or method specified in the rental-
- 7 purchase agreement.
- 8 * * *
- 9 § 6905. Lessee's right to acquire ownership.
- 10 (a) Limitation on cost of lease services. -- The total amount
- 11 charged by the lessor for the cost of lease services in a
- 12 rental-purchase transaction shall not exceed the cash price of
- 13 the property.
- 14 (b) Acquisition of ownership.--[At] <u>A rental-purchase</u>
- 15 agreement must provide that at any time after tendering an
- 16 initial rental payment, a lessee may acquire ownership of the
- 17 property that is the subject of the rental-purchase agreement
- 18 [by tendering an amount equal at a maximum to the amount by
- 19 which the cash price of the leased property exceeds 50% of all
- 20 rental payments made by the lessee.] at a price or by a formula
- 21 or method specified in the rental-purchase agreement.
- 22 <u>(c) Chart.--A rental-purchase agreement must be accompanied</u>
- 23 by a chart showing the amount required to exercise the option to
- 24 purchase the rented property after each rental payment if rental
- 25 payments are made as scheduled.
- 26 Section 3. This act shall take effect in 60 days.
