- 16 OR POTENTIAL DISASTER, MASS CASUALTY SITUATION OR SUBSTANTIAL
- 17 THREAT TO PUBLIC HEALTH, A VEHICLE OWNED BY A COUNTY OR REGIONAL
- 18 POLICE ASSOCIATION AND OPERATED BY A POLICE OFFICER THAT IS USED
- 19 FOR POLICE TRANSPORT OR VICTIM EXTRACTION, ANY VEHICLE OPERATED

- 1 (1) A POLICE CHIEF AND ASSISTANT CHIEF.
- 2 (2) A FIRE CHIEF, ASSISTANT CHIEF AND, WHEN A FIRE
- 3 COMPANY HAS THREE OR MORE FIRE VEHICLES, A SECOND OR THIRD
- 4 ASSISTANT CHIEF.
- 5 (3) A FIRE POLICE CAPTAIN AND FIRE POLICE LIEUTENANT.
- 6 (4) AN AMBULANCE CORPS COMMANDER AND ASSISTANT
- 7 COMMANDER.
- 8 (5) A RIVER RESCUE COMMANDER AND ASSISTANT COMMANDER.
- 9 (6) A COUNTY EMERGENCY MANAGEMENT COORDINATOR.
- 10 (7) A FIRE MARSHAL.
- 11 (8) A RESCUE SERVICE CHIEF AND ASSISTANT CHIEF.
