AN ACT

Making appropriations to the Trustees of the University of 1 Pennsylvania. 2 The General Assembly of the Commonwealth of Pennsylvania 3 4 hereby enacts as follows: 5 Section 1. (a) The sum of \$31,660,000, or as much thereof 6 as may be necessary, is hereby appropriated to the Trustees of the University of Pennsylvania for the fiscal year July 1, 2020, 7 to June 30, 2021, for veterinary activities. 8 9 The sum of \$295,000, or as much thereof as may be (b) 10 necessary, is hereby appropriated to the Trustees of the 11 University of Pennsylvania for the fiscal year July 1, 2020, to 12 June 30, 2021, for the Center for Infectious Diseases. 13 Section 2. (a) Payments to the University of Pennsylvania on account of the appropriations provided in section 1 shall be 14 15 made quarterly by the Secretary of Agriculture on the basis of 16 costs during the fiscal year and shall be conditioned on 17 continuing authority for inclusion on the Board of Trustees of 18 the University of Pennsylvania of a minimum of four persons who

1 are not elected officials and who are appointed by the President 2 pro tempore of the Senate, the Minority Leader of the Senate, 3 the Speaker of the House of Representatives and the Minority 4 Leader of the House of Representatives for terms of office 5 coterminous with that of the respective appointing authority; 6 and shall be further conditioned on these appointees receiving 7 full voting rights as members of the board of trustees.

8 (b) The University of Pennsylvania shall provide full, 9 complete and accurate information as may be required by the 10 Department of Agriculture or the chairman or the minority 11 chairman of the Appropriations Committee of the Senate or the 12 chairman or the minority chairman of the Appropriations 13 Committee of the House of Representatives.

The University of Pennsylvania shall report its revenues 14 (C) 15 and expenditures and present its financial statements in 16 accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the 17 "Higher Education Finance Manual (1975)" and the "Commonwealth 18 of Pennsylvania Budget Instructions for the State System of 19 20 Higher Education, State-Related Universities and Non-State-Related Colleges and Universities." 21

22 The Trustees of the University of Pennsylvania shall (d) report on forms provided by the Department of Agriculture to 23 24 both the chairman and minority chairman of the Appropriations 25 Committee of the Senate and the chairman and minority chairman 26 of the Appropriations Committee of the House of Representatives 27 by September 30, 2021, on how State-appropriated funds were expended for fiscal year 2020-2021 to reduce the costs to 28 29 Pennsylvania resident students or to provide services to 30 Pennsylvania residents.
