AN ACT

- Providing for regional response health collaborations to promote health in facilities by supporting COVID-19 readiness and
- response and improving the quality of infection prevention.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Regional
- 8 Response Health Collaborative Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Assisted living residence." As defined in section 1001 of
- 14 the act of June 13, 1967 (P.L.31, No.21), known as the Human
- 15 Services Code.
- 16 "Authority." The Commonwealth Financing Authority.

- 1 "COVID-19." The novel coronavirus as identified in the
- 2 Governor's Proclamation of Disaster Emergency issued on March 6,
- 3 2020, published at 50 Pa.B. 1644 (March 21, 2020).
- 4 "Emergency medical services agency." As defined in 35
- 5 Pa.C.S. § 8103 (relating to definitions).
- 6 "Facility." Any of the following:
- 7 (1) An assisted living residence.
- 8 (2) A long-term care nursing facility.
- 9 (3) A personal care home.
- 10 "Federal funds." Funds received from the Federal Government
- 11 to fight COVID-19 under the Federal Coronavirus Aid, Relief, and
- 12 Economic Security Act (Public Law 116-136, 134 Stat. 281).
- "Health collaborative." A collaboration of a local health
- 14 care system that provides educational support and clinical
- 15 coaching in a specific region of this Commonwealth.
- 16 "Long-term care nursing facility." As defined in section
- 17 802.1 of the act of July 19, 1979 (P.L.130, No.48), known as the
- 18 Health Care Facilities Act.
- 19 "Personal care home." As defined in section 1001 of the
- 20 Human Services Code.
- 21 "Region." The following areas of this Commonwealth:
- 22 (1) Northeast.
- 23 (2) Southeast.
- 24 (3) North central.
- 25 (4) South central.
- 26 (5) Northwest.
- 27 (6) Southwest.
- 28 Section 3. Regional response health collaborative.
- 29 (a) Division. -- The authority shall divide this Commonwealth
- 30 into regions and shall delineate all of the facilities within

- 1 the parameters of a region.
- 2 (b) Proposals. -- The authority shall solicit proposals from
- 3 health collaboratives to provide operations, management and
- 4 administration of the purposes provided under subsection (e) in
- 5 each region to protect residents in facilities from COVID-19.
- 6 (c) Contract. -- The authority shall contract with at least
- 7 one health collaborative in each region for the purposes
- 8 provided under subsection (e).
- 9 (d) Appropriation. -- The amount of \$500,000,000 of the
- 10 Federal funds is appropriated to the authority for the purposes
- 11 of this act. The authority shall distribute the funds to each
- 12 health collaborative contracted under subsection (c).
- 13 (e) Purpose.--Each health care collaborative shall:
- 14 (1) Promote health and stabilize the economy of the
- region by directly supporting COVID-19 readiness and response
- in facilities.
- 17 (2) Improve the quality of care related to infection
- 18 prevention and other priority health care conditions common
- 19 to facilities.
- 20 (3) Expand COVID-19 testing to include asymptomatic
- 21 staff and residents in facilities to expand public health
- 22 surveillance.
- 23 Section 4. Duties.
- 24 (a) Review.--Each health collaborative shall perform daily
- 25 strategic review of facilities in their region.
- 26 (b) Plan.--Through collaborative review of the clinical
- 27 situation within facilities identified as having unmet needs, a
- 28 health collaborative shall formulate an action plan tailored to
- 29 the facility, identifying specific resources or tactical actions
- 30 to implement to assist facilities.

- 1 (c) Components. -- A health collaborative shall provide for
- 2 the following as provided under section 5:
- 3 (1) Enhanced testing capability.
- 4 (2) Infection control consultation and implementation,
- 5 including contact tracing.
- 6 (3) Advanced clinical care, including remote monitoring
- 7 and physician consultation.
- 8 (d) Funds. -- A health collaborative shall:
- 9 (1) budget for and distribute funds provided by the
- 10 authority; and
- 11 (2) track and record the expense associated with each
- 12 type of testing and with implementing infection control
- 13 consultation across the region.
- 14 Section 5. Components.
- 15 (a) Enhanced testing. --
- 16 (1) If a facility experiences a positive test of COVID-
- 17 19, testing of facility residents and health care workers
- shall be conducted. Onsite testing shall be made available
- through mobile testing teams developed by the health
- 20 collaborative. The health collaborative shall coordinate the
- 21 testing response with participation from local emergency
- 22 medical services agencies and regional testing laboratories
- 23 to prioritize receipt of test results.
- 24 (2) A health collaborative shall deploy systematic
- 25 surveillance testing on a weekly basis using a random
- 26 sampling of not more than five asymptomatic residents in a
- facility. Results of the testing shall be shared with all
- 28 stakeholders and the Commonwealth.
- 29 (b) Infection control and consultation. -- A health
- 30 collaborative shall deploy clinical staff to perform onsite

- 1 observation and consultation as part of the mobile testing team.
- 2 The clinical staff shall:
- 3 (1) implement infection control practices, such as
- 4 cohorting, personal protective equipment use, case detection
- 5 and staffing practices; and
- 6 (2) facilitate completion of exposure tracing studies.
- 7 (c) Advanced clinical management assistance.--Clinical staff
- 8 shall provide onsite and telemedicine-supported clinical care
- 9 for a facility.
- 10 Section 6. Effective date.
- 11 This act shall take effect immediately.
