1 2 3 4 5 6 7 8 9 10 11 12 13 14	Amending the act of August 5, 1941 (P.L.752, No.286), entitled "An act regulating and improving the civil service of certain departments and agencies of the Commonwealth; vesting in the State Civil Service Commission and a Personnel Director certain powers and duties; providing for classification of positions, adoption of compensation schedules and certification of payrolls; imposing duties upon certain officers and employes of the Commonwealth; authorizing service to other State departments or agencies and political subdivisions of the Commonwealth in matters relating to civil service; defining certain crimes and misdemeanors; imposing penalties; making certain appropriations, and repealing certain acts and parts thereof," in prohibitions, penalties and enforcement, further providing for political activity.
15	The General Assembly of the Commonwealth of Pennsylvania
16	hereby enacts as follows:
17	Section 1. Section 905.2(b), (c) and (e) of the act of
18	August 5, 1941 (P.L.752, No.286), known as the Civil Service
19	Act, added June 26, 1989 (P.L.47, No.10), are amended and the
20	section is amended by adding a subsection to read:
21	Section 905.2. Political Activity* * *
22	[(b) No person in the classified service shall take an
23	active part in political management or in a political campaign.
24	Activities prohibited by this subsection include, but are not

1 limited to, the following activities:

2 (1) Serving as an officer of a political party, a member of
3 a National, State or local committee of a political party or an
4 officer or member of a committee of a partisan political club,
5 or being a candidate for any of these positions.

6 (2) Organizing or reorganizing a political party7 organization or political club.

8 (3) Directly or indirectly soliciting, receiving, 9 collecting, handling, disbursing or accounting for assessments, 10 contributions or other funds for a partisan political purpose. 11 (4) Organizing, selling tickets to, promoting or actively 12 participating in a fund-raising activity of a candidate in a 13 partisan election or of a political party, or political club.

14 (5) Taking an active part in managing the political campaign 15 of a candidate for public office in a partisan election or a 16 candidate for political party office.

17 (6) Becoming a candidate for, or campaigning for, an18 elective public office in a partisan election.

19 (7) Soliciting votes in support of or in opposition to a 20 candidate for public office in a partisan election or a 21 candidate for political party office.

(8) Acting as recorder, watcher, challenger or similar
officer at the polls on behalf of a political party or a
candidate in a partisan election.

(9) Driving voters to the polls on behalf of a politicalparty or a candidate in a partisan election.

(10) Endorsing or opposing a candidate for public office in a partisan election or a candidate for political party office in a political advertisement, a broadcast, campaign, literature or similar material.

(11) Serving as a delegate, alternate or proxy to a
 political party convention.

3 (12) Addressing a convention, caucus, rally or similar
4 gathering of a political party in support of or in opposition to
5 a partisan candidate for public office or political party
6 office.

7 (13) Initiating or circulating a partisan nominating8 petition.

9 (14) Soliciting, paying, collecting or receiving a 10 contribution at or in the workplace from any employe for any 11 political party, political fund or other partisan recipient.

12 (15) Paying a contribution at or in the workplace to any 13 employe who is the employer or employing authority of the person 14 making the contribution for any political party, political fund 15 or other partisan recipient.]

16 (c) An employe or individual to whom subsection (a) [or (b)] 17 applies retains the right to vote and to express an opinion on 18 political subjects and candidates, and may engage in the 19 following activities:

20 (1) Register and vote in any election.

(2) Express an opinion as an individual privately andpublicly on political subjects and candidates.

(3) Display a political picture, sticker, badge or buttonwhen not on duty and at locations other than the workplace.

(4) Participate in the nonpartisan activities of a civic,
community, social, labor or professional organization, or of a
similar organization.

28 (5) Be a member of a political party or other political 29 organization or club and participate in its activities to the 30 extent consistent with this section.

(6) Attend a political convention, rally, fund-raising
 function or other political gathering.

3 (7) Sign a political petition as an individual.

4 (8) Make a financial contribution to a political party or5 organization.

6 (9) Be politically active in connection with a question 7 which is not specifically identified with a political party, 8 such as a constitutional amendment, referendum, approval of a 9 municipal ordinance or any other question or issue of a similar 10 character.

(10) Otherwise participate fully in public affairs, except 11 12 as prohibited by law, in a manner which does not materially compromise efficiency or integrity as an employe or the 13 14 neutrality, efficiency or integrity of a Commonwealth agency. 15 (c.1) In addition to the activities permitted under subsection (c), a person in the classified service may take an 16 active part in political management or in a political campaign. 17 Activities permitted include, but are not limited to, the 18 19 following:

20 (1) Serving as an officer of a political party, a member of
21 a national, State or local committee of a political party or an
22 officer or member of a committee of a partisan political club,

23 or being a candidate for any of these positions.

28	(e) Subsection (c) <u>or (c.1)</u> does not authorize an employe to
29	engage in political activity while on duty or while in a uniform
30	that identifies him as an employe. The head of an agency may

prohibit or limit the participation of an employe or class of 1 employes of the agency in an activity permitted by subsection 2 (c) or (c.1), if participation in the activity would interfere 3 with the efficient performance of official duties or create a 4 conflict or apparent conflict of interests. An employe may not 5 do any of the following: 6 (1) Solicit, pay, collect or receive a contribution at or in 7 the workplace from any employe for any political party, 8 9 political fund or other partisan recipient. 10 (2) Pay a contribution at or in the workplace to any employe

11 who is the employer or employing authority of the person making

12 the contribution for any political party, political fund or

- 13 other partisan recipient.
