1 2 3	Amending Title 34 (Game) of the Pennsylvania Consolidated Statutes, in special licenses and permits, further providing for definitions and for exotic wildlife possession permits.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. The definitions of "exotic wildlife" and "exotic
7	wildlife dealer" in section 2961 of Title 34 of the Pennsylvania
8	Consolidated Statutes are amended to read:
9	§ 2961. Definitions.
10	The following words and phrases when used in this subchapter
11	shall have the meanings given to them in this section unless the
12	context clearly indicates otherwise:
13	* * *
14	"Exotic wildlife." The phrase includes[, but is not limited
15	to, all bears, coyotes, lions, tigers, leopards, jaguars,
16	cheetahs, cougars, wolves and any crossbreed of these animals
17	which have similar characteristics in appearance or features.
18	The definition is applicable whether or not the birds or animals

1	were bred or reared in captivity or imported from another state
2	or nation.] all nonindigenous animals and the following,
3	regardless of whether the animals are bred or reared in
4	captivity or imported from another state or nation:
5	(1) All members of the order Primates (nonhuman
6	primates).
7	(2) All members of the family Ursidae (bears).
8	(3) All members of the species:
9	<u>(i) Canis latrans (coyotes).</u>
10	<u>(ii) Canis lupus (gray wolves).</u>
11	<u>(iii) Canis rufus (red wolves).</u>
12	<u>(iv) Felis rufus (bobcat).</u>
13	(v) Panthera leo (lions).
14	<u>(vi) Panthera tigris (tigers).</u>
15	(vii) Panthera pardus (leopards).
16	(viii) Panthera unica (snow leopards).
17	(ix) Neofelis nebulosa (clouded leopard).
18	<u>(x) Panthera onca (jaguars).</u>
19	<u>(xi) Acinonyx jubatus (cheetahs).</u>
20	<u>(xii) Felis concolor (cougars).</u>
21	(xiii) Any crossbreed of the animals specified in
22	this paragraph which have similar characteristics in
23	<u>appearance or features.</u>
24	The term shall not be construed to include any member of the
25	class Aves (birds), any member of the families Equidae (horses,
26	asses and zebras), Camelidae (camels, alpacas and llamas),
27	Cervidae (deer, moose and elk), Bovidae (wild cattle and spiral-
28	horned antelopes), Muridae (rats and mice), Chinchillidae
29	(chinchillas and viscachas), Leporidae (rabbits and hares),

3	any "domestic animal" as that term is defined in 18 Pa.C.S. §
4	5511 (relating to cruelty to animals).
5	"Exotic wildlife dealer." Any person who <u>:</u>
6	(1) imports into this Commonwealth, possesses, buys,
7	sells, locates or finds for a fee, barters, donates, gives
8	away or otherwise disposes of [more than one bird or one
9	animal classified as] exotic wildlife [by this subchapter.];_

11	(2) engages in at least five documented transactions
12	annually involving exotic wildlife.

14	Section 2. Section 2963 of Title 34 is amended to read:
15	§ 2963. Exotic wildlife possession permits.
16	(a) AuthorizationThe commission may issue permits to
17	persons to possess exotic wildlife which shall authorize the
18	holder to purchase, receive or possess exotic wildlife from any
19	lawful source from within or without this Commonwealth.
20	<u>(a.1)</u> Prohibition
21	(1) Beginning January 1, 2015, the commission shall not
22	issue any new permits authorized under subsection (a) for the
23	possession of exotic wildlife, and shall only issue permits
24	as set forth in sections 2930 (relating to propagating
25	permits), 2962 (relating to exotic wildlife dealer permits)
26	and 2964(a) (relating to menagerie permits) and 58 Pa. Code §
27	147.302 (relating to general).
28	(2) (i) The provisions of paragraph (1) shall not apply
29	to a permit issued under subsection (a), provided that
30	the permit is issued prior to December 31, 2014. The

1	permit shall only authorize the continued possession,
2	after December 31, 2014, of the exotic wildlife
3	identified in the permit.
4	(ii) The provisions of paragraph (1) shall not apply
5	to a wildlife sanctuary for which the commission, in its
6	sole discretion, has designated a facility and authorized
7	it to operate as a place of refuge to provide temporary
8	or lifetime shelter, care and protection for abused,
9	neglected, unwanted, impounded, abandoned, orphaned or
10	displaced wildlife under the authority provided under
11	section 2902(c) (relating to general categories of
12	permits).
13	(3) The provisions of this section shall not apply to
14	any young born after December 31, 2014, from exotic wildlife
15	with a valid permit issued under subsection (a).
16	(b) Shelter, care and protectionNo permit provided for in
17	this section shall be granted until the commission is satisfied
18	that the provisions for housing and caring for such exotic
19	wildlife and for protecting the public are proper and adequate
20	and in accordance with the standards established by the
21	commission.
22	(c) Unlawful actsIt is unlawful for any person to:
23	(1) [Possess, purchase or receive exotic wildlife] <u>Keep</u>
24	exotic wildlife in captivity or have exotic wildlife in the
25	person's custody or control, without first securing a permit
26	[to possess exotic wildlife issued under this section or
27	regulations pertaining to this section] <u>issued by the</u>
28	commission as set forth in sections 2930, 2962, 2963 and
29	<u>2964(a) or 58 Pa. Code § 147.302</u> .
30	(2) [Release] <u>Violate any of the provisions of this</u>

1 <u>section or release</u> exotic wildlife into the wild.

2 (3) Fail to exercise due care in safeguarding the public3 from attack by exotic wildlife.

4 (4) Recklessly engage in conduct which places or may
5 place another person in danger of attack by exotic wildlife.
6 (d) Penalty.--

7 (1) A violation of this section relating to [permits is
8 a summary offense of the third degree] <u>unlawful release of</u>
9 <u>exotic wildlife is a misdemeanor offense</u>.

10 (2) Any other violation of this section is a summary
11 offense of the [fifth] <u>first</u> degree.

12 (3) Each day of violation shall constitute a separate 13 offense[, but under no circumstances shall the accumulated 14 penalty for purposes of a field receipt exceed \$300. There 15 shall be no limit on any accumulated penalty a court may 16 assess].

17 (4) A second or subsequent conviction within a seven 18 year period for a violation of subsection (c) (1) or (2) is a
 19 misdemeanor of the first degree.

(e) Discretion of director.--In addition to the penalties provided, the director may, for any violation of this section, revoke or suspend any permit and order the disposal of any exotic wildlife held.
