AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An-<--2 act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in terms and courses of study, further providing for agreements with institutions of higher education; in opportunities for educational excellence, further providing for definitions and for concurrent enrollment agreements; and extensively revising and adding-9 charter school provisions. 10 AMENDING THE ACT OF MARCH 10, 1949 (P.L.30, NO.14), ENTITLED "AN <--11 ACT RELATING TO THE PUBLIC SCHOOL SYSTEM, INCLUDING CERTAIN 12 PROVISIONS APPLICABLE AS WELL TO PRIVATE AND PAROCHIAL 13 SCHOOLS; AMENDING, REVISING, CONSOLIDATING AND CHANGING THE LAWS RELATING THERETO, " IN CHARTER SCHOOLS, FURTHER PROVIDING 15 FOR FUNDING FOR CHARTER SCHOOLS. 16 The General Assembly of the Commonwealth of Pennsylvania 17 18 hereby enacts as follows: 19 Section 1. Section 1525 of the act of March 10, 1949 <--(P.L.30, No.14), known as the Public School Code of 1949, added 20 July 4, 2004 (P.L.536, No.70), is amended to read:

- 2 Education. Notwithstanding any other provision of law to the
- 3 contrary, a school district, charter school, regional charter
- 4 school, cyber charter school or area vocational technical school
- 5 may enter into an agreement with one or more institutions of
- 6 higher education approved to operate in this Commonwealth in
- 7 order to allow [resident] students to attend such institutions
- 8 of higher education while the [resident] students are enrolled-
- 9 in the school district, charter school, regional charter school,
- 10 cyber charter school or area vocational technical school. The
- 11 agreement may be structured so that high school students may
- 12 receive credits toward completion of courses at the school-
- 13 district, charter school, regional charter school, cyber charter
- 14 <u>school or area vocational technical school</u> and at institutions
- 15 of higher education approved to operate in this Commonwealth.
- 16 Section 2. The definitions of "concurrent student" and
- 17 "school entity" in section 1602-B of the act, added July 13,
- 18 2005 (P.L.226, No.46), are amended to read:
- 19 Section 1602-B. Definitions.
- 20 The following words and phrases when used in this article-
- 21 shall have the meanings given to them in this section unless the-
- 22 context clearly indicates otherwise:
- 23 * * *
- 24 "Concurrent student." A student who is enrolled in a school
- 25 district, a charter school, a regional charter school, a cyber
- 26 charter school, an area vocational technical school, a nonpublic
- 27 school, a private school or a home education program under-
- 28 section 1327.1 and who takes a concurrent course through a
- 29 concurrent enrollment program.
- 30 * * *

- 1 "School entity." A school district, a charter school, a
- 2 regional charter school, a cyber charter school or an area
- 3 vocational-technical school.
- 4 * * *
- 5 Section 3. Section 1613 B of the act is amended by adding a
- 6 subsection to read:
- 7 Section 1613-B. Concurrent enrollment agreements.
- 8 * * *
- 9 <u>(c) Charter schools, regional charter schools and cyber</u>
- 10 <u>charter schools. Charter schools, regional charter schools and</u>
- 11 cyber charter schools shall have the power and authority to
- 12 <u>enter into a concurrent enrollment agreement with an institution</u>
- 13 <u>of higher education</u>, and appropriate credit shall be awarded to
- 14 students concurrently enrolled under the agreement.
- 15 Section 4. Section 1703 A of the act, amended June 29, 2002
- 16 (P.L.524, No.88), is amended to read:
- 17 Section 1703 A. Definitions. As used in this article,
- 18 "Administrator" shall include an employe of a charter school
- 19 entity, including the chief administrator of a charter school
- 20 entity and any other employe, who by virtue of the employe's
- 21 position is responsible for taking official action of a
- 22 <u>nonministerial nature with regard to contracting or procurement,</u>
- 23 administering or monitoring grants or subsidies, managing or
- 24 regulating staff, student and school activities or any activity
- 25 where the official action has an economic impact of greater than
- 26 a de minimis nature on the interests of any person.
- 27 "Appeal board" shall mean the State Charter School Appeal
- 28 Board established by this article.
- 29 "Assessment" shall mean the Pennsylvania System of School
- 30 Assessment test, the Keystone Exam or another test established

- 1 by the State board to meet the requirements of section 2603-
- 2 B(d)(10)(i) and required under the No Child Left Behind Act of
- 3 2001 (Public Law 107 110, 115 Stat. 1425) or its successor
- 4 <u>Federal statute.</u>
- 5 "At risk student" shall mean a student at risk of educational
- 6 failure because of limited English proficiency, poverty,
- 7 community factors, truancy, academic difficulties or economic-
- 8 disadvantage.
- 9 "Charter school" shall mean an independent public school
- 10 established and operated under a charter from the local board of
- 11 school directors and in which students are enrolled or attend. A
- 12 charter school must be organized as a public, nonprofit
- 13 corporation. Charters may not be granted to any for profit
- 14 entity.
- 15 <u>"Charter school entity" shall mean a charter school, regional</u>
- 16 <u>charter school or cyber charter school.</u>
- 17 "Charter school foundation" shall mean a nonprofit
- 18 organization under section 501(c)(3) of the Internal Revenue
- 19 Code of 1986 (Public Law 99 514, 26 U.S.C. \$ 501(c)(3)), that
- 20 provides funding, resources or otherwise serves to support a
- 21 charter school entity, either directly or through an affiliated
- 22 entity.
- 23 "Chief administrator" shall mean an individual appointed by a
- 24 board of trustees to oversee and manage the operation of a
- 25 charter school entity. The term shall not include a professional
- 26 staff member under this article.
- 27 ["Chief executive officer" shall mean an individual appointed
- 28 by the board of trustees to oversee and manage the operation of
- 29 the charter school, but who shall not be deemed a professional
- 30 staff member under this article.

- 1 "Cyber charter school" shall mean an independent public-
- 2 school established and operated under a charter from the
- 3 Department of Education and in which the school uses technology
- 4 in order to provide a significant portion of its curriculum and
- 5 to deliver a significant portion of instruction to its students
- 6 through the Internet or other electronic means. A cyber charter
- 7 school must be organized as a public, nonprofit corporation. A
- 8 charter may not be granted to a for profit entity.
- 9 "Department" shall mean the Department of Education of the
- 10 Commonwealth.
- 11 <u>"Educational management service provider" shall mean a</u>
- 12 nonprofit charter management organization, for profit education
- 13 management organization, school design provider, business
- 14 manager or any other partner entity with which a board of
- 15 trustees of a charter school entity contracts to provide
- 16 educational design, business services, comprehensive management
- 17 <u>or personnel functions or to implement the charter. The term</u>
- 18 shall not include a charter school foundation.
- "Immediate family member" shall mean a parent, spouse, child,
- 20 brother or sister.
- 21 "Local board of school directors" shall mean the board of
- 22 directors, School Reform Commission or other governing authority
- 23 of a school district in which a proposed or an approved charter
- 24 school is located.
- 25 "Nonrelated" shall mean an individual who is not an immediate
- 26 <u>family member</u>.
- 27 "Regional charter school" shall mean an independent public
- 28 school established and operated under a charter from more than
- 29 one local board of school directors and in which students are
- 30 enrolled or attend. A regional charter school must be organized

- 1 as a public, nonprofit corporation. Charters may not be granted
- 2 to any for profit entity.
- 3 "School district of residence" shall mean the school district
- 4 in this Commonwealth in which [the parents or quardians of a
- 5 child reside a child resides as determined under section 1302
- 6 and 22 Pa. Code § 11.11(a)(1) (relating to entitlement of
- 7 resident children to attend public schools).
- 8 "School entity" shall mean a school district, intermediate
- 9 unit, joint school or area vocational-technical school.
- 10 "Secretary" shall mean the Secretary of Education of the-
- 11 Commonwealth.
- 12 "State board" shall mean the State Board of Education of the
- 13 Commonwealth.
- 14 Section 4.1. The act is amended by adding a section to read:
- 15 Section 1704-A. Charter School Funding Advisory
- 16 <u>Commission. (1) The Governor shall immediately convene a</u>
- 17 Statewide advisory commission, to be known as the Charter School
- 18 Funding Advisory Commission, to examine the financing of charter
- 19 schools, regional charter schools and cyber charter schools in
- 20 the public education system. The commission shall examine how
- 21 charter school, regional charter school and cyber charter school
- 22 finances affect opportunities for teachers, parents, pupils and
- 23 community members to establish and maintain schools that operate
- 24 <u>independently from the existing school district structure as a</u>
- 25 method to accomplish the requirements of section 1702 A. The
- 26 Office of the Budget and the department shall provide
- 27 <u>administrative support, meeting space and any other assistance</u>
- 28 required by the commission to carry out its duties under this
- 29 section.
- 30 (2) The commission shall consist of the following members:

- 1 (i) Four members of the Senate appointed by the President
- 2 pro tempore of the Senate, in consultation with the Majority
- 3 Leader of the Senate and the Minority Leader of the Senate, with
- 4 two appointees from the majority party and two appointees from
- 5 <u>the minority party.</u>
- 6 <u>(ii)</u> Four members of the House of Representatives appointed
- 7 by the Speaker of the House of Representatives, in consultation
- 8 with the Majority Leader of the House of Representatives and the
- 9 <u>Minority Leader of the House of Representatives, with two</u>
- 10 appointees from the majority party and two appointees from the
- 11 <u>minority party.</u>
- 12 <u>(iii) The secretary or a designee.</u>
- 13 (iv) To represent the interests of charter school entities,
- 14 the following members, who shall be appointed by the Governor:
- 15 (A) One member who shall represent charter schools.
- 16 (B) One member who shall represent regional charter schools.
- 17 (C) One member who shall represent cyber charter schools.
- 18 (D) One member who shall be a teacher in a charter school
- 19 entity.
- 20 (E) One member who shall be a parent of a child attending a
- 21 charter school entity.
- 22 (v) To represent the interests of school districts, the
- 23 <u>following members, who shall be appointed by the Governor:</u>
- 24 (A) One member who shall be a teacher in a public school
- 25 <u>that is not a charter school entity.</u>
- 26 (B) One member who shall represent school administrators.
- 27 <u>(C) Two members who shall represent school board members.</u>
- 28 (D) One member who shall be a business manager of a school
- 29 district.
- 30 (vi) One member who shall represent an institution of higher

- 1 <u>education and who shall be appointed by the Governor.</u>
- 2 (3) Members of the commission shall be appointed within
- 3 twenty (20) days of the effective date of this section. Any
- 4 vacancy on the commission shall be filled by the original
- 5 appointing authority. The commission shall select a chairman and
- 6 <u>vice chairman from among its membership at an organizational</u>
- 7 meeting. The organizational meeting shall take place not later
- 8 than forty-five (45) days following the effective date of this
- 9 section.
- 10 (4) The commission shall hold meetings at the call of the
- 11 <u>chairman. The commission may also hold public hearings on the</u>
- 12 matters to be considered by the commission at locations
- 13 throughout this Commonwealth. All meetings and public hearings
- 14 of the commission shall be deemed public meetings for the
- 15 purpose of 65 Pa.C.S. Ch. 7 (relating to open meetings). Ten
- 16 (10) members of the commission shall constitute a quorum at any
- 17 meeting. Each member of the commission may designate another
- 18 person to represent that member at meetings of the commission.
- 19 (5) Commission members shall receive no compensation for
- 20 their services but shall be reimbursed by the department for all
- 21 necessary travel and other reasonable expenses incurred in
- 22 connection with the performance of their duties as members.
- 23 Whenever possible, the commission shall utilize the services and
- 24 expertise of existing personnel and staff of State government.
- 25 The department may utilize undistributed funds not expended,
- 26 <u>encumbered or committed from appropriations for grants and</u>
- 27 <u>subsidies made to the department, not to exceed three hundred</u>
- 28 thousand dollars (\$300,000), to carry out this section.
- 29 (6) The commission shall have the following powers and
- 30 duties:

- 1 <u>(i) Meet with current charter school entity operators,</u>
- 2 school district personnel and representatives of institutions of
- 3 higher education within this Commonwealth.
- 4 (ii) Review charter school entity financing laws in
- 5 operation throughout the United States.
- 6 (iii) Explore the actual cost of educating a child in a
- 7 <u>cyber charter school</u>.
- 8 (iv) Evaluate and make recommendations on the following:
- 9 (A) Consideration of establishing a higher education
- 10 authorizer of charter school entities.
- 11 <u>(a.1) Consideration of establishing an independent State</u>
- 12 <u>level board to authorize charter school entities and support</u>
- 13 <u>charter school quality and accountability through performance</u>
- 14 monitoring and technical assistance.
- 15 <u>(B) Appropriate assessment of fees on charter school</u>
- 16 <u>entities for potentially funding a higher education authorizer</u>
- 17 of charter school entities, including review of independent
- 18 authorizer fees and structures throughout the United States.
- 19 (C) The process by which charter school entities are funded
- 20 under section 1725 A, including the continuation of school
- 21 district deductions for food services and for retirement
- 22 contributions paid to the Public School Employees' Retirement
- 23 System and addressing other potential funding inequities.
- 24 (v) Issue a report pursuant to paragraph (7).
- 25 (7) The commission shall, no later than March 31, 2014,
- 26 issue a report of its findings and recommendations to the
- 27 Governor, the President pro tempore of the Senate, the Majority
- 28 Leader of the Senate, the Minority Leader of the Senate, the
- 29 <u>chairman and minority chairman of the Appropriations Committee</u>
- 30 of the Senate, the chairman and minority chairman of the

- 1 Education Committee of the Senate, the Speaker of the House of
- 2 Representatives, the Majority Leader of the House of
- 3 Representatives, the Minority Leader of the House of
- 4 Representatives, the chairman and minority chairman of the
- 5 Appropriations Committee of the House of Representatives and the
- 6 chairman and minority chairman of the Education Committee of the
- 7 House of Representatives. The recommendations of the commission
- 8 shall not take effect unless the recommendations are approved by

- 11 Section 5. Section 1715-A of the act, amended or added June
- 12 19, 1997 (P.L.225, No.22) and July 9, 2008 (P.L.846, No.61), is
- 13 amended to read:
- 14 Section 1715 A. Charter School Entity Requirements. (a)
- 15 Charter [schools] school entities shall be required to comply
- 16 with the following provisions:
- 17 (1) Except as otherwise provided in this article, a charter
- 18 school entity is exempt from statutory requirements established
- 19 in this act, from regulations of the State board and the
- 20 standards of the secretary not specifically applicable to-
- 21 charter [schools] school entities. Charter [schools] school
- 22 <u>entities</u> are not exempt from statutes applicable to public-
- 23 schools other than this act.
- 24 (2) A charter school entity shall be accountable to the
- 25 parents, the public and the Commonwealth, with the delineation
- 26 of that accountability reflected in the charter. Strategies for
- 27 meaningful parent and community involvement shall be developed
- 28 and implemented by each school.
- 29 (3) A charter school entity shall not unlawfully
- 30 discriminate in admissions, hiring or operation.

- 1 (4) A charter school entity shall be nonsectarian in all-
- 2 operations.
- 3 (5) (i) [A] Subject to subparagraph (ii), a charter school-
- 4 entity shall not provide any religious instruction, nor shall it
- 5 display religious objects and symbols on the premises of the
- 6 charter school[.] entity.
- 7 (ii) It shall not be a violation of this paragraph for a
- 8 <u>charter school entity to utilize a sectarian facility:</u>
- 9 (A) if the charter school entity provides for discrete and
- 10 separate entrances to buildings utilized for school purposes
- 11 <u>only;</u>
- 12 (B) if the religious objects and symbols within the portions
- 13 of the facility utilized by the school are covered or removed to
- 14 the extent reasonably feasible; or
- 15 (C) in which the unused portion of the facility or its
- 16 common areas contain religious symbols and objects.
- 17 (6) A charter school entity shall not advocate unlawful
- 18 behavior.
- 19 (7) A charter school or regional charter school shall only
- 20 be subject to the laws and regulations as provided for in-
- 21 section 1732 A, or as otherwise provided for in this [article]
- 22 act.
- 23 (7.1) A cyber charter school shall only be subject to the
- 24 laws and regulations as provided for in section 1749 A, or as
- 25 <u>otherwise provided for in this act.</u>
- 26 (8) A charter school entity shall participate in [the
- 27 Pennsylvania State Assessment System as provided for in 22 Pa.
- 28 Code Ch. 5 (relating to curriculum), or subsequent regulations
- 29 promulgated to replace 22 Pa. Code Ch. 5,] assessments in the
- 30 manner in which the school district in which the charter school-

- 1 <u>entity</u> is located is scheduled to participate.
- 2 (9) A charter school entity shall provide a minimum of one
- 3 hundred eighty (180) days of instruction or nine hundred (900)
- 4 hours per year of instruction at the elementary level, or nine
- 5 hundred ninety (990) hours per year of instruction at the-
- 6 secondary level. Nothing in this clause shall preclude the use-
- 7 of computer and satellite linkages for delivering instruction to-
- 8 students.
- 9 (10) Boards of trustees and contractors of charter [schools]
- 10 <u>school entities</u> shall be subject to the following statutory
- 11 requirements governing construction projects and construction-
- 12 related work:
- 13 (i) The following provisions of this act:
- 14 (A) Sections 751 and 751.1.
- 15 (B) Sections 756 and 757 insofar as they are consistent with
- 16 the act of December 20, 1967 (P.L.869, No.385), known as the
- 17 "Public Works Contractors' Bond Law of 1967."
- 18 (ii) Section 1 of the act of May 1, 1913 (P.L.155, No.104),
- 19 entitled "An act regulating the letting of certain contracts for-
- 20 the erection, construction, and alteration of public buildings."
- 21 (iii) The act of August 11, 1961 (P.L.987, No.442), known as
- 22 the "Pennsylvania Prevailing Wage Act."
- 23 (iv) The "Public Works Contractors' Bond Law of 1967."
- 24 (v) The act of March 3, 1978 (P.L.6, No.3), known as the
- 25 "Steel Products Procurement Act."
- 26 (11) Trustees of a charter school entity shall be public
- 27 officials[.] for the purposes of 65 Pa.C.S. Ch. 11 (relating to
- 28 ethics standards and financial disclosure) and shall file a
- 29 statement of financial interests for the preceding calendar year
- 30 with the State Ethics Commission and either the local board of

- 1 school directors in the case of a charter school or regional
- 2 <u>charter school</u>, or the department in the case of a cyber charter
- 3 school, not later than May 1 of each year that members hold the
- 4 position and of the year after a member leaves the position. All
- 5 members of the board of trustees of a charter school entity
- 6 <u>shall take the oath of office as required under section 321</u>
- 7 before entering upon the duties of their office.
- 8 [(12) A person who serves as an administrator for a charter
- 9 school shall not receive compensation from another charter-
- 10 school or from a company that provides management or other-
- 11 services to another charter school. The term "administrator"
- 12 shall include the chief executive officer of a charter school
- 13 and all other employes of a charter school who by virtue of
- 14 their positions exercise management or operational oversight
- 15 responsibilities. A person who serves as an administrator for a
- 16 charter school shall be a public official under 65 Pa.C.S. Ch.
- 17 11 (relating to ethics standards and financial disclosure). A
- 18 violation of this clause shall constitute a violation of 65
- 19 Pa.C.S. § 1103(a) (relating to restricted activities), and the
- 20 violator shall be subject to the penalties imposed under the
- 21 jurisdiction of the State Ethics Commission.]
- 22 <u>(b) An individual who serves as an administrator for a</u>
- 23 charter school entity shall be a public employe for the purposes
- 24 of 65 Pa.C.S. Ch. 11 and shall file a statement of financial
- 25 interests for the preceding calendar year with the board of
- 26 trustees not later than May 1 of each year that the person holds
- 27 the position and of the year after the person leaves the
- 28 position.
- 29 (c) (1) No individual who serves as an administrator for a
- 30 charter school entity may receive compensation from another

- 1 <u>charter school entity or from an educational management service</u>
- 2 provider, unless:
- 3 (i) The administrator has submitted a sworn statement to the
- 4 board of trustees of the charter school entity and the sworn
- 5 statement details the work for the other entity and includes the
- 6 projected number of hours, rate of compensation and projected
- 7 duration.
- 8 (ii) The board of trustees of the charter school entity has
- 9 <u>reviewed the sworn statement under subclause (i) and agreed, by</u>
- 10 resolution, to grant permission to the administrator.
- 11 (2) A copy of the sworn statement under clause (1) (i) and
- 12 the resolution by the board of trustees granting the permission
- 13 under clause (1) (ii) shall be provided to, and kept on file
- 14 with, the charter school entity and the local board of school
- 15 directors or, in the case of a cyber charter school, the
- 16 department.
- 17 (3) No administrator of a charter school entity or immediate
- 18 <u>family member of the administrator may serve as a voting member</u>
- 19 of the board of trustees of the charter school entity that
- 20 employs the administrator.
- 21 (4) (i) No administrator of a charter school entity may
- 22 participate in the selection, award or administration of a
- 23 contract if the person has a conflict of interest as that term
- 24 is defined in 65 Pa.C.S. § 1102 (relating to definitions).
- 25 (ii) An administrator who knowingly violates this clause
- 26 commits a violation of 65 Pa.C.S. § 1103(a) (relating to
- 27 restricted activities) and shall be subject to the penalties
- 28 imposed under the jurisdiction of the State Ethics Commission.
- 29 <u>(iii) Any contract made in violation of this clause shall be</u>
- 30 voidable by the board of trustees of the charter school entity.

- 1 (5) An administrator shall be immediately dismissed upon
- 2 conviction for an offense graded as a felony, an infamous crime,
- 3 an offense pertaining to fraud, theft or mismanagement of public-
- 4 funds or any crime involving moral turpitude.
- 5 Section 6. Section 1716 A(c) of the act, added June 19, 1997
- 6 (P.L.225, No.22), is amended and the section is amended by
- 7 adding subsections to read:
- 8 Section 1716 A. Powers of Board of Trustees. * * *
- 9 (b.1) (1) For a charter school or regional charter school
- 10 chartered after the effective date of this subsection, an-
- 11 <u>individual shall be prohibited from serving as a voting member</u>
- 12 <u>of the board of trustees of the charter school or regional</u>
- 13 <u>charter school if the individual or an immediate family member</u>
- 14 <u>receives compensation from or is employed by or is a member of</u>
- 15 the local board of school directors who participated in the
- 16 <u>initial review, approval, oversight, evaluation or renewal</u>
- 17 process of the charter school or regional charter school
- 18 chartered by that board.
- 19 (2) An employe of the school district that chartered a
- 20 charter school or regional charter school may serve as a member
- 21 of the board of trustees of the charter school or regional
- 22 <u>charter_school_without_voting_privileges.</u>
- 23 (b.2) (1) No member of the board of trustees of a charter
- 24 school entity may participate in the selection, award or
- 25 administration of any contract if the member has a conflict of
- 26 interest as that term is defined in 65 Pa.C.S. \$ 1102 (relating
- 27 to definitions).
- 28 (2) Any member of the board of trustees of a charter school
- 29 entity who in the discharge of the person's official duties
- 30 would be required to vote on a matter that would result in a-

- 1 conflict of interest shall abstain from voting and follow the
- 2 procedures required under 65 Pa.C.S. § 1103(j) (relating to
- 3 restricted activities).
- 4 <u>(3) A member of the board of trustees of a charter school</u>
- 5 entity who knowingly violates this subsection commits a
- 6 violation of 65 Pa.C.S. § 1103(a) and shall be subject to the
- 7 penalties imposed under the jurisdiction of the State Ethics

14	application, shall be clearly stated in the notice.
15	(3) Upon approval of a cyber charter school application,
16	a written charter shall be developed which shall contain the
