AN ACT

Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as reenacted, "An act relating to alcoholic liquors, alcohol and 2 malt and brewed beverages; amending, revising, consolidating 3 and changing the laws relating thereto; regulating and restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding 6 in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 7 8 persons engaged or employed therein; defining the powers and 9 10 duties of the Pennsylvania Liquor Control Board; providing for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," 16 further providing for malt and brewed beverages retail 17 licenses, for retail dispensers' restrictions on purchase and 18 sales, and for unlawful acts relative to malt or brewed 19 20 beverages and licensees. 21 The General Assembly of the Commonwealth of Pennsylvania 22 hereby enacts as follows: 23 Section 1. Section 432 of the act of April 12, 1951 (P.L.90, 24 No.21), known as the Liquor Code, reenacted and amended June 29, 25 1987 (P.L.32, No.14), is amended by adding a subsection to read: 26 Section 432. Malt and Brewed Beverages Retail Licenses. -- * *

- 1 (g) Hotel, eating places, or municipal golf course retail

- 12 regulation, the holder of a retail dispenser license may obtain
- 13 <u>a special permit to sell wine by the glass pursuant to section</u>
- 14 492(22) so long as that wine has been obtained from a winery

- 20 It shall be unlawful--

- 22 (22) For any retail dispenser licensee, his servant, agents
- 23 or employes to sell wine by the glass on premises otherwise
- 24 licensed for solely malt and brewed beverage sales unless the
- 25 <u>licensee receives a special permit from the board to do so. Only</u>
- 26 those licensees holding a valid hotel, eating place or municipal
- 27 golf course retail dispenser license shall be allowed to apply
- 28 for the permit. Any licensee that wishes to apply for a wine
- 29 sales permit must notify the board and pay the permit fee on an
- 30 annual basis. The board may charge a fee of one thousand dollars

- 1 (\$1,000) each calendar year. The wine sales permit shall enable
- 2 the holder to sell wine by the glass to a guest so long as the
- 3 wine has been purchased from a winery licensed under section
- 4 505.2.
- 5 Section 4. This act shall take effect in 60 days.
