A CONCURRENT RESOLUTION

Extending in whole the disaster emergency declared on June 12, 1 2023, in response to the collapse of the northbound bridge 2 and severe compromise of the southbound bridge on Interstate 3 95 in the City of Philadelphia, Philadelphia County. 4 5 WHEREAS, On June 12, 2023, the Governor issued a proclamation declaring a disaster emergency in response to the collapse of 6 the northbound bridge and severe compromise of the southbound 7 bridge of Interstate 95 in the City of Philadelphia, 8 9 Philadelphia County; and 10 WHEREAS, On June 11, 2023, a tanker truck fire erupted underneath a northbound and southbound bridge on Interstate 95 11 12 in the City of Philadelphia, Philadelphia County; and 13 WHEREAS, The fire led to the collapse of the northbound 14 bridge and severe compromise of the southbound bridge; and 15 WHEREAS, The subsequent closing of the northbound and 16 southbound lanes of Interstate 95 has created serious disruption 17 to transportation and commerce; and

WHEREAS, In addition to the economic impacts, there is
concern for the public safety and well-being of individuals in
the vicinity of the incident; and

4 WHEREAS, The City of Philadelphia and surrounding political 5 subdivisions continue to experience adverse impacts, including 6 ongoing traffic disruption in and around the scene of the 7 accident; and

8 WHEREAS, These adverse impacts are of such magnitude or 9 severity as to render essential the Commonwealth's 10 supplementation of county and municipal efforts and resources 11 and the activation of all applicable State, county and municipal 12 emergency response plans; and

13 WHEREAS, It is necessary to take immediate steps to provide 14 for the reopening of Interstate 95 and to repair and reconstruct 15 the bridges; and

16 WHEREAS, Recovery efforts in response to the damage caused by 17 the incident remain ongoing; and

18 WHEREAS, Extending the disaster emergency declaration will 19 ensure that the Department of Transportation is eligible to 20 receive emergency relief funding from the Federal Government to 21 assist the City of Philadelphia; therefore be it

22 RESOLVED (the Senate concurring), That the General Assembly, 23 in accordance with section 20(c) of Article IV of the 24 Constitution of Pennsylvania, extend in whole until June 12, 25 2024, the disaster emergency declared on June 12, 2023, in 26 response to the collapse of the northbound bridge and severe compromise of the southbound bridge on Interstate 95 in the City 27 28 of Philadelphia, Philadelphia County, except as terminated or 29 extended, in whole or in part, by the General Assembly; and be it further 30
