| 9 | WHEREAS, On June 12, 2023, the Governor issued a proclamation |
| 10 | declaring a disaster emergency in response to the collapse of |
| 11 | the northbound bridge and severe compromise of the southbound |

| 14 | WHEREAS, On June 11, 2023, a tanker truck fire erupted |
| 15 | underneath a northbound and southbound bridge on Interstate 95 |
| 16 | in the City of Philadelphia, Philadelphia County; and |
| 17 | WHEREAS, The fire led to the collapse of the northbound |
| 18 | bridge and severe compromise of the southbound bridge; and |
| 19 | WHEREAS, The City of Philadelphia and surrounding political |
| 2 Ո | subdivisions continue to experience adverse impacts including |

- 1 ongoing traffic disruption in and around the scene of the
- 2 incident; and
- 3 WHEREAS, These adverse impacts are of such magnitude and
- 4 severity as to render essential the Commonwealth's
- 5 supplementation of county and municipal efforts and resources
- 6 and the activation of all applicable State, county and municipal
- 7 emergency response plans; and
- 8 WHEREAS, Recovery and rebuilding efforts in response to the
- 9 damage caused by the incident remain ongoing; and
- 10 WHEREAS, On June 30, 2023, the Senate and the House of
- 11 Representatives both adopted Senate Resolution No. 136 which
- 12 extended in whole the declaration of disaster emergency until
- 13 November 1, 2023; and
- 14 WHEREAS, On September 27, 2023, the House of Representatives
- 15 adopted House Resolution No. 197, which was subsequently adopted
- 16 by the Senate on October 23, 2023, extending in whole the
- 17 declaration of disaster emergency for an additional 120 calendar
- 18 days from November 1, 2023; and
- 19 WHEREAS, Extending the disaster emergency declaration will
- 20 ensure that the Commonwealth is eligible to receive emergency
- 21 relief funding from the Federal Government to assist the
- 22 Commonwealth recovery and rebuilding activities related to the
- 23 collapse of the northbound bridge and severe compromise of the
- 24 southbound bridge on Interstate 95; therefore be it
- 25 RESOLVED (the Senate concurring), That the General Assembly,
- 26 in accordance with section 20(c) of Article IV of the
- 27 Constitution of Pennsylvania, further extend in whole the
- 28 disaster emergency declared on June 12, 2023, and extended in
- 29 whole until November 1, 2023, by Senate Resolution No. 136, and
- 30 further extended by 120 calendar days from November 1, 2023, by

- 1 House Resolution No. 197, for an additional 90 calendar days
- 2 from February 29, 2024, in response to the collapse of the
- 3 northbound bridge and severe compromise of the southbound bridge
- 4 on Interstate 95 in the City of Philadelphia, Philadelphia
- 5 County, except as terminated or extended, in whole or in part,
- 6 by the General Assembly; and be it further
- 7 RESOLVED, That, upon adoption of this concurrent resolution
- 8 by both chambers of the General Assembly, the Secretary of the
- 9 Senate and the Chief Clerk of the House of Representatives be
- 10 directed to notify the Governor of the General Assembly's
- 11 action; and be it further
- 12 RESOLVED, That the Secretary of the Senate and the Chief
- 13 Clerk of the House of Representatives be directed to transmit
- 14 this concurrent resolution to the Legislative Reference Bureau
- 15 for publication in the next available issue of the Pennsylvania
- 16 Bulletin as specified under 45 Pa.C.S. § 725(a)(4).
