A RESOLUTION

- Honoring the life and expressing condolences upon the passing of
- Robert W. Edgar, former Pennsylvania Congressman and 2 President of Common Cause who died on April 23, 2013. 3
- 4
- WHEREAS, Born in Philadelphia on May 29, 1943, Robert W.
- 5 Edgar grew up in Springfield, Delaware County, received a
- 6 bachelor of arts degree from Lycoming College, Williamsport and
- a master's of divinity degree from the Theological School of
- Drew University, Madison, New Jersey. He also received five
- honorary doctoral degrees; and 9
- 10 WHEREAS, Mr. Edgar was elected to the House of
- 11 Representatives of the United States Congress in 1974 to
- represent the 7th Congressional District of Pennsylvania, which 12
- 13 covered parts of Delaware County and Philadelphia; and
- WHEREAS, Mr. Edgar's congressional class was elected in the 14

- 1 wake of the Watergate scandal and went on to lead sweeping
- 2 reforms in Congress; and
- 3 WHEREAS, During his six terms in the United States House of
- 4 Representatives, Mr. Edgar led efforts to improve public
- 5 transportation, fought wasteful water projects and authored the
- 6 Community Right to Know provision of Super Fund legislation,
- 7 among other things; and
- 8 WHEREAS, Mr. Edgar served on the House Select Committee on
- 9 Assassinations that investigated the deaths of Dr. Martin Luther
- 10 King, Jr., and President John F. Kennedy. He also served on the
- 11 Veterans Affairs Committee, working on readjustment counseling
- 12 to treat posttraumatic stress disorder and treatment for Agent
- 13 Orange; and
- 14 WHEREAS, In recent years he worked with the Ford Foundation
- 15 to help the civilians in Vietnam affected by Agent Orange,
- 16 especially the multitudes of children with genetic defects who
- 17 have been abandoned and essentially warehoused in makeshift
- 18 orphanages; and
- 19 WHEREAS, Mr. Edgar sat on the boards of several
- 20 organizations, including the National Coalition on Health Care,
- 21 the Environment and Energy Study Institute, the National
- 22 Foundation on Alternative Medicine, Drew University and the
- 23 National Committee for Responsive Philanthropy; and
- 24 WHEREAS, In May 2007, he became the president and CEO of
- 25 Common Cause, one of the nation's most effective grassroots
- 26 advocacy organizations working to restore the core values of
- 27 American democracy, with nearly 400,000 members and supporters,
- 28 a strong presence on Capitol Hill and state chapters in 36
- 29 states; and
- 30 WHEREAS, During his tenure, Mr. Edgar oversaw the relaunch of

- 1 at least seven state chapters, traveled tirelessly to meet with
- 2 and recruit Common Cause supporters and raised the
- 3 organization's national profile and its critical mission of
- 4 accountable government that works for the public interest and
- 5 empowering ordinary people to make their voices heard; and
- 6 WHEREAS, Mr. Edgar worked to limit the influence of big money
- 7 in politics and for more transparency in government. He called
- 8 for a constitutional amendment to stop the flood of corporate
- 9 and super PAC money in the wake of the Citizens United Supreme
- 10 Court decision of 2010; and
- 11 WHEREAS, Prior to assuming the leadership of Common Cause, he
- 12 served seven years as secretary-general of the National Council
- 13 of the Churches of Christ in the USA, the leading United States
- 14 organization in the movement for Christian unity that advocates
- 15 for progressive social policies and has particular focus on
- 16 eliminating poverty and, before that, as president of the
- 17 Claremont School of Theology, where he served for ten years. He
- 18 was also a part-time chaplain at the Federal penitentiary in
- 19 Lewisburg; and
- 20 WHEREAS, His wide-ranging career has also included pastorates
- 21 at United Methodist congregations and stints as a teacher,
- 22 college chaplain, community organizer and director of a "think
- 23 tank" on national security issues; and
- 24 WHEREAS, Mr. Edgar was the author of "Middle Church," a call
- 25 to progressive people of faith to take back the moral high
- 26 ground from the extremists and make America a better and less
- 27 divided country; and
- 28 WHEREAS, As a minister at Drexel, Mr. Edgar founded the
- 29 People's Emergency Center, a nonprofit social services agency
- 30 for homeless families, a food kitchen and a center to help

- 1 people find jobs; and
- WHEREAS, Mr. Edgar is survived by his wife of 48 years,
- 3 Merle, and their sons, Andrew, David and Rob and their families;
- 4 therefore be it
- 5 RESOLVED, That the House of Representatives honor the life
- 6 and express condolences upon the death of Robert W. Edgar, who
- 7 will be remembered as a great hero of Pennsylvania liberals and
- 8 admired for his deep commitment to social justice and
- 9 strengthening our democracy; and be it further
- 10 RESOLVED, That copies of this resolution be transmitted to
- 11 the family of Robert W. Edgar and to Common Cause.
