A RESOLUTION

Beseeching the Department of Defense and the President of the United States to expedite the recovery of the remains of the 2 crew of the plane that went down and to continue their efforts in finding and recovering all remains of military personnel from all conflicts. 5 WHEREAS, On November 27, 1945, a C-47 Dakota aircraft took 6 off from Singapore on a transport flight to Butterworth Airfield; and WHEREAS, The crew of the aircraft was as follows: 9 10 Pilot: Flight Officer Judson B. Baskett from Texas. 11 (2) Co-Pilot: 1st Lt. William H. Myers from 12 Elizabethtown, Pennsylvania. 13 Radio operator: Private First Class Donald E. Jones from Minnesota; 14 15 and 16 WHEREAS, The crew members were part of the 1305th Army Air

- 1 Force Base Unit and the aircraft was assigned to the Air
- 2 Transport Command; and
- 3 WHEREAS, The last reported location of the aircraft was by
- 4 radio. After being reported missing, American and British
- 5 aircraft cooperated in searching for the missing aircraft. On
- 6 the fifth day of searching, flares were sighted, but no results
- 7 were reported; and
- 8 WHEREAS, The aircraft was initially discovered during July
- 9 1966, in the jungle near Perak, Malaysia, and was found again in
- 10 1985 and 2009; and
- 11 WHEREAS, The wreckage was reported to the Joint POW/MIA
- 12 Accounting Command on October 13, 2009; therefore be it
- 13 RESOLVED, That the House of Representatives beseech the
- 14 Department of Defense and the President of the United States to
- 15 expedite the recovery of the remains of the crew of the plane
- 16 that went down and to continue their efforts in finding and
- 17 recovering all remains of military personnel from all conflicts;
- 18 and be it further
- 19 RESOLVED, That a copy of this resolution be sent to the
- 20 President, the Secretary of Defense, each member of Congress
