A RESOLUTION

- 1 Honoring the life and career of Wendell W. Young, III, President
- 2 Emeritus of the United Food and Commercial Workers Local
- 3 1776, Philadelphia labor relations leader and advocate for
- 4 workers' rights and extending condolences to his family.
- 5 WHEREAS, Wendell W. Young, III, a husband, father,
- 6 grandfather, friend and committed trade unionist, passed away on
- 7 January 1, 2013, at 74 years of age; and
- 8 WHEREAS, Mr. Young was born in 1938 in the City of
- 9 Philadelphia's Mayfair section, and as a sophomore at Northeast
- 10 Catholic High School he was employed as a part-time worker at
- 11 Acme Markets, becoming an active member and steward of the
- 12 Retail Clerks Union Local 1357; and
- 13 WHEREAS, After graduating from St. Joseph's University with a

- 1 degree in political science, Mr. Young began his career as a
- 2 labor leader when at 23 years of age he was named president of
- 3 Retail Clerks Union Local 1357, now known as the United Food and
- 4 Commercial Workers Local 1776; and
- 5 WHEREAS, While serving for 43 years as the President of the
- 6 United Food and Commercial Workers Local 1776, Mr. Young became
- 7 personally responsible for saving the jobs of thousands of union
- 8 members when he engineered the labor agreement which formed
- 9 Super Fresh Markets; and
- 10 WHEREAS, Renowned as a visionary and innovator, Mr. Young was
- 11 instrumental in the implementation of benefits for workers,
- 12 including the first prepaid legal program, pension benefit
- 13 program, child care assistance program and higher education
- 14 program; and
- 15 WHEREAS, Dedicating his career to workers' rights, Mr. Young
- 16 acted not only as an advocate for workers, but also as a civic
- 17 and community leader, serving with the Pennsylvania State
- 18 Chapter of the AFL-CIO and on the boards of the Sisters of the
- 19 Blessed Sacrament and the Northeast Catholic High School Alumni
- 20 Association; and
- 21 WHEREAS, Throughout Mr. Young's career, he received numerous
- 22 awards and honors from entities such as the International
- 23 Foundation of Employee Benefit Plans and the St. Joseph's
- 24 University Brother Bartholomew A. Sheehan Award; therefore be it
- 25 RESOLVED, That the House of Representatives express its
- 26 sadness upon the passing of Wendell W. Young, III, and offer its
- 27 most sincere condolences to his family and friends; and be it
