A RESOLUTION

- Requesting that the Legislative Budget and Finance Committee conduct a comprehensive review of data maintained by the 2 Department of Education and the Department of Public Welfare 4
- on the number of transition-age youth and young adults
- diagnosed with Autism Spectrum Disorders. 5
- 6 WHEREAS, The Autism census report update in December 2013,
- using data from the 2011 census and social service databases,
- indicated that there were approximately 8,395 adults 21 years of
- age and older with Autism Spectrum Disorders (ASD) in 2013 and
- 10 projects that by 2020 there will be more than 30,000 adults with
- 11 ASD; and
- 12 WHEREAS, In fiscal year 2013-2014, an estimated 418 slots for
- Adult Autism Waivers (AAW) were available and an estimated 146 13
- 14 slots for Adult Community Autism Program (ACAP) were available;
- 15 and
- 16 WHEREAS, The Bureau of Autism Services (BAS) reports that it
- 17 maintains "interest lists" for AAW and ACAP which do not

- 1 guarantee either a place in line or that services will be
- 2 received and, in May 2014, there were an estimated 1,200 people
- 3 on the interest lists; and
- 4 WHEREAS, There is an unknown number of individuals with ASD
- 5 receiving some services through the intellectual disabilities
- 6 service system, Medicaid waiver services administered through
- 7 the Office of Long-Term Living, mental health services or the
- 8 Office of Vocational Rehabilitation; and
- 9 WHEREAS, There is an unknown number of individuals with ASD
- 10 who are not dually diagnosed with other disabilities and do not
- 11 meet the eligibility criteria for one of the Medicaid waivers
- 12 for people with intellectual disabilities and people with
- 13 physical disabilities or other similar programs and are
- 14 therefore in need of services administered by the BAS; and
- 15 WHEREAS, There is an unknown number of individuals with ASD
- 16 who are found in other State and community service systems
- 17 including homeless services, State hospitals, the criminal
- 18 justice system and the correction system; and
- 19 WHEREAS, There is an unknown number of individuals with ASD
- 20 not served in any State or community system who are living at
- 21 home and reliant on aging parents or siblings; and
- 22 WHEREAS, The Office of Developmental Programs has developed
- 23 and maintains a comprehensive waiting list for people with
- 24 intellectual disabilities that categorizes the level of support
- 25 needed by each individual, the county of residence and if the
- 26 person resides with an elderly caregiver, however that type of
- 27 list has not been developed for people with ASD; and
- 28 WHEREAS, The budget for fiscal year 2013-2014 allocated
- 29 funding for an additional 1,080 people with intellectual
- 30 disabilities but only allocated funding for an additional 118

- 1 people with ASD; and
- 2 WHEREAS, The proposed budget for fiscal year 2014-2015
- 3 allocates funding for an additional 1,100 people with
- 4 intellectual disabilities but only allocates funding for an
- 5 additional 100 people with ASD; therefore be it
- 6 RESOLVED, That the House of Representatives request that the
- 7 Legislative Budget and Finance Committee conduct a comprehensive
- 8 review of data maintained by the Department of Education and the
- 9 Department of Public Welfare on the number of transition-age
- 10 youth and young adults diagnosed with Autism Spectrum Disorder;
- 11 and be it further
- 12 RESOLVED, That the Legislative Budget and Finance Committee
- 13 issue a report of its findings and recommendations to the
- 14 Department of Public Welfare and the Bureau of Autism Services
- 15 and recommend a plan to provide home-based and community-based

- 16 supports for adults with Autism Spectrum Disorders AND ALSO
- 17 ISSUE AN ELECTRONIC COPY OF THE REPORT TO THE HOUSE OF
- 18 REPRESENTATIVES no later than six months from the passage of
- 19 this resolution.
