## A RESOLUTION

- Designating the month of September 2014 as "Childhood Cancer
- Awareness Month" in Pennsylvania, honoring those young people who have lost their lives to childhood cancer, expressing
- gratitude to the doctors and nurses who provide special care
- to patients and families affected by childhood cancer, and
- encouraging all citizens to join the fight against childhood 6
- cancer in this Commonwealth.

- 8 WHEREAS, Childhood cancers make up less than 1% of all
- cancers diagnosed each year and childhood cancer rates have been
- 10 rising slightly for the past few decades; and
- 11 WHEREAS, Childhood cancer is the second leading cause of
- death in children under the age of 15, exceeded only by 12
- 13 accidents, and about 1,350 children are expected to die of

- 1 cancer in 2014; and
- 2 WHEREAS, The American Cancer Society estimates that about
- 3 10,450 children in the United States under the age of 15 will be
- 4 diagnosed with cancer in 2014; and
- 5 WHEREAS, The potential years of life lost to childhood cancer
- 6 and the potential years of life saved by treatment exceed all
- 7 other cancers with the exception of breast cancer; and
- 8 WHEREAS, Most children cannot be treated at a local hospital,
- 9 and families must face the disruption of moving for treatment at
- 10 a regional cancer center; and
- 11 WHEREAS, Because of major treatment advances in recent
- 12 decades, more than 80% of children with cancer now survive 5
- 13 years or more; and
- 14 WHEREAS, This is a huge increase since the mid-1970s, when
- 15 the 5-year survival rate was less than 60%; and
- 16 WHEREAS, Survival rates vary depending on the type of cancer
- 17 and other factors; and
- 18 WHEREAS, There is significant progress that still must be
- 19 made with regard to childhood cancer treatment because there are
- 20 many types of childhood cancer, and some varieties with lower
- 21 survival rates are still very difficult to treat; and
- 22 WHEREAS, Pennsylvania is a leader in the fight against and
- 23 treatment of childhood cancer with six Children's Oncology Group
- 24 hospitals, St. Christopher's Hospital for Children, The
- 25 Children's Hospital of Philadelphia, Geisinger Medical Center,
- 26 Lehigh Valley Hospital Muhlenburg, Hershey Medical Center and
- 27 Children's Hospital of Pittsburgh; and
- 28 WHEREAS, Two of only ten institutions in the Pediatric Brain
- 29 Tumor Consortium are in Pennsylvania, The Children's Hospital of
- 30 Philadelphia and Children's Hospital of Pittsburgh, and Penn

- 1 State Hershey Children's Hospital is one of only 11 institutions
- 2 nationwide in the Pediatric Oncology Experimental Therapeutic
- 3 Consortium; therefore be it
- 4 RESOLVED, That the House of Representatives designate the
- 5 month of September 2014 as "Childhood Cancer Awareness Month" in
- 6 Pennsylvania; and be it further
- 7 RESOLVED, That the House of Representatives honor those young
- 8 people who have lost their lives to childhood cancer, express
- 9 gratitude to the doctors and nurses who provide special care to
- 10 patients and families affected by childhood cancer, and
- 11 encourage all citizens to join the fight against childhood
- 12 cancer in this Commonwealth.
