AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania 1
- Consolidated Statutes, in minors, providing for the offense 2 3
 - of trafficking drugs containing fentanyl to minors; and
- imposing a penalty.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 18 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- § 6314.1. Trafficking drugs containing fentanyl to minors.
- 10 (a) General rule. -- Notwithstanding section 6314 (relating to
- 11 sentencing and penalties for trafficking drugs to minors), a
- 12 person over 18 years of age commits a felony of the second
- degree if the person intentionally administers, dispenses, 13
- delivers, gives, prescribes, sells or distributes any controlled 14
- 15 substance or counterfeit controlled substance in violation of
- 16 section 13(a)(14) or (30) of the act of April 14, 1972 (P.L.233,
- No. 64), known as The Controlled Substance, Drug, Device and 17
- Cosmetic Act, and that controlled substance contains fentanyl or 18

- 1 <u>fentanyl analogues and the recipient of the controlled substance</u>
- 2 is a minor.
- 3 (b) Penalty.--A person convicted under subsection (a) shall
- 4 <u>be sentenced to a term of imprisonment fixed by the court at not</u>
- 5 <u>less than 20 years and not more than 40 years.</u>
- 6 (c) Authority of court in sentencing. -- There shall be no
- 7 <u>authority for a court to impose on a defendant to which this</u>
- 8 <u>section is applicable a lesser sentence than provided for in</u>
- 9 <u>subsection</u> (b), to place the defendant on probation or to
- 10 suspend sentence. Nothing in this section shall prevent the
- 11 <u>sentencing court from imposing a sentence greater than that</u>
- 12 provided in this section. Sentencing quidelines promulgated by
- 13 <u>the Pennsylvania Commission on Sentencing shall not supersede</u>
- 14 the mandatory sentences provided in this section.
- 15 <u>(d) Appeal by Commonwealth.--If a sentencing court refuses</u>
- 16 to apply this section where applicable, the Commonwealth shall
- 17 have the right to appellate review of the action of the
- 18 sentencing court. The appellate court shall vacate the sentence
- 19 and remand the case to the sentencing court for imposition of a
- 20 sentence in accordance with this section if it finds that the
- 21 <u>sentence was imposed in violation of this section.</u>
- 22 (e) Forfeiture. -- Assets against which a petition seeking
- 23 forfeiture has been filed and is pending or against which the
- 24 Commonwealth has indicated an intention to file a petition
- 25 seeking forfeiture shall not be subject to a fine under this
- 26 section.
- 27 <u>(f) Definitions.--As used in this section, the following</u>
- 28 words and phrases shall have the meanings given to them in this
- 29 subsection unless the context clearly indicates otherwise:
- 30 "Minor." An individual under 18 years of age.

1 Section 2. This act shall take effect in 60 days.
