AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in miscellaneous provisions relating 5 to institutions of higher education, providing for Higher 6 Education Task Force. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 10 as the Public School Code of 1949, is amended by adding a 11 12 section to read: 13 Section 2004-I. Higher Education Task Force. 14 (a) Establishment. -- The Higher Education Task Force is 15 established. 16 (b) Purpose. -- The task force shall meet, discuss and make 17 recommendations to the General Assembly relating to the 18 following with respect to the universities within the State

System of Higher Education and community colleges in this

16	(c) Membership The task force shall consist of the
17	<pre>following members:</pre>
18	(1) Four representatives of the State System of Higher
19	Education who are appointed by its Board of Governors.
20	(2) Four representatives from the community colleges who
21	are appointed by a Statewide association that represents
22	<pre>community colleges.</pre>
23	(3) One representative from the Pennsylvania College of
24	Technology.
25	(4) One representative from the Thaddeus Stevens College
26	of Technology.
27	(5) One representative from each of the State-related
28	universities.
29	(6) Four representatives from independent colleges in

- 2 (7) Four representatives from private technical
- 3 colleges, including private schools of cosmetology.
- 4 (8) Two school district superintendents who are
- 5 <u>appointed by a Statewide organization that represents school</u>
- 6 <u>district superintendents.</u>
- 7 (9) Two representatives from career and technology
- 8 <u>centers appointed by the Governor from names submitted to the</u>
- 9 Governor by career and technology centers.
- 10 (d) Chair. -- The members of the task force shall appoint a
- 11 <u>chair and vice chair from their membership.</u>
- 12 <u>(e) Meetings.--</u>
- 13 (1) The task force shall convene its first meeting by
- July 15, 2025, and other meetings at such times as determined
- by the chair.
- 16 (2) Meetings of the task force shall be subject to 65
- Pa.C.S. Ch. 7 (relating to open meetings).
- 18 (f) Reimbursement of expenses. -- Members of the task force
- 19 shall be eligible for reimbursement of reasonable expenses
- 20 related to their participation in the meetings.
- 21 (g) Report.--The task force shall prepare a written report
- 22 of its discussions and recommendations and shall, no later than
- 23 April 30, 2026, file the report with the Education Committee of
- 24 the Senate, the Education Committee of the House of
- 25 Representatives, the Appropriations Committee of the Senate and
- 26 the Appropriations Committee of the House of Representatives.
- 27 Section 2. This act shall take effect immediately.
