- 1 "Wireless device location information." Information
- 2 indicating the geographical location of a telecommunications
- 3 device.
- 4 "INVESTIGATIVE OR LAW ENFORCEMENT OFFICER." THE TERM SHALL <-
- 5 HAVE THE SAME MEANING AS THAT IN 18 PA.C.S. § 5702 (RELATING TO
- 6 DEFINITIONS).
- 7 "MOBILE COMMUNICATIONS TRACKING INFORMATION." INFORMATION
- 8 GENERATED BY A COMMUNICATION COMMON CARRIER OR A COMMUNICATION
- 9 SERVICE WHICH INDICATES THE LOCATION OF AN ELECTRONIC DEVICE
- 10 SUPPORTED BY THE COMMUNICATION COMMON CARRIER OR COMMUNICATION
- 11 SERVICE.
- "Wireless telecommunications service provider." A provider
- 13 of commercial mobile radio services, as that term is defined in
- 14 section 332(d) of the Communications Act of 1934 (48 Stat. 1064,
- 15 47 U.S.C. § 332(d)), including all broadband personal
- 16 communications services, wireless radio telephone services,
- 17 geographic area specialized and enhanced specialized mobile
- 18 radio services and incumbent wide area specialized mobile radio
- 19 licensees, which offers real-time, two-way voice service
- 20 interconnected with the public switched telephone network and is
- 21 doing business in this Commonwealth.
- 22 "Written form." A form approved or prescribed by the <--
- 23 Attorney General that includes all of the following:
- 24 (1) The name of the INVESTIGATIVE OR LAW ENFORCEMENT <--
- officer making a request for disclosure.

- 7 Section 3. Disclosure of wireless device location MOBILE <--
- 8 COMMUNICATIONS TRACKING information in emergency
- 9 situations.
- 10 (a) Disclosure.--Notwithstanding 18 Pa.C.S. § 5713 (relating <--
- 11 to emergency situations) CH. 57 (RELATING TO WIRETAPPING AND <--
- 12 ELECTRONIC SURVEILLANCE), upon receipt of a written form from a-<--
- 13 law enforcement agency AN INVESTIGATIVE OR LAW ENFORCEMENT <--
- 14 OFFICER, a wireless telecommunications service provider shall
- 15 provide the requested wireless device location MOBILE <--
- 16 COMMUNICATIONS TRACKING information concerning the device to the
- 17 requesting law enforcement agency INVESTIGATIVE OR LAW <--
- 18 ENFORCEMENT OFFICER.
- 19 (b) Protocols.--A wireless telecommunications service
- 20 provider shall establish protocols consistent with this act that
- 21 govern its response to a request from a law enforcement agency <--
- 22 AN INVESTIGATIVE OR LAW ENFORCEMENT OFFICER under this section. <--
- 23 Section 4. Immunity
- No cause of action shall lie in any court against a wireless
- 25 telecommunications service provider, its officers, employees,
- 26 agents or other specified persons for providing wireless device <--
- 27 location MOBILE COMMUNICATIONS TRACKING information to a law <--
- 28 enforcement agency AN INVESTIGATIVE OR LAW ENFORCEMENT OFFICER <--
- 29 as required by this act.
- 30 Section 5. Effective date.

1 This act shall take effect in 60 days.
