## AN ACT

Amending Title 65 (Public Officers) of the Pennsylvania Consolidated Statutes, in ethics standards and financial 2 disclosure, further providing for definitions and for 3 restricted activities; and prescribing penalties. 4 5 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 7 Section 1. Section 1102 of Title 65 of the Pennsylvania Consolidated Statutes is amended by adding definitions to read: § 1102. Definitions. 10 The following words and phrases when used in this chapter 11 shall have, unless the context clearly indicates otherwise, the 12 meanings given to them in this section: 13 14 "Cash gift." 15 (1) Any of the following: (i) United States or foreign currency. 16 17 (ii) A money order.

19	related to being a public official or public employee.

- 20 (1) Any person who intentionally violates the provisions
- 21 <u>of section 1103(k) (relating to restricted activities)</u>

- (i) An amount of less than \$250 commits a

- 25 pay a fine of not more than \$1,000 plus costs and, if
- 26 payment of the fine and costs is not timely made, to
- imprisonment for not more than two years.
- (ii) An amount of \$250 or more commits a felony and
- 29 shall, upon conviction, be sentenced to pay a fine of not
- more than \$10,000 plus costs or to imprisonment for not

- 5 Section 3. This act shall take effect in 60 days.
