Amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, IN CHILD PROTECTIVE SERVICES, FURTHER <--PROVIDING FOR PERSONS REQUIRED TO REPORT SUSPECTED CHILD ABUSE; AND providing for protection from employment discrimination. The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Title 23 of the Pennsylvania Consolidated Statutes is amended by adding a section to read: SECTION 1. PERSONS REQUIRED TO REPORT SUSPECTED CHILD ABUSE. 12 13 14 (D) CIVIL ACTION FOR DISCRIMINATION AGAINST PERSON FILING 15 REPORT. -- ANY PERSON WHO, UNDER THIS SECTION, IS REQUIRED TO 16 REPORT OR CAUSE A REPORT OF SUSPECTED CHILD ABUSE TO BE MADE AND

WHO, IN GOOD FAITH, MAKES OR CAUSES THE REPORT TO BE MADE AND,

- 8 IS REQUIRED TO REPORT OR CAUSE A REPORT OF SUSPECTED CHILD ABUSE
- 9 TO BE MADE AND WHO, IN GOOD FAITH, MADE OR CAUSED TO BE MADE A

- 19 (a) Basis for relief. -- A person may commence an action for

- 20 appropriate relief if all of the following apply:
- 21 (1) The person is required to report under section 6311
- 22 (relating to persons required to report suspected child
- 23 abuse) or encouraged to report under section 6312 (relating
- 24 to persons encouraged to report suspected child abuse).
- 25 (2) The person acted in good faith in making or causing
- the report of suspected child abuse to be made.
- 27 (3) As a result of making the report of suspected child
- 28 abuse, the person is discharged from employment or is
- 29 discriminated against with respect to compensation, hire,
- 30 tenure, terms, conditions or privileges of employment. This <--

- 2 (B) APPLICABILITY. -- THIS SECTION does not apply to an
- 3 individual making a report of suspected child abuse who is found

- 7 <u>suspected child abuse</u>) and is <u>subject to conviction under</u>

- 9 <u>or to refer.</u>
- 10 (C) Location. -- An action under this section must be <--
- 11 filed in the court of common pleas of the county in which the
- 12 <u>alleged unlawful discharge or discrimination occurred.</u>
- 13 (c) (D) Relief.--Upon a finding in favor of the plaintiff, <--
- 14 the court may grant appropriate relief, which may include
- 15 reinstatement of the plaintiff with back pay.
- 16 (E) Departmental intervention. -- The department may <--
- 17 intervene in an action commenced under this section.
- 18 Section 2. This act shall take effect January 1, 2014. <--
- 19 SECTION 3. THIS ACT SHALL TAKE EFFECT DECEMBER 31, 2014. <--
