## AN ACT

- Designating the portion of State Route 1013 (Academy Road) from the intersection with Cromwell Road to the intersection with
- 3 Comly Road in Philadelphia, Philadelphia County, as the U.S.
- 4 Army Ranger SPC Devin J. Kuhn Memorial Highway.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. U.S. Army Ranger SPC Devin J. Kuhn Memorial Highway.
- 8 (a) Findings.--The General Assembly finds that:
- 9 (1) Born and raised in Philadelphia, Specialist Devin
- 10 James Kuhn graduated from Archbishop Ryan High School in
- 11 2013, where he played several sports.
- 12 (2) SPC Kuhn enjoyed the outdoors and participated in
- activities such as hiking, skiing, golfing and running in
- 14 endurance marathons.
- 15 (3) Proudly serving his country in the United States
- 16 Army as an army ranger, SPC Kuhn deployed once in support of
- 17 Operation Freedom's Sentinel.
- 18 (4) SPC Kuhn was decorated with the following awards:

- 1 (i) National Defense Service Medal.
- 2 (ii) Army Service Ribbon.
- 3 (iii) The Expert Infantryman Badge.
- 4 (iv) The Parachutist Badge.
- 5 (v) The Ranger Tab.
- 6 (5) SPC Kuhn tragically lost his life in a training
- 7 accident and is survived by his wife, Brittany, his parents,
- James and Lynn Kuhn and his sister, Sara Kuhn.
- 9 (6) This Commonwealth and the nation are indebted to SPC
- 10 Kuhn for his bravery and sacrifice in protecting freedom and
- 11 liberty at home and abroad.
- 12 (7) Enacting this memorial highway would be a small yet
- 13 significant action to honor the service and life of SPC Kuhn.
- 14 (b) Designation. -- The portion of State Route 1013 (Academy
- 15 Road) from the intersection with Cromwell Road to the
- 16 intersection with Comly Road in Philadelphia, Philadelphia
- 17 County, is designated as the U.S. Army Ranger SPC Devin J. Kuhn
- 18 Memorial Highway.
- 19 (c) Signs.--The Department of Transportation shall erect and
- 20 maintain appropriate signs displaying the name of the highway to
- 21 traffic in both directions on the highway.
- 22 Section 2. Effective date.
- 23 This act shall take effect in 60 days.
