A CONCURRENT RESOLUTION

Establishing a special bipartisan, bicameral legislative commission to recommend improvements for the recruitment and retention of law enforcement officers, corrections officers 3 and prosecutors in this Commonwealth and develop and promote legislation in furtherance of its recommendations. 5 6 WHEREAS, For there to be law and order in this Commonwealth, 7 the Commonwealth must have properly staffed law enforcement personnel in all counties and departments, county and State 8 correctional institutions and district attorneys' offices with 10 qualified and experienced prosecutors; and 11 WHEREAS, Recruitment and retention challenges for all three 12 professions are at unprecedented levels, presenting more 13 challenges for these public servants to do their jobs 14 effectively; and 15 WHEREAS, Vacancies in these professions result in delays of 16 justice and fears of a decrease in public safety; and 17 WHEREAS, It is vital for vacancies in these professions to be 18 filled in a timely manner to ensure law and order; and WHEREAS, The passage of Senate Resolution No. 6 in 2017 19

- 1 established a special bipartisan, bicameral legislative
- 2 commission to recommend improvements to the delivery of
- 3 emergency services in this Commonwealth; and
- 4 WHEREAS, This commission provided legislative recommendations
- 5 that have been enacted by the General Assembly and therefore
- 6 have improved the delivery of emergency services in this
- 7 Commonwealth; therefore be it
- 8 RESOLVED (the House of Representatives concurring), That the
- 9 General Assembly establish a special bipartisan, bicameral
- 10 legislative commission to recommend improvements for the
- 11 recruitment and retention of law enforcement officers,
- 12 corrections officers and prosecutors in this Commonwealth and
- 13 develop and promote legislation in furtherance of its
- 14 recommendations; and be it further
- 15 RESOLVED, That the commission consist of the following
- 16 members:
- 17 (1) Four senators, two from the majority party and two
- from the minority party, appointed by the President pro
- 19 tempore of the Senate.
- 20 (2) Four representatives, two from the majority party
- and two from the minority party, appointed by the Speaker of
- the House of Representatives.
- 23 (3) A designee of the County Commissioners Association
- of Pennsylvania.
- 25 (4) A designee of the Pennsylvania Municipal League.
- 26 (5) A designee of the Pennsylvania State Association of
- Boroughs.
- 28 (6) A designee of the Pennsylvania State Association of
- 29 Township Commissioners.
- 30 (7) A designee of the Pennsylvania State Association of

- 1 Township Supervisors.
- 2 (8) A designee of the Pennsylvania Association of
- 3 Councils of Governments.
- 4 (9) The Commissioner of Pennsylvania State Police or a

- 18 (16) The Secretary of Corrections of the Commonwealth or

- 22 (18) Two State corrections officers in this
- Commonwealth, one of whom shall be selected by the President
- 24 pro tempore of the Senate and one of whom shall be selected
- by the Speaker of the House of Representatives.
- 26 (19) Two county corrections officers in this
- Commonwealth, one of whom shall be selected by the President
- pro tempore of the Senate and one of whom shall be selected
- 29 by the Speaker of the House of Representatives.
- 30 (20) A designee of the Pennsylvania Bar Association.

- 1 (21) A designee of the Pennsylvania District Attorneys

- 3 (22) Six district attorneys in this Commonwealth who are
- 4 members of the Pennsylvania District Attorneys Association,
- 5 three of whom shall be selected by the President pro tempore
- of the Senate and three of whom shall be selected by the
- 7 Speaker of the House of Representatives;
- 8 and be it further
- 9 RESOLVED, That the commission elect a chair from its
- 10 legislative membership; and be it further
- 11 RESOLVED, That the commission develop and recommend
- 12 legislation to improve recruitment and retention of law
- 13 enforcement officers, corrections officers and prosecutors; and
- 14 be it further
- 15 RESOLVED, That the commission hold hearings, take testimony
- 16 and conduct investigations at any location it deems necessary in
- 17 this Commonwealth; and be it further
- 18 RESOLVED, That the Legislative Budget and Finance Committee
- 19 provide staff support and assist with the final report; and be
- 20 it further
- 21 RESOLVED, That the commission make a final report of all
- 22 legislative recommendations by January 1, 2024, which shall be
- 23 submitted to the President pro tempore of the Senate and the
- 24 Speaker of the House of Representatives; and be it further
- 25 RESOLVED, That the members of the commission serve without
- 26 compensation but be reimbursed for all necessary and reasonable
- 27 expenses incurred in the performance of their duties; and be it
- 28 further
- 29 RESOLVED, That reasonable expenses incurred by the commission
- 30 be equally divided between the Senate and the House of

- 1 Representatives; and be it further
- 2 RESOLVED, That the approval of the President pro tempore of
- 3 the Senate and the Speaker of the House of Representatives be
- 4 required to preauthorize all proposed actions of the commission
- 5 which will entail the expenditure of State funds and approve all
- 6 expenditures, including expense reimbursement requests of
- 7 commission members, prior to payment.
