A RESOLUTION

Directing the Joint State Government Commission to study the 1 issue of student suicide in higher education, to establish an 2 advisory committee to conduct a thorough and comprehensive analysis of the underlying causes of student suicide and to report to the Senate with its findings and recommendations. 5 6 WHEREAS, This Commonwealth is home to some of the finest higher education institutions in the world; and 7 8 WHEREAS, Each year thousands of young men and women matriculate at these colleges and universities to pursue a 10 higher education degree to prepare them for a future career; and 11 WHEREAS, Many of the young men and women who enroll in an institution of higher education will face numerous issues, both 12 academic and nonacademic, associated with obtaining a college, 13 14 graduate or professional degree; and WHEREAS, Mental health issues often manifest themselves 15 16 during an individual's late teens and early twenties; and 17 WHEREAS, Academic pressures coupled with the pressure of 18 adapting to new surroundings, schedules, activities and

- 1 responsibilities can lead to increased stress and anxiety among
- 2 students; and
- 3 WHEREAS, Increased stress among college students often leads
- 4 to depression, substance abuse or other behaviors and conditions
- 5 that may raise the risk of suicide, attempted suicide or
- 6 suicidal thoughts among students; and
- 7 WHEREAS, The stigma associated with seeking or receiving
- 8 mental health counseling or services often deters students from
- 9 communicating their thoughts and feelings and seeking
- 10 professional help; and
- 11 WHEREAS, According to the Suicide Prevention Resource Center,
- 12 suicide is the second leading cause of death among college-age
- 13 students accounting for approximately 1,100 deaths per year on
- 14 college campuses; and
- 15 WHEREAS, According to the Pennsylvania Youth Suicide
- 16 Prevention Initiative, suicide is the third leading cause of
- 17 death for young people 15 to 24 years of age; and
- 18 WHEREAS, Available data suggest that suicide occurs at a rate
- 19 between 6.5 and 7.5 per 100,000 college students; and
- 20 WHEREAS, In 2011, the American College Health Association-
- 21 National College Health Assessment (ACHA-NCHA), a nationwide
- 22 assessment of college students at two-year and four-year
- 23 institutions, found that approximately 30% of students reported
- 24 being "so depressed that it was difficult to function" in the
- 25 prior year. That same 2011 survey found that approximately 6% of
- 26 college students reported seriously considering suicide and 1%
- 27 reported attempting suicide in the prior year; and
- 28 WHEREAS, Student suicide unfortunately has touched a number
- 29 of college and university campuses in this Commonwealth in the
- 30 last few years; and

- 1 WHEREAS, The Senate recognizes the seriousness of the issue
- 2 of suicide among college, graduate and professional students in
- 3 this Commonwealth and wishes to convene an advisory committee to
- 4 study the issue; therefore be it
- 5 RESOLVED, That the Senate direct the Joint State Government
- 6 Commission to establish an advisory committee of 25 members
- 7 consisting of higher education officials, public officials and
- 8 experts on the issue of student suicide in higher education. The
- 9 committee is balanced so that it encompasses a wide range of
- 10 backgrounds and viewpoints; and be it further
- 11 RESOLVED, That the advisory committee contain the following
- 12 individuals:
- 13 (1) The President of The Pennsylvania State University
- or his designee. The designee may be an officer or faculty
- member of the university or an employee of the university,
- who provides services to students through a university
- 17 counseling center, university health center or through
- university residency and housing programs.
- 19 (2) The President of the University of Pittsburgh or his
- designee. The designee may be an officer or faculty member of
- 21 the university or an employee of the university, who provides
- 22 services to students through a university counseling center,
- 23 university health center or through university residency and
- housing programs.
- 25 (3) The President of Temple University or his designee.
- The designee may be an officer or faculty member of the
- 27 university or an employee of the university, who provides
- services to students through a university counseling center,
- 29 university health center or through university residency and
- 30 housing programs.

- 1 The President of Lincoln University or his designee. The designee may be an officer or faculty member of the 3 university or an employee of the university, who provides services to students through a university counseling center, university health center or through university residency and housing programs.
 - The Chancellor of the State System of Higher Education or his designee. The designee may be an officer of the State System of Higher Education, a president, officer or faculty member of a university within the State System of Higher Education or an employee of a university within the State System of Higher Education, who provides services to students through a university counseling center, university health center or through university residency and housing programs.
 - Two representatives, or their designees, of private institutions of higher education within this Commonwealth selected by the Joint State Government Commission upon the recommendation of the Association of Independent Colleges and Universities of Pennsylvania. Designees may be an officer or faculty member of the university or an employee of the university, who provides services to students through a university counseling center, university health center or through university residency and housing programs.
 - An individual representing the community colleges of this Commonwealth selected by the Joint State Government Commission upon the recommendation of the Pennsylvania Commission for Community Colleges.
 - Three students enrolled in good standing at institutions of higher education within this Commonwealth

- 1 selected by the Joint State Government Commission. One
- 2 student shall be enrolled at a State-related institution, one
- 3 shall be enrolled at a university within the State System of
- 4 Higher Education and one student shall be enrolled in an
- 5 independent college or university within this Commonwealth.
- 6 (9) The Secretary of Health, or his designee.
- 7 (10) The Secretary of Education, or her designee.
- 8 (11) An individual representing the Department of Public
- 9 Welfare's Office of Mental Health and Substance Abuse
- 10 Services, selected by the Secretary of Public Welfare.
- 11 (12) Eleven members of the public who are experts on the
- issue of suicide, physical, behavioral or mental health, or
- who are involved in any other profession relevant to the
- issue of student suicide. Of the 11 members, nine shall be
- 15 selected by the Joint State Government Commission, one shall
- be selected by the President pro tempore of the Senate and
- one shall be selected by the Minority Leader of the Senate;
- 18 and be it further
- 19 RESOLVED, That the Joint State Government Commission, working
- 20 with the advisory committee, conduct a thorough and
- 21 comprehensive analysis of student suicide in higher education,
- 22 including graduate and professional schools, the issues set
- 23 forth in this resolution and other related issues as determined
- 24 by the commission; and be it further
- 25 RESOLVED, That the Joint State Government Commission, working
- 26 with the advisory committee, review the following to identify
- 27 the best practices to address the issue of student suicide, its
- 28 causes and effective suicide prevention strategies and to
- 29 develop recommendations best suited for institutions of higher
- 30 education in this Commonwealth:

- 1 (1) Proposals and policies of other states.
- 2 (2) Policies currently in place at institutions of
- 3 higher education in this Commonwealth and other states.
- 4 (3) Other resources on the issue of student suicide;
- 5 and be it further
- 6 RESOLVED, That the Joint State Government Commission
- 7 establish a process by which interested members of the public
- 8 can make suggestions and have input; and be it further
- 9 RESOLVED, That the final report include recommendations to
- 10 implement necessary changes in State statutes, practices,
- 11 policies and procedures relating to student suicide, including
- 12 measures to reduce the incidences of student suicide, and to
- 13 develop awareness, education and other strategies to address
- 14 issues relating to student suicide in higher education; and be
- 15 it further
- 16 RESOLVED, That the Joint State Government Commission issue a
- 17 report to the Senate with its findings and recommendations not
- 18 later than December 31, 2014 2015.
